



Presented to both Houses of Parliament by His Excellency's Command.



#### GOVERNMENT NOTICE.

#### No. 244.

#### Chief Secretary's Office, 8th September, 1884.

THE Governor in Council has been pleased, in accordance with the provisions of the 10th Section of "The Police Regulation Amendment Act, 1881," 45 Victoria, No. 21, to revoke the Regulations which appear in Government Notice, No. 134, of the 13th April, 1883, and to substitute the following Regulations in lieu thereof.

# **REGULATIONS** made by the Governor in Council under "The Police Regulation Amendment Act, 1881," 45 Victoria, No. 21, for the purposes of the Territorial Police Provident and Reward Fund.

1. In the construction and for the purpose of these Regulations-

- retirement or death to the Member or his family from
- the Fund as hereinafter provided : "Treasurer" shall mean the Treasurer of Tasmania for the time being.

2. There shall be a Police Provident Fund established under the said Act, to which the contributions and payments here-after specified shall be appropriated; and such Fund shall be divided into and shall consist of a Superannuation and Reward Branch.

3. Out of the moneys provided by Parliament for that purpose for the year 1882, there shall be paid to the Treasurer One Shilling in the Pound on all existing salaries of every Member entitled to participate in the said Fund, and by him carried to the credit of the said Provident Fund. Such pay-ments shall be made by the Inspector of Police out of the salary payable from time to time to each member. salary payable from time to time to each member.

4. From and after the year 1882 there shall be a deduction of One Shilling in the Pound from the pay of each member, which amount shall be paid to the Treasurer, and by him carried to the credit of the said Provident Fund. Such deductions shall be made by the Inspector of Police out of the salary payable from time to time to each member.

5. A separate account shall be opened for every member, showing the amount paid by or for him. The interest on investments, less expenses for management (if any) will be divided by the Inspector of Police *pro rata* annually, and also carried to the credit of each account.

6. The amount standing to the credit of any member who o. The amount standing to the credit of any member who may resign or be discharged before he has served three years, or may be dismissed from the Force for misconduct, shall be deemed to be forfeited, and shall form part of the said Provident Fund, and be divided by the Inspector of Police and carried to the credit of each account annually as per Pule No. 5 Rule No. 5.

7. Members who may hereafter resign shall, on discharge, be paid a proportion of the amount to their credit under Regulations 4, 5, and 6, as follows:—

After 3 years' service, 40 per cent. Without any inter-est or other dis-ributions.

After 5 years' service, 60 per cent. After 8 years' service, 70 per cent. After 11 years' service, 80 per cent. After 14 years' service, 90 per cent. After 17 years' service, 100 per cent. On the retirement of a member who is only entitled to a per-centage of the amount to his credit, the balance shall be

distributed as per Rule No. 5. No person to be entitled under any circumstances to any portion of the said Fund unless he shall have served three years in the Force. In no case can the period of service be

reckoned as commencing anterior to the 1st January, 1882. 8. Any member retiring consequent on ill-health (such ill-health being established to the satisfaction of the Inspector) shall be entitled to the whole amount to his credit; and, in the event of the death of any member, the family of the deceased member shall, in like manner, be so entitled.

#### 9. Reward Branch.

On the recommendation of the Inspector, and with the consent of the Governor in Council, such amounts as the Inspector shall fix shall be paid by the Treasurer to members as rewards for extraordinary diligence, or compensation for wounds or injuries received in the performance of their duty, such amounts in the aggregate not to exceed the sum received by the Treasurer under the authority of Section 9 of "The Police Regulation Amendment Act, 1881."
