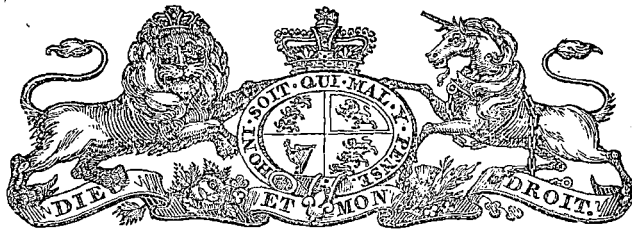

BOARD OF IMMIGRATION:

REPORT FOR 1880.

Laid upon the Table by Mr. Moore, and ordered by the Council to be printed,
July 19, 1881.



Immigration Office, 24th June, 1881.

SIR,

THE Board of Immigration have the honor to forward their Report for the year ending the 31st December, 1880.

Bounty Immigration during the year has been almost entirely restricted to the introduction of Emigrants under Tickets issued by the Agents of the Board in London, as the sale of Tickets in this Colony had to be suspended, owing to the refusal of Messrs. Money Wigram & Sons to continue to provide passages for our Bounty Emigrants upon the terms originally agreed to. The Board were also informed that the line of steamers belonging to that firm would probably cease running to Melbourne.

Under these circumstances the Managers of the "Orient" line of steamers were communicated with, and the Board have deemed it advisable to accept the terms offered by the Company though involving additional cost for the introduction of each Immigrant.

The issue of Bounty Tickets was resumed on the 3rd December.

The number of Immigrants introduced during the year was fifty-two, consisting of seven married couples, the wife of an Immigrant already in the Colony, and a widow with two children joining her relatives; also, five single males, eight single females, sixteen male and seven female children,—in all fifty-two souls.

The cost to the Board for their introduction was £401.

Fourteen males and eighteen females came from England, seven males and three females from Ireland, and seven males and three females from Scotland.

Land Certificates were issued to seventy-four individuals under the 7th section of the Act of Parliament 31 Vict. No. 26, entitling the holders to select three thousand nine hundred and sixty acres of the Waste Lands of the Crown.

These Certificates represent sixty-one male and fifty female adults, and ninety-eight children; in all 209 souls.

Twenty Land Orders were issued under the 5th section of the same Act, entitling the holders to select or purchase seven hundred and seventy-four acres of the Waste Lands of the Crown. These orders represented twenty-five male, thirteen female adults, and ten children.

For the reasons already stated the Board only issued one family and three single female tickets during the year; and the agents in London issued six family, three male, and five female single tickets.

The Board would again call attention to the pressing need for a reliable description of the Colony, its resources, and its advantages as a field for emigration; and would respectfully urge upon the Government the desirability of offering inducements sufficient to secure the compilation of a work which should contain not only the latest statistical information, but set before the public at large a faithful representation of Tasmania and its capabilities.

Another and very important want is a correct map; and the Board trust that the Government may be pleased to expedite the preparation of this most necessary aid in the dissemination of correct information respecting the Colony.

The balance at the disposal of the Board on the 31st December amounted to £3707 18s. 6d.

Appended are the usual Returns prepared by the Immigration Agent,—five relating to the operations of the Board under the Bounty System, and two transactions under the Acts of Parliament 31 Vict. No. 26 and 28 Vict. No. 16.

A statement is also appended showing the acreage taken up by the holders of Land Certificates and Land Orders since the date of the last Report.
