

MY DEAR SIR,

In reply to yours of the 12th instant, requesting me to state in reply the circumstances under which the cases of the men Williamson and Mullins, tried before Mr. Kirwan at Brown's River, were brought under your notice, I beg to inform you that on the 29th May, 1857, I received a letter from Mr. H. Pointon detailing the particulars of the conviction of the man Mullins, and requesting me to publish the same. I declined doing so, not thinking it a fit subject for a newspaper column; but, believing that it deserved to be brought under the notice of the Executive, I lost no time in seeing you, and handing the communication over to you, and requesting you to bring it under the notice of the Government, with a view to some steps being taken to prevent such occurrences in future. You immediately enquired who Pointon was, and whether implicit credence could be placed in his statements? I informed you that on Saturday Pointon would be in Town, and that I would see that you had an opportunity of questioning him on the subject. On Saturday, being myself otherwise occupied, I sent my brother William with you to point out Pointon to you. I believe the information I gave you on Saturday was the first intimation you possessed of such a trial and conviction having taken place. I have also every reason for believing that, until Pointon was pointed out to you by my brother, you had had no previous acquaintance with him (Pointon), nor had you ever before spoken to him.
