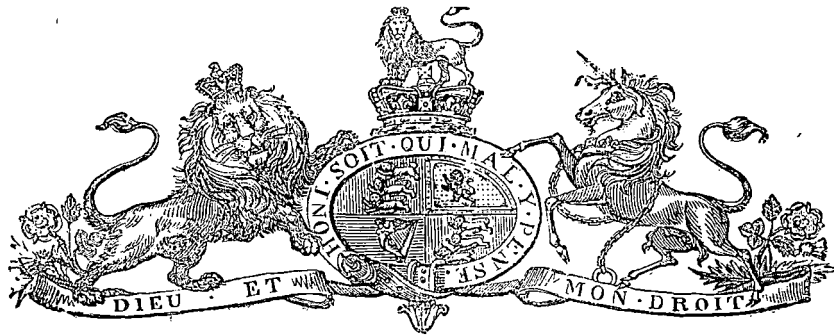

IMPERIAL BUILDINGS.

RETURN TO AN ORDER OF THE HOUSE.

(Mr. Crookes, 21 August.)

Laid upon the Table by Mr. Attorney-General, and ordered by the Council to be printed, 7 September, 1860.



Comptroller-General's Office, 28th August, 1860.

SIR,

I HAVE the honor, in accordance with the request contained in your letter of 25th instant, to furnish a Return showing the Buildings now occupied by the Convict Department, and which is all the information which I can afford on the subject of the Return as Comptroller-General of Convicts.

With regard to any other Imperial Buildings, the information can only be obtained from the Commanding Royal Engineer, Commissariat, or Ordnance Departments.

RETURN of Buildings in the Occupation of the CONVICT DEPARTMENT, Tasmania.

Prisoners' Barracks, Hobart Town.—Used and required for the accommodation of Male Convicts.

Female Factory, Hobart Town.—Used and required for the accommodation of Female Convicts.

Buildings on Tasman's Peninsula.—1. Port Arthur.—All used and required for the accommodation of Male Convicts.

2. Cascades.—Not used or required for any Convict purpose.

3. Impression Bay.—Already transferred to Colonial Government.

4. Salt Water River.—Not required for any Convict purpose except such accommodation as may be wanted for a District Constable.

5. Coal Mines.—Not required for Convict purposes; a portion of the buildings now occupied by the Lessee of the Mines.

HOBART TOWN.

Military Barracks.—In occupation by Troops.

Main Guard.—Lent on conditions and at a nominal rent of 1s. per annum as a Telegraph Office.

Military Stores.—In occupation.

Prince of Wales Battery and Land attached.—Under repair.

Queen's Battery and ditto.—In use by Volunteer Artillery Company.

Prince Albert Battery and ditto.—Ditto.

Denison Battery and ditto.

Commissariat Office.—In occupation.

Commissariat Stores.—Ditto.

Commissariat Wharf.—Ditto.

Powder Magazine.—One-third of this Magazine is appropriated to the use of the Colony, the Government of which bore that proportion of the expense.

Royal Engineer Office and Yard.—In occupation by Royal Engineer Department.

LAUNCESTON.

Military Barracks.—Not occupied at present in consequence of the reduced state of the Garrison in Tasmania.

Military Officers' Quarters.—Lent on conditions to Colonial Government at a nominal rate of 1s. per annum.

Royal Engineer Yard and Land attached.—Land lent to Colonial Government at a nominal rent of 1s. per annum.

Royal Engineer Office.—Occupied; in charge of Barrack Serjeant.

Ordnance Store.—Occupied by Barrack Department.

Powder Magazine and Guard-room attached.—In bad repair; powder lately removed to New Colonial Magazine.

Commissariat Store.—Has been in occupation by the Colony, but is about to be resumed by the Imperial Government.

RICHMOND.

Military Barracks.—Belong to Imperial Government, but have been in charge of Colonial Government since the year 1855.

CONVICT BUILDINGS.

HOBART TOWN.

Prisoners' Barracks.—These buildings are maintained at the cost of the Imperial Government.

Cascade Factory.—Ditto.

TASMAN'S PENINSULA.

All the Buildings erected thereon, including those at Eagle Hawk Neck.
