

It is calculated that about £3000 additional will be required, and I am desired by the Trustees to enquire whether that sum will be placed at their disposal.

I should deem it a favour to be furnished with an early reply, as until the decision of the Government is received the notices, which are now ready, cannot be served on the several proprietors of the land required.

Sir,

I AM instructed by the Cemetery Trustees to call your attention to my letter of September last, and the Colonial Secretary's reply thereto, dated 23rd November, relative to the funds which are required to enable them to proceed with the important work which has been entrusted to them by the Government.

The delay that has already taken place in furnishing them with the necessary funds has been a source of much regret to the Trustees; and as the work is one which is urgently required on account of the public health, and can never become a burden on the General Revenue, but must necessarily be reproductive and self-supporting, they trust the Government will have no hesitation in taking immediate measures for raising the sum required for the purchase of the land at Cornelian Bay, and the laying out and planting of the grounds, which they are of opinion will not exceed £8000.

The Commissioners have desired me respectfully to suggest that the money might be raised by the issue of special Cemetery Debentures, like those issued by the Hobert Town Corporation for the erection of the City Waterworks, or that the money might be raised directly by the Government and advanced to the Trustees, on terms similar to those on which the amount required for the construction of the Bridge at Bridgewater was lent to the Commissioners for that work.
