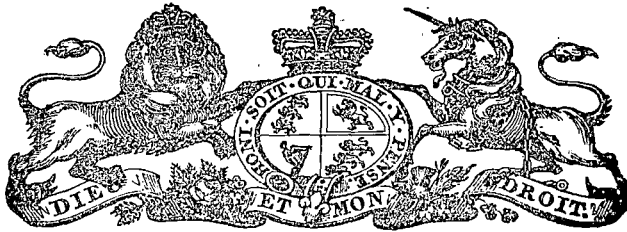

SIR,

I HAVE the honor to submit herewith the Annual Returns of this Prison for the year ended 31st December, 1876.

The Return (A.) shows the Receipts and Expenditure, from which you will observe the cost per head for effectives, taking credit for proceeds of labour, is £7 7s. 3½d., as against £2 2s. per head for 1875, being an increase of £5 5s. 3½d.; this is accounted for by the additional cost for the armed guard and stores.

Return (B.) shows the value of labour and material supplied to departments.

Return (C.)—Description and money value of public work performed.

Return (D.)—Nominal list of prisoners received from Port Arthur.

Return (E.)—Male prisoners tried and convicted at superior courts received during the year.

Return (F.)—Ditto, ditto, discharged ditto.

Return (G.)—Male prisoners tried and convicted at inferior courts received during the year.

Return (H.)—Ditto, ditto, discharged ditto.

Return (I.)—Offences tried at superior courts during the year.

Return (J.)—Male prisoners tried and convicted at inferior courts remaining at end of year.

Return (K.)—Ditto, ditto, superior courts ditto.

Return (L.)—Juvenile prisoners who have passed through the Gaol to Training School, Cascades.

Return (M.)—Visits of Sheriff and Visiting Magistrates during the year.

Return (N.)—Boots and shoes made and repaired during the year, with value of same, &c.

To the above is appended copy of visitors' entries.

During the year seven prisoners effected their escape, one from the Government House Gang, one from the Royal Society's Gardens, one from the Queen's Asylum Farm, one from the stone cells by filing through the iron bar of the window, and three from stone-shed; of this number four were re-captured, and three are still at large. There were also three others who attempted to escape, but were re-captured by the officers of the prison.

The number of cases tried before the Visiting Justices during the year was six; four for absconding, and two for breaches of prison discipline.

The admissions for the year have been 465 as against 521 for the year 1875, and the daily average 139 as against 156 for the previous year.

Shoemaking I may say is the only trade that is carried on in the Establishment: the average number of men employed daily has been 15; of these 5 have been taught the trade in the building, and eight are learners. Recently fine work has been introduced with a view to give the prisoners an opportunity of perfecting themselves in the trade. For quantity of work performed during the year, see Return (N.)

Repairs, &c. to the buildings have been done by prison labour; the amount expended by the Public Works Department for material, &c. was £42 17s. 8d.

The average earnings of each effective prisoner for the year has been £33 Os. 3½d. as against £30 16s. 4d. for 1875.

The officers have been well conducted, and discharged their duties to my satisfaction. The prisoners as a rule have been well behaved.
