A Bill for an Act to provide for, and regulate access to, voluntary assisted dying, to establish the Voluntary Assisted Dying Commission, and for related purposes (Bill No. 30 of 2020 (*Act No. 1 of 2021*))

A Bill for an Act to provide for the protection of the community from persons who have committed offences involving violence, or an element of violence, and who are declared to be dangerous criminals, or who have committed serious offences and are determined to be at a high risk of committing further serious offences, to amend various enactments consequent upon the enactment of this Act, and for related purposes (Bill No. 28 of 2020 (Act No. 2 of 2021))

A Bill for an Act to make provision for the purchase by the Crown of certain land, and improvements, affected by earth movements at Brickmakers Point in Deviot in the West Tamar Council municipal area, and for related purposes (Bill No. 15 of 2020 (*Act No. 3 of 2021*))

A Bill for an Act to amend the Children, Young Persons and Their Families Act 1997, the Commissions of Inquiry Act 1995, the Public Interest Disclosures Act 2002 and the Youth Justice Act 1997 (Bill No. 6 of 2021 (*Act No. 4 of 2021*))

having been presented to the Governor for the Royal Assent, she has, in the name and on behalf of Her Majesty the Queen, assented to the said Bills.
