Clause 13	Repeal of Act
	A mechanism to repeal this Act a year after its commencement date.
Schedule I	Legislation Repealed
	Lists the legislation to be repealed under clause 11.
Schedule 2	Legislation Rescinded
	Lists the legislation to be rescinded under clause 12.
Schedule 3	Legislation Revoked
	Lists the legislation to be revoked under clause 13.
