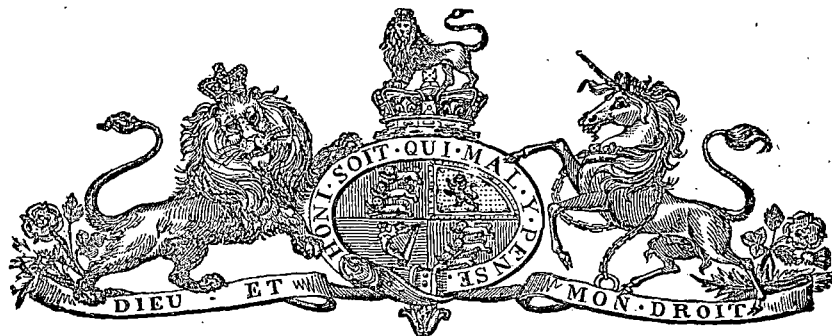

The Joint Committee did not consider it necessary to call for further evidence than is to be found in the documents before referred to.

At various sittings, and after a full discussion of the important questions submitted, this Joint Committee have passed the following Resolutions:—

1. That this Committee is of opinion that the recommendations of Commodore Sir William Wiseman and Brigadier-General Carey for the defence of the City and Port of Hobart Town be approved.

2. That a Militia Bill be submitted to Parliament with as little delay as possible.

3. That, before proceeding to carry out the recommendations of Commodore Sir W. Wiseman and Brigadier-General Carey, this Committee would recommend that His Excellency the Governor be moved to address the Secretary of State on the subject, pointing out the necessity of erecting the Towers recommended by Commodore Sir W. Wiseman and Brigadier-General Carey, and requesting the assistance of the British Government towards the cost of the same.

4. That in the opinion of this Committee the Volunteer Force should be confined to such a body of Artillery as that indicated in the Estimate submitted by the Colonial Secretary on the 19th instant.

5. That a Sergeant-Instructor of Musketry and Orderly-room Clerk be added to the permanent staff of the Southern Division.

6. That in the opinion of this Committee, and in accordance with the recommendations of the Royal Commission, the present Volunteer Force should be disbanded, in order that a force in accordance with Resolution No. 4 may be forthwith organised; and that members of the present Force be invited to join in such proposed organisation.

7. That in the opinion of this Committee it is desirable the said Force should be trained in Light Infantry as well as Artillery drill.

8. That Prizes be offered for attendance at drill, and the best shots with ordnance and rifle, in lieu of grants of land.

In conclusion, the Committee recommend that an Address be presented to His Excellency the Governor, praying that he will be pleased to give effect to the foregoing Resolutions, by desiring his responsible Advisers, at an early date, to prepare such a paper setting forth the claims of the Colony for assistance in the matter of Defence, as will enable him to make an appeal to the Imperial Government with some hope that the liberality which has recently been displayed towards the rich Colony of Victoria will be extended to Tasmania, either by supplying or assisting to supply Towers of the kind recommended by Commodore Sir William Wiseman and General Carey, or by a remission of such an amount of the debt due by the Colony to the Imperial Government as may, under the circumstances, seem just and reasonable.
