THIRTEENTH ANNUAL REPORT of the Inspector of the CONSTABULARY FORCES maintained by the Municipalities in Tasmania for the Year ending the 30th June, 1870.—(Pursuant to 29th VICTORIA, No. 9.)

Office of Inspector of Police, 12th August, 1870.

SIR,

IN presenting this my Thirteenth Annual Report on the state of the Municipal Police Forces in Tasmania, under my supervision, I am enabled to state, that with a few exceptions a fair standard of efficiency and sufficiency has been maintained by them.

With respect to the state of Crime, more than the usual number of offences against the person, several of them involving charges of and convictions for murder, have been reported. The Returns which I have received show, however, as compared with those of the previous year, a slight decrease in the number of indictable offences generally that have been committed, but the difference is too insignificant to be deserving of any particular notice. But robberies are not so prevalent as they were; and, as these are generally committed by vagrants, there is strong reason to believe that if the existing law was vigorously enforced against this class, systematic vagrancy and the evils attendant thereon would be considerably diminished. I observe that much difference, however, prevails in the manner in which the provisions of the Police and other Acts affecting protection of property and good order are carried out in different Municipalities,—leniency towards offenders apparently prevailing to too great an extent.

The number of changes amongst the Constables generally does not appear to have been above the average of preceding years, though variations are more frequent in some forces than others. Numerous changes in a police force materially weaken its efficiency; and it becomes essential in the interests of an efficient system to make provision for men who become worn out in discharge of onerous duties tending to wear out the constitution in a greater degree than many other occupations. This object can, however, only be satisfactorily attained by the re-establishment of a Superannuation Fund, which will require legislative interference.

I observe with regret that a system of taking men into Police Forces as Constables who have been dismissed from the Constabulary for misconduct prevails. This is no doubt not only injurious to the Force generally, but especially to the credit of the establishments into which these men are received. No Constable dismissed from any police force should be admitted into any other except on very special grounds, nor until after reference to the authorities by whom he was so dismissed, and strict enquiry into his previous conduct, and the cause of dismissal.

The late Census having been taken for Electoral Districts, differing vastly in area to Municipal ones, I have not been able to supply the item of population as heretofore, except for Hobart Town and Launceston.

No further extension of Municipal action has taken place since 1866.

A satisfactory standard of efficiency has been maintained in this Force, which was complete at the time of inspection. One Petty Constable was, however, absent, exempt from duty. Its organisation, numerical strength, and pay remain unchanged. The clothing, equipments, and necessaries were of excellent quality. The Force is not armed. Three Constables had resigned, and two had been dismissed for breaches of discipline, but the general conduct of the men was reported by the Superintendent to have been satisfactory. Five Petty Constables had been promoted to the merit class, with an increase of pay.

During the year ending 30th June, 244 indictable offences had been reported to the Police, for which 148 persons had been apprehended, of whom 111 were summarily convicted or committed for trial. 266 persons—146 males and 120 females—had been charged with being drunk and disorderly, and 679 persons—399 males and 238 females—were proceeded against under the Police Act and City Bye Laws. Informations had been laid against 16 publicans, of whom 14 were convicted. The station-house, wards, and cells were in good order, and as cleanly as the nature of the buildings will permit, and the books, records, and returns well and correctly kept. A medical officer, whose professional services the men are not entitled to gratuitously, attends the station-house. The Acting Sub-Inspector is Inspector of Common Lodging-houses, Bailiff of the Small Debts Court, and Summoning Officer of Petty Sessions.

TOWN OF LAUNCESTON.—(*Established 1st January, 1858.*)

This Force has satisfactorily maintained its standard of efficiency, and remains unchanged in organisation and pay. It has been augmented by one Petty Constable in aid of the detective department since last inspection. The Force was complete, and was well clothed and equipped, their arms and accoutrements being in excellent order. Permanency of service continues a very favourable feature, no resignations nor dismissals having occurred within the year.

During the year ending the 30th June, 170 indictable offences had been reported to the Police, for which 125 persons had been apprehended, of whom 72 were summarily convicted or committed for trial. 247 persons—138 males and 109 females—were charged with drunkenness and disorderly conduct, and 447 persons—282 males and 165 females—proceeded against under the Police Act and Bye-laws. 5 publicans had been proceeded against, 4 of whom were fined. The station and cells were in good repair and cleanly, and the books, records, and returns correctly kept. The Superintendent is Examiner of Weights and Measures, and the Sub-Inspector an Inspector of Nuisances. No medical officer is attached to the Force.

GLAMORGAN.—(*Established 28th February, 1860.*)

This Force remains unaltered in its effective numerical strength, organisation, and pay, but an additional Special Constable has been appointed. The only resignation that had taken place was that of the Superintendent, and there had been no dismissal. The clothing was of good quality, and the arms and accoutrements were in serviceable order. A station at the Water Meetings, now the traffic is tending towards the Gold-fields, would add to the efficiency of the Force.

During the year ending 30th June, 20 indictable offences had been reported to the Police, for which a similar number of persons had been apprehended, of whom 8 were summarily convicted or committed for trial. 1 male person had been charged with drunkenness, and 6 persons—3 males and 3 females—have been proceeded against under the Police Act and Bye Laws. No informations had been laid against publicans. The head station-house requires considerable alterations and repairs to ensure security, great defects in its construction having been discovered on the escape of a prisoner. The wards and cells were cleanly, and the books, records, and returns correctly kept. A medical man is attached to the Force. The Superintendent is Bailiff of the Court of General Sessions, Examiner of Weights and Measures, and Inspector of Stock.

SPRING BAY.—(*Established 19th October, 1860.*)

This Force remains unchanged in organisation, numerical strength, and pay. Permanency of service is a good feature in it, there having been no resignations nor dismissals therefrom for two years. No steps have been taken to erect the escort station conjointly with the Municipalities of Richmond and Sorell, which I have suggested should be done for several years past. The clothing, a cheap undress uniform; was in tolerable good order, and the arms and accoutrements serviceable. Slight repairs were required at the head Station-house and at the White Hut Station.

During the year ending 30th June, 2 indictable offences had been reported to the Police, for which 1 person had been apprehended but discharged. 8 persons, 7 males and 1 female, were charged with drunkenness and disorderly conduct, and 2 male persons proceeded against under the Police Act. No informations had been laid against publicans. The wards and cells in the station-houses were cleanly, and the books, records, and returns correctly kept. The Superintendent is Bailiff of the Court of General Sessions, Examiner of Weights and Measures, and Inspector of Stock. No medical man is attached to the Force.

CLARENCE.—(*Established 13th November, 1860.*)

Strength of Force { Effectives 4 } 8

The organisation and numerical effective strength of this Force remain the same, but it has been augmented by the appointment of two Special Constables. It is now clothed in uniform, the Council having complied with my suggestion; the pay of the men has also been increased. The Superintendent had been dismissed for embezzlement, and two Petty Constables reduced as ineffective. The arms and accoutrements were in serviceable order.

During the year ending 30th June, 12 indictable offences had been reported to the Police, for which 13 persons were apprehended, of whom 9 were summarily convicted or committed for trial. 11 persons, 10 males and 1 female, were charged with being drunk and disorderly, and 45 persons proceeded against under the Police Act and Bye-laws. No informations had been laid against publicans. The Station-houses were in good repair, and the cells and wards therein cleanly. The books, records, and returns were correctly kept. No medical man is attached to the Force. The Superintendent is Council Clerk, Examiner of Weights and Measures, and Inspector of Stock and Roads.

RICHMOND.—(*Established 1st August, 1861.*)

Strength of Force 7

No change has taken place in the organisation, numerical strength, nor pay of this Force. The escort station referred to by me in my last Report (to be established conjointly with Sorell and Spring Bay Municipalities) has not been erected but is still required. The uniform worn by the Force was of good quality, and their arms and accoutrements were in serviceable order. One Sub-Inspector had been removed as inefficient.

During the year ending 30th June, 29 indictable offences had been reported to the Police, for which 25 persons were apprehended, of whom 20 were summarily convicted or committed for trial. 56 persons, 44 males and 12 females, were charged with being drunk and disorderly, and 68 persons, 54 males and 14 females, proceeded against under the Police Act and Bye-laws. No informations had been laid against publicans. The Station-house was in good repair, and the wards and cells therein cleanly. The books, records, and returns were correctly kept. The Superintendent is Council Clerk, and a Sergeant acts as Bailiff of the Court of General Sessions. No medical officer is attached to the Force.

OATLANDS.—(*Established 9th January, 1862.*)

Strength of Force 7

The organisation and pay of this Force remain unaltered, but one Petty Constable at head quarters has been dispensed with without materially impairing its efficiency. The pay is, however, inadequate, and ought to be increased to its original standard. One Constable had resigned, having received an appointment in another Municipality. The uniform was of good quality, and the arms and accoutrements in serviceable order.

During the year ending 30th June, 46 indictable offences had been reported to the Police, for which 29 persons were apprehended, of whom 23 were summarily convicted or committed for trial. 58 persons, 44 males and 14 females, were charged with being drunk and disorderly, and 225 persons, 164 males and 61 females, proceeded against under the Police Act and Bye-laws. 10 Publicans were proceeded against, of whom 9 were fined. The Station-houses were in good repair, the Wards and Cells therein cleanly, and the books, records, and returns correctly kept. The Superintendent is Bailiff of the Court of General Sessions, Examiner of Weights and Measures, and Inspector of Stock. No medical man is attached to the Force.

LONGFORD.—(*Established 28th February, 1862.*)

Strength of Force 8

This Force continues to be well paid, well appointed, and to retain the same organation as

heretofore, but its numerical strength has been reduced by the removal of a Petty Constable whom the discontinuance of the Railway Works rendered it no longer necessary to retain. The Uniform was of good quality, and the Arms and Accoutrements in serviceable order. There had been no resignations nor dismissals from the Force.

During the year ending 30th June, 50 indictable offences had been reported to the Police, for which 32 persons were apprehended, of whom 24 were summarily convicted or committed for trial. 183 persons, 128 males and 55 females, were charged with being drunk and disorderly, and 121 persons, 93 males and 28 females, proceeded against under the Police Act and Bye-laws. One information had been laid against a Publican but dismissed. The Station-houses were all in good repair, the Wards and Cells therein cleanly, and the books, records, and returns correctly kept. The Superintendent is Bailiff of the Court of General Sessions, Examiner of Weights and Measures, and Inspector of Stock. No medical man is attached to the Force.

GREEN PONDS.—(*Established 15th April, 1862.*)

Strength of Force 7

The organisation and numerical strength of this Force, together with its standard of efficiency, remain unaltered. Permanency of service is a favourable feature in it, there having been no resignations nor dismissals for two years. The Clothing was of excellent quality, and the Arms and Accoutrements in serviceable order.

During the year ending the 30th June, 46 indictable offences had been reported to the Police, for which 30 persons were apprehended, of whom 25 were summarily convicted or committed for trial. 25 persons, 18 males and 7 females, were charged with drunkenness and disorderly conduct, and 142 persons, 93 males and 49 females, were proceeded against under the Police Act and Bye-laws. No Publicans had been proceeded against. The Station-houses were in good repair, and the Wards and Cells cleanly. The books, records, and returns were correctly kept. The Superintendent is Council Clerk, Examiner of Weights and Measures, and a Sergeant acts as Bailiff of the Court of General Sessions. No medical man is attached to the Force.

SORELL.—(*Established 30th June, 1862.*)

Strength of Force 5

The efficiency of this Force under its present organisation, as I anticipated last year, is not satisfactory, and an expression of opinion among the ratepayers to this effect is very prevalent. I found that an ill-feeling existed between members of the Force, striking at the very root of discipline and mutual co-operation. I was given to understand that a want of unanimity in the Municipal Council tended to a continuance of the then existing state of things. The Mounted-troopers (2) are not clothed in uniform, the other Constables wearing an undress one. The pay of the Force has, as I recommended, been slightly increased.

During the year ending 30th of June, 24 indictable offences had been reported to the Police, for which 24 persons were apprehended, of whom 5 only were summarily convicted or committed for trial. 29 persons, 14 males and 15 females, were charged with drunkenness and disorderly conduct, and 41 persons, 21 males and 20 females, were proceeded against under the Police Act and Bye-laws. 8 informations had been laid against publicans, one of whom only was fined. No resignations nor dismissals from the Force had taken place. The Station-house was in tolerably good repair, and the wards and cells cleanly. The books, records, and returns were correctly kept. The Superintendent is Council Clerk, Examiner of Weights and Measures, and Inspector of Stock. A Constable is Bailiff of the Court of General Sessions. No medical officer is attached to the force.

BOTHWELL. (*Established 31st January, 1863.*)

Strength of Force 4

The organisation, numerical strength, and pay of this Force remain unchanged. Permanence of service prevails, there having been during the last two years neither a resignation nor a dismissal. The clothing was of good quality, and the arms and accoutrements were in serviceable order.

During the year ending 30th June, 24 indictable offences had been reported to the Police, for which 18 persons were apprehended, all of whom were summarily convicted or committed for trial. 20 persons, 12 males and 8 females, were charged with drunkenness and disorderly conduct; and 69 persons, 51 male and 18 females, were proceeded against under the Police Act and Bye-laws. No informations had been laid against publicans. The Station-houses were in good repair, and the wards and cells therein cleanly. The books, records, and returns were correctly kept. The Superintendent is Bailiff of the Court of General Sessions, Examiner of Weights and Measures, and Inspector of Stock.

ROSS. (*Established 17th February, 1863.*)

Strength of Force { Effectives 3 }
 { Special.. 1 } 4

Since my last Report, two Special Constables have been reduced without, however, impairing the efficiency of this Force. Its organisation and pay remain unaltered. Two Petty Constables had resigned. The clothing was of good quality, and the arms and accoutrements were in serviceable order.

During the year ending 30th June, 21 indictable offences had been reported to the Police, for which 17 persons were apprehended, of whom 14 were summarily convicted or committed for trial. 27 persons, 19 males and 8 females, were charged with drunkenness and disorderly conduct, and 129 persons, 97 males and 32 females, proceeded against under the Police Act and Bye-laws. Three publicans had been proceeded against, two of whom were fined. The Station-house was in good repair, and the cells cleanly. The books, records, and returns were correctly kept. The Superintendent is Examiner of Weights and Measures, and Inspector of Stock. A Constable is Bailiff of the Court of General Sessions. There is no medical man attached to the Force.

FINGAL.—(Established 27th February, 1863.)

Strength of Force..... 13

Consequent on the considerable increase of population on the Mangana and Blackboy Diggings, this Force, which maintains its standard of efficiency, has been augmented by two Petty Constables, its organisation and pay remaining unchanged. No steps have yet been taken to enlarge the station-house at Avoca. One Petty Constable had been dismissed. The uniform was of good quality, and the arms and accoutrements in serviceable order.

During the year ending 30th June, 29 indictable offences had been reported to the Police, for which 21 persons were apprehended, of whom 15 were summarily convicted or committed for trial. 61 persons—39 males and 22 females—were charged with drunkenness and disorderly conduct, and 118 persons—75 males and 43 females—proceeded against under the Police Act and Bye-laws. The station-houses, wards, and cells were cleanly, and the books, records, and returns correctly kept. The Superintendent is Bailiff of the Court of General Sessions, Examiner of Weights and Measures, and Inspector of Stock. There is no medical man attached to the Force.

NEW NORFOLK.—(Established 17th March, 1863.)

Strength of Force..... 7

This Force maintains its standard of efficiency, having undergone no change in organisation, numerical strength, or pay since my last inspection. It is well distributed, a station at the Dry Creek having been established, and a Constable removed thither from Head Quarters. No resignations nor dismissals having taken place for several years, permanency of service is a leading feature in its character. The clothing was of good quality, and the arms and accoutrements were in serviceable order.

During the year ending 30th June, 65 indictable offences had been reported to the Police, for which 41 persons were apprehended, all of whom were summarily convicted or committed for trial. 49 persons—28 males and 21 females—were charged with drunkenness and disorderly conduct, and 91 persons—67 males and 24 females—proceeded against under the Police Act and Bye-laws. Five publicans had been convicted and fined. The station-houses were in good repair, and the wards and cells cleanly. The books, records, and returns were correctly kept. The Superintendent is Bailiff of the Court of General Sessions, Examiner of Weights and Measures, and Inspector of Stock.

HAMILTON.—(Established 13th September, 1863.)

Strength of Force..... 6

No change has been made in the organisation, numerical strength, or pay of this Force, which is efficient. One Constable had been dismissed, and a vacancy, caused by the reduction of a member of the Force, filled up since my last inspection. The clothing was of good quality, and the arms and accoutrements in serviceable order.

During the year ending 30th June, 30 indictable offences had been reported to the Police, for which 15 persons were apprehended, all of whom were summarily convicted or committed for trial. 19 persons—17 males and 2 females—were charged with being drunk and disorderly, and 29 persons—28 males and 1 female—proceeded against under the Police Act and Bye Laws. No informations had been laid against publicans. The station-houses were in good repair, the wards and cells cleanly, and the books, records, and returns correctly kept. The Superintendent is Bailiff of the Court of General Sessions, Examiner of Weights and Measures, and Inspector of Stock. No medical man is attached to this Force.

BRIGHTON.—(Established 19th November, 1863.)

Strength of Force { Effectives 4 } 5
 { Special.. 1 }

The organisation of this Force, together with its numerical strength and pay, remain unaltered. To make it efficient, I consider another Constable is required at head quarters. The clothing was of good quality, and the arms and accoutrements in serviceable order. No dismissals or resignations had taken place.

During the year ending the 30th June, 33 indictable offences had been reported to the Police, for which 18 persons had been apprehended, all of whom were summarily convicted or committed for trial. 40 persons, 29 males and 11 females, were charged with being drunk and disorderly; and 122 persons, 110 males and 12 females, proceeded against under the Police Act and Bye-laws. No informations had

been laid against publicans. The Station-houses, wards, and cells were cleanly; and the books, records, and returns correctly kept. The Superintendent is Bailiff of the Court of General Sessions, Examiner of Weights and Measures, and Inspector of Stock. No medical man is attached to the Force.

WESTBURY.—(*Established 15th December, 1863.*)

Strength of Force { Effectives 11 } 12
 { Special.. 1 }

The numerical effective strength of this Force has been reduced,—the services of a Petty Constable at Carrick having been dispensed with, and a special substituted, the townships being visited twice a week by out-station Constables. The Police protection afforded is not, I think, sufficient for a populous locality. Its organisation and pay remain unaltered. One Constable had been dismissed and one reduced since last inspection. The clothing was of good quality, and the arms and accoutrements in serviceable order.

During the year ending 30th June, 76 indictable offences had been reported to the Police, for which 45 persons were apprehended, of whom 22 were summarily convicted or committed for trial. 107 persons—79 males and 28 females—were charged with drunkenness and disorderly conduct, and 153 persons—124 males and 29 females—proceeded against under the Police Act and Bye-laws. No informations had been laid against publicans. The station-houses were in good repair, the wards and cells cleanly, and the books, records, and returns correctly kept. The Superintendent is Bailiff of the Court of General Sessions, Examiner of Weights and Measures, and Inspector of Stock. No medical man is attached to the Force.

DELORAIN.—(*Established 15th December, 1863.*)

Strength of Force 6

The numerical strength, pay, and organisation of this Force remain unaltered. The Superintendent had resigned, and the Sub-Inspector in charge promoted to the vacant office. One Petty Constable had also resigned. The clothing was of good quality, and the arms and accoutrements in serviceable order.

During the year ending 30th June, 42 indictable offences had been reported to the Police, for which 32 persons had been apprehended, of whom 25 were summarily convicted or committed for trial. 112 persons—80 males and 32 females—were charged with drunkenness and disorderly conduct, and 121 persons—94 males and 27 females—proceeded against under the Police Act and Bye-laws. No proceedings had been taken against publicans. The station-houses were in good repair, the wards and cells cleanly, and the books, records, and returns correctly kept. The Superintendent is Bailiff of the Court of General Sessions, Examiner of Weights and Measures, and Inspector of Stock. No medical man is attached to the Force.

GLENORCHY.—(*Established 30th June, 1864.*)

Strength of Force 7

This Force satisfactorily maintains its standard of efficiency; its organisation, numerical strength, and pay remain unchanged. A Petty Constable holds the appointment of Water Bailiff under the Salmon Commissioners. There had been no resignations nor dismissals. The clothing was of excellent quality, and the arms and accoutrements were in serviceable order.

During the year ending 30th June, 9 indictable offences had been reported to the Police, for which 5 persons were apprehended, of whom 3 were summarily convicted or committed for trial. 21 persons—14 males and 7 females—were charged with drunkenness and disorderly conduct, and 25 persons—22 males and 3 females—proceeded against under the Police Act and Bye-laws. No informations had been laid against publicans. The station-house does not afford sufficient accommodation, but the wards and cells were cleanly. The books, records, and returns were correctly kept. The Superintendent is Bailiff of the Court of General Sessions, Examiner of Weights and Measures, and Inspector of Stock. No medical man is attached to the Force.

EVANDALE.—(*Established 29th December, 1865.*)

Strength of Force 7

The organisation, pay, and numerical strength of this Force remain unaltered, and its standard of efficiency has been maintained. The Special Constable employed on the railway works had been reduced. The Head Station, though in the best repair in which it can be maintained, requires to be replaced by an entirely new building affording more accommodation. One Petty Constable had resigned and another had been dismissed. The Clothing was of good quality, and the Arms and Accoutrements were in serviceable order.

During the year ending 30th June, 16 indictable offences had been reported to the Police, for which 11 persons were apprehended, of whom 8 were summarily convicted or committed for trial. 59 persons, 49 males and 10 females, were charged with drunkenness and disorderly conduct, and 71 persons, 67 males and 4 females, proceeded against under the Police Act and Bye-laws. No information had been laid against Publicans. The Wards and Cells in the Station-house were cleanly, and the Books, Records, and Returns correctly kept. The Superintendent is Bailiff of the Court of General Sessions, Examiner of Weights and Measures, and Inspector of Stock. No medical man is attached to the Force.

CAMPBELL TOWN.—(*Established 18th September, 1866.*)

Strength of Force 9

This Force maintains its standard of efficiency, its organisation and numerical strength remaining unchanged. No steps had been taken towards enlarging the Head Station-house, which does not at present afford sufficient accommodation. The Clothing was of good quality, and the Arms and Accoutrements were in serviceable order. Two Petty Constables had resigned.

During the year ending 30th June, 25 indictable offences had been reported to the Police, for which 16 persons were apprehended, of whom 13 were summarily convicted or committed for trial. 58 persons, 36 males and 22 females, were charged with drunkenness and disorderly conduct, and 38 persons, 28 males and 10 females, were proceeded against under the Police Act and Bye-laws. Two Publicans had been convicted and fined. The Station-houses were in good repair, the Wards and Cells cleanly, and the books, records, and returns correctly kept. The Superintendent is Bailiff of the Court of General Sessions, Examiner of Weights and Measures, and Inspector of Stock. No medical man is attached to the Force.
