A BILL FOR

An Act to amend certain Acts consequent on the enactment of the *Traffic Amendment Act 2009*

Be it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:

PART 1 – PRELIMINARY

1. Short title

This Act may be cited as the *Traffic Amendment* (Road Rules Consequential Amendments) Act 2009.

2. Commencement

This Act commences on the day on which this Act receives the Royal Assent.
