A BILL FOR

An Act to amend certain Acts consequent on the enactment of the *National Parks and Reserves Management Act 2002* and the *Nature Conservation Act 2002*

Be it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:

Short title

1. This Act may be cited as the *National Parks and Wildlife Separation (Consequential Amendments) Act 2002.*

Commencement

2. This Act commences on the day on which the *National Parks and Reserves Management Act 2002* commences.
