### **Notices of Motion**

- **166** The Minister for Health to move—That the House:—
  - (1) Notes that National Stroke Week 2019 is taking place from 2-8 September 2019.
  - (2) Further notes that the theme for National Stroke Week in 2019 is "F.A.S.T. Heroes" recognising the everyday heroes who have spotted the signs of a stroke and called an ambulance straight away.
  - (3) Further notes the F.A.S.T. test helps us to remember the stroke signs we need to watch out for and what to do if you suspect somebody is having a stroke:—
    - (a) Face has the person's face dropped;
    - (b) Arms can they lift both arms;
    - (c) Speech is the person's speech slurred and can they understand what is being said; and
    - (d) Time calling 000 as soon as possible is critical.
  - (4) Congratulates the Stroke Foundation for their outstanding work to provide support for people living with stroke and raising awareness of stroke both locally and nationally.
  - (5) Acknowledges the Tasmanian Government's strong investment in boosting access to stroke services and support, including \$440,000 of funding provided to the Stroke Foundation in 2018 and the new stroke telemedicine service which will commence later in 2019 thanks to the recruitment of full time neurologists to service the North and North-West. (5 September 2019)
- 167 The Minister for Health to move—That the House:—
  - (1) Recognises Women's Health Week, which takes place from September 2 -6, with the theme of movement Put your best foot forward for your health.
  - (2) Notes the two biggest barriers for women not maintaining a healthy lifestyle is 'lack of time' and 'health not being a priority'.
  - (3) Further notes that Women's Health Week serves as a timely reminder to all women that they need to look after themselves, inside and out.
  - (4) Supports the Tasmanian Women's Strategy 2019-2021, which focuses on four priority areas financial security, leaderships and participation, safety and health and wellbeing.
  - (5) Acknowledges the Hodgman Liberal Government has taken strong action on this issue, including investment of \$435,200 to Women's Health Tasmania to improve health and wellbeing outcomes for Tasmanian women, especially women vulnerable to poorer health. \$398,100 was also allocated to The Link Youth Health Services to provide an implement services which improve the health and wellbeing of young people, noting that young women represent the majority of service clients.
  - (6) Encourages individuals, communities and workplaces to get involved by sharing our health messages, hosting an event and encouraging as many women as possible to sign up to the week. (3 September, 2019)

- 168 The Minister for Police, Fire and Emergency Management to move—That the House:—
  - (1) Recognises that the Government has a duty to protect those who protect us.
  - (2) Notes that the Hodgman majority Liberal Government makes no apology for taking strong action to protect people from the scourge of drugs and violence.
  - (3) Further notes Labor's track record of siding with the Greens when it came to the Hodgman majority Liberal Government's strong action to protect Tasmanians by cracking down on serious organised crime and outlaw motorcycle gangs, even against the advice of Tasmania Police and the Australian Criminal Intelligence Commission.
  - (4) Further notes that just like the Greens, Labor opposed and continue to oppose guaranteed prison time for assaults on off duty police officers.
  - (5) Further notes that Labor together with the Greens opposed and continue to oppose protections for our frontline workers and oppose guaranteed prison time for criminals who assault our frontline workers.
  - (6) Further notes that Labor just like the Greens, consistently opposes guaranteed prison time for serious child sex offenders.
  - (7) Further notes that Labor, like the Greens, has no policies to support the police in their role to protect the Tasmanian community.
  - (8) Would welcome the Government bringing forward new legislation to guarantee prison time for assaults on frontline workers and serious child sex offenders. (5 September 2019)
- Ms O'Connor to move—That the House condemns the Hodgman Liberal Government for its reckless mismanagement of wildlife in Tasmania that is driving species towards extinction. (5 September 2019)
- 170 Ms *Dow* to move—That the House:—
  - (1) Notes that Tas Ports has called for \$80 million to be invested in the Burnie Port to deliver the upgrades outlined in the Burnie Port Masterplan.
  - (2) Confirms that the Hodgman Liberal Government has failed to allocate any State money to the project in the 10 year infrastructure pipeline released during the week commencing 2 September 2019.
  - (3) Acknowledges the potential for job-expansion in mining, agriculture, forestry and tourism relies on upgrades at the Burnie Port.
  - (4) Further notes that the Hodgman Liberal Government has failed to invest in a project that is crucial to protect and grow Tasmanian jobs at a time when the state desperately needs leadership on jobs.
  - (5) Further notes that businesses have told Tasmanian Labor that capacity constraints at the Burnie Port are costing them thousands and are particularly jeopardizing new jobs and investment in the minerals sector.
  - (6) Further acknowledges that more than 5,100 full time Tasmanian jobs have been lost in the past year with the North-West and West Coast suffering severely under the Hodgman Liberal Government.
  - (7) Further confirms that this is yet another example of how people on the North-West Coast and in regional Tasmania are being left behind by the Hodgman Liberal Government. (10 September 2019)
- 171 Ms O'Connor to move—That the House:—
  - (1) Acknowledges the critical role forests play in carbon sequestration and oxygen production.
  - Understands that to prevent the extremes of global heating the carbon that is in the ground, must stay in the ground.
  - (3) Calls on the Labor and Liberal Parties to support the protection of the 356,000ha of high conservation value, carbon-rich forests set aside under the Tasmanian Forests Agreement. (10 September 2019)
- 172 Dr Woodruff to move—That the House:—

- Acknowledges the bushfire season has started early and ferociously in eastern Australia, with large out of control bushfires in New South Wales and Queensland.
- (2) Recognises these fires have caused devastating losses to families and businesses, with firefighters battling horrific high wind conditions with at least one critically injured.
- (3) Further acknowledges with concern the bushfires that ravaged 3% of the State last summer, and that these extreme bushfire seasons are going to become more common unless we reverse atmospheric overheating.
- (4) Condemns the Liberals for their lack of action on the climate emergency.
- (5) Notes the Hodgman Government did not agree to fully implement all of the recommendations of the 2016 Tony Press Report and ignored the recommendations of a Report prepared by Tasmania Fire Service union and authors Simon Pilkington and Alex Dean.
- (6) As a hot, dry summer approaches, calls on the Government to table information detailing the changes that have been implemented leading up to the next fire season, including the number of employed and volunteer Remote Area Firefighters now, compared to early 2019, and any increase in resourcing to implement the 2019 Australian Fire and Emergency Service Authorities Council recommendations. (10 September 2019)

### 173 Ms *O'Byrne* to move—That the House:—

- (1) Recognises that family violence is Tasmania's greatest community safety and law and order issue.
- (2) Further recognises that the Family Violence Counselling and Support Service (FVCSS) sits within the Tasmanian Government Safe at Home service delivery framework.
- (3) Notes:—
  - (a) that the FVCSS Adult Program was not acknowledged in the Safe Homes, Families, Community Action Plan 2019-2022. The omission fails to recognise that 6,126 referrals of victims of family violence were assessed, contacted, supported and provided with counselling, information and support by the FVCSS;
  - (b) there has been no increased investment in the Adult Program of the FVCSS. The Tasmanian Government has not supported the FVCSS to meet current demand. Adding single worker services in the community and fragmenting the provision of service delivery has not created additional capacity in the sector.
  - (c) that the FVCSS has seen an increase in demand of 200% and that 6,126 clients were referred or accessing this service in the last year; and
  - (d) that in order to meet demand the FVCSS has identified a staffing shortfall of 11.54 FTW statewide.
- (4) Further notes:—
  - (a) with concern the proposal to integrate sexual assault and family violence sectoral response; and
  - (b) the Federal Government decision to fund couples counselling for victims of family violence.
- (5) Calls on the State Government to recognise the FVCSS as an integral part of the Safe at Home service delivery model and fund the staffing shortfall immediately. (10 September 2019)

### 174 The Minister for Veterans' Affairs to move—That the House:—

- (1) Recognises that 15 September 2019 is Battle of Britain Day, an annual day of remembrance for those who fought and died in the Battle of Britain, history's first entirely aerial campaign and a strategic turning point of the Second World War.
- (2) Notes that the Battle occurred over the United Kingdom between 10 July 1940 and 31 October 1940 between the air forces of Nazi Germany and the then British Empire and Commonwealth.
- (3) Further notes that Allied success in the Battle was pivotal in seeing the planned seaborne invasion of the United Kingdom by Hitler's Germany cancelled, allowing the British Isles to eventually become the springboard from which the invasion of

- occupied Europe was performed, leading to the liberation of millions under Nazi oppression.
- (4) Pays tribute to 'The Few', as Winston Churchill immortally named the fighter pilots fighting in the skies over Britain, for their service, courage and sacrifice, including more than thirty Australians, 14 of whom died in the Battle including Flight Lieutenant Stuart Walch, of Hobart, who attended the Hutchins School before joining the RAAF.
- (5) Acknowledges that over this coming weekend, a memorial service commemorating the Battle will be held at St David's Cathedral and a wreath laying service at the Hobart Cenotaph with representatives from the Australian Defence Force, foreign militaries, ex-service organisations and all levels of Government attending and encourages all Tasmanians to pay their respects. (10 September 2019)

# 175 Mrs *Rylah* to move—That the House:—

- (1) Acknowledges that the Hodgman Liberal Party Government is working with primary producers to develop their exports, particularly into key Asian markets.
- (2) Notes that Tasmanian growers will be showcasing our produce at Hong Kong's Fruit Logistics in the week 10 13 September 2019 which attracts more than 13,000 buyers from over 76 countries enabling Tasmanian producers to connect with key buyers and importers across Asia.
- (3) Further notes in 2019 Fruit Growers Tasmania has partnered with Brand Tasmania to exhibit at Asia Fruit logistics in their own right under the unique Tasmanian banner of 'the quiet pursuit of the extraordinary.'
- (4) Further acknowledges that Tasmania's brand is one of our State's greatest assets and Tasmanian growers will affirm their commitment to exceptional quality which is expected to boost export demand for our premium horticultural products.
- (5) Further notes that a key priority in our Trade Strategy is to build the export capability of local businesses and growing our agricultural exports will help deliver our target to grow the annual farm gate value of Tasmanian agriculture to \$10 billion by 2050.
- (6) Recognises that over 80 per cent of Tasmania's exports are consigned to the Asian region, with China and Hong Kong alone accounting for 35 per cent of total Tasmanian exports.
- (7) Further acknowledges that the Tasmanian Government is committed to empowering businesses to take their products to the world, so that the Tasmanian economy continues to grow, creating local jobs. (10 September 2019)

### 176 Mrs *Rylah* to move—That the House:—

- (1) Acknowledges that the '2018 19 Preliminary Outcomes Report', confirmed that the Hodgman Liberal Government, has delivered a balanced State Budget, returning a modest surplus of \$101.9 million.
- (2) Notes that the same Report shows the Government is on track to deliver a surplus for the fourth year in a row of approximately 1.6 per cent of revenue.
- (3) Further acknowledges that the NAB Monthly Business Survey results, for the seventh month in a row, found that Tasmania's business conditions are the best in the nation, three times better than the national result in trend terms.
- (4) Recognises that the this Government continues to have a strong balance sheet, holds net cash and investments, as opposed to net debt.
- (5) Further acknowledges that only by keeping the Budget strong can we deliver record investments in health, education and infrastructure. (10 September 2019)

# 177 Mrs *Rylah* to move—That the House:—

- (1) Acknowledges that Tourism contributes more than \$3 billion to Tasmania's economy.
- (2) Notes that our Tourism industry supports approximately 38,000 jobs–15.6% of total employment across the State.
- (3) Records that the Hodgman Liberal Government continues to invest strongly into our visitor economy, ensuring all regions reap the benefits.
- (4) Recognises that as a part of our 2019-20 Budget, this Government has committed \$20 million into the 'Regional Loan Attraction Scheme' that provides low interest loans of up to \$1 million for business to invest in new job creating tourism projects.

- (5) Congratulates the Hodgman Liberal Government for continuing to support visitor growth in Tasmania by:—
  - (a) supporting Tourism Tasmania marketing;
  - (b) growing the number of flights to the north of the State;
  - (c) launching the Western Wilds drive journey and the next iconic walk;
  - (d) investing \$72 million in our 'Roads to Support Tasmania's Visitor Economy' program; and
  - (e) investing in the 'Event Attraction Fund' which helps attract major events to regional centres. (10 September 2019)

### 178 Mrs *Rylah* to move—That the House:—

- (1) Acknowledges the purchase of Specialty Veneers timber processing business by Britton Timbers.
- (2) Notes that Specialty Veneers is a productive member of the Tasmanian timber industry producing a premium range of products for the joinery and furniture industries.
- (3) Further notes that Specialty Veneers also manufacture and supply a number of quality solid Tasmanian timber species under the Corinna Timbers name.
- (4) Congratulates the famous Tasmanian timber industry family business, Britton Timbers on their announcement in late August 2019 of the purchase of the Specialty Veneers company.
- (5) Further notes that Britton Timbers now employ in excess of 180 people, the majority of which live in regional areas.
- (6) Further notes that this purchase is a vote of confidence in the Tasmanian timber industry, helping secure the future of over 20 employees in the North West region.
- (7) Further acknowledges the industry's confidence, backed by the solid support of the Hodgman Liberal Government. (10 September 2019)

### 179 Mr *Tucker* to move—That the House:—

- (1) Notes the continued failure of the Tasmanian Leader of the Opposition, Hon. Rebecca White MP to develop a long-term Plan for Tasmania, after two and a half years in the role.
- (2) Further notes the inconsistency of the Opposition on whether former Labor candidates will be invited and accepted back into the Labor Party if they are successful in the recount for the seat of Clark.
- (3) Further notes that the chaos and dysfunction within the Opposition has resulted in the unprecedented intervention of former Labor senior figures including former Premiers Paul Lennon and David Bartlett, and former MPs Harry Quick and Julian Amos to restore policy consistency.
- (4) Agrees with the comments of former Labor MHR Harry Quick, who said the Tasmanian Opposition Leader was "out of touch" and "fixated on peripheral issues".
- (5) Further agrees with the sentiment of the Derwent Valley Branch of the Labor Party expressed in its motion at the recent State Labor Council stating "we cannot expect people to vote for us without greater clarity about what we stand for and present it in a manner that is specific to them and is easily identified".
- (6) Calls on the Leader of the Opposition, Hon. Rebecca White MP, to develop a longterm Plan for Tasmania, to develop an alternative budget and be honest with the community on what her party can and cannot deliver for Tasmanians. (10 September 2019)

**6** Roads and Jetties Amendment (Validation) Bill 2019 (No. 25 of 2019): Adjourned Debate on the Question proposed on Tuesday, 10 September 2019 by the Minister for Infrastructure – That the Bill be now read the Second time. (Next Speaker: Mrs *Rylah*)

7 Battery of the Nation: Adjourned Debate on the Question proposed on Wednesday, 31 July 2019 by Mrs *Rylah*—That the House:—

- (1) Notes Tasmania has the renewable and dispatchable energy the rest of the nation needs, and the Hodgman Liberal Government is committed to using this advantage to ensure all Tasmanians benefit.
- (2) Records this Governments continuing drive for the development of the Battery of the Nation and the crucial second interconnector, the Marinus project, which have the potential to inject up to \$5 billion into the Tasmanian economy and deliver 2,000 jobs, particularly into regional areas.
- (3) Further notes that the development stage of the first phase of the Battery of the Nation carries the commitment of the Federal Government through the Federal Underwriting New Generation Investment program.
- (4) Further notes that support by both the Hodgman Liberal Government and the Federal Government, gives UPC Renewables and AC energy, more confidence to develop their Robbins Island and Jims Plain wind and solar parks.
- (5) Recognises that Tasmania has a world-class wind resource complemented by our pumped hydro that means there will always be some electricity available for export when the mainland is experiencing low wind or high demand.
- (6) Acknowledges that the Australian Government clearly recognises the importance of Tasmania's energy solutions and our status as the leading energy state.
- (7) Commends the Hodgman Liberal Government for its strong commitment to making use of the natural resources available to the State while at the same time ensuring all Tasmanians will have access to low cost, reliable and clean energy in their homes and businesses. (Mrs *Rylah*)

To which the following amendment has been proposed by Dr *Woodruff*, by leaving out all words after "That the House:-" and inserting instead:

- "(1) Notes that the Liberals repeatedly talk about the Marinus project and use it as a political wedge, particularly during election periods, despite the fact that they have not put forward a financing proposal or a position on who should finance the multi-billion project.
- (2) Agrees that the project could cost in excess of current total Public Non-Financial Corporations Sector debt, and feasibility studies and prominent economists such as Saul Eslake have raised serious concerns about the viability of the project, which have not been addressed by the State Government.
- (3) Notes that the Liberals passed legislation to set wholesale electricity prices at a rate higher than projected, leading to energy bills decreasing by less than they would otherwise would have.
- (4) Notes with alarm that the Liberal Government continues to allow Entura to engage in profiteering from immoral projects overseas such as the Karuma hydro power project Uganda, which has been linked to killings and other human rights violations.

- (5) Condemns the Liberal Government for their lack of honesty, ethics or plan in their handling of the Energy portfolio." (Next Speaker: Minister for Energy)
- **8** Minimum Mandatory Sentences: Adjourned Debate on the Question proposed on Wednesday, 7 August 2019 by Mr *Tucker*—That the House:—
  - (1) Welcomes the Federal Labor party's recent sensible backflip on minimum mandatory sentences for crimes relating to child abuse.
  - (2) Acknowledges the Tasmanian Labor Party is now out of step with its Federal Labor colleagues.
  - (3) Supports the introduction of minimum mandatory sentences for serious sexual offences against children. (Next Speaker: The Attorney-General)
- **9** Housing and Homelessness: Adjourned Debate on the Question proposed on Thursday, 8 August 2019 by the Minister for Housing—That the House:—
  - (1) Acknowledges the dedicated work that is being done every day in the community and housing sectors to support Tasmanians experiencing homelessness or who are at risk of homelessness.
  - (2) Further acknowledges that homelessness is often linked to other challenges such as mental illness, and the Tasmanian Government is focusing on the integration of mental health services to provide more holistic support and greater independence for clients.
  - (3) Further acknowledges that Tasmania's Affordable Housing Strategy is responding to the current challenges in the housing market by boosting supply across a spectrum of needs.
  - (4) Further acknowledges that the Affordable Housing Action Plan Stage 2 and the additional investment in funding is another positive step towards continuing this momentum.
  - (5) Recognises that all levels of government have a role to play in addressing the supply and demand in our housing market.
  - (6) Call on all Members to work together to put the needs of Tasmanians above political point scoring. (Next Speaker: Minister for Housing)
