- 1 The House met at Ten o'clock a.m.
- 2 ACKNOWLEDGEMENT OF TRADITIONAL PEOPLE. - The Speaker made a statement acknowledging the traditional people of the land.
- 3 PRAYERS AND REFLECTION. – The Speaker read Prayers.
- 4 QUESTIONS SEEKING INFORMATION. – In accordance with Standing Order No. 43, Questions without notice were asked.
- 5 PAPERS. – The Minister for Primary Industries and Water laid upon the Table of the House the following Papers:-

**10 MESSAGE FROM HER EXCELLENCY THE GOVERNOR.** – The Speaker read the following Message from Her Excellency the Governor:-

MESSAGE.

C. WARNER, *Governor*.

A Bill for an Act to provide for special measures, related to the social and financial effects of the COVID-19 disease in the State, in relation to commercial leases (Bill No. 19 (*Act No.13 of 2020*))

having been presented to the Governor for the Royal Assent, she has, in the name and on behalf of Her Majesty the Queen, assented to the said Bills.

**11 BILL NO. 21.** – The Minister for State Growth presented -

“A Bill for an Act to amend the Land Use Planning and Approvals Act 1993, the Electricity Supply Industry Act 1995 and the Water and Sewerage Industry Act 2008”.

And Mr *Ferguson* having presented the said Bill, the same was read the First time and made an Order of the Day for tomorrow.

**12 LEAVE TO MAKE MOTION WITHOUT NOTICE.** - *Ordered*, That the Minister for Infrastructure and Transport have leave to make certain Motions without Notice. (The Minister for Infrastructure and Transport)

**13 SUSPENSION OF STANDING ORDERS.** – *Ordered*, That so much of Standing and Sessional Orders be suspended as would prevent the Order of the Day for the second reading of the Regulatory Reform Amendments Bill 2020 from being called at this day’s sitting (The Minister for Infrastructure and Transport)

**14** SITTING TIMES. – *Ordered*, that for this day’s sitting the House not stand adjourned at half past Two o’clock and that the House continue to sit past half past Two o’clock (The Minister for Infrastructure and Transport)

**15** LEAVE TO MAKE MOTION WITHOUT NOTICE. - *Ordered*, That the Premier have leave to make a Motion without Notice. (The Premier)

**16** THE LATE THE HONOURABLE JOHN MAXWELL BEATTIE: CONDOLENCE RESOLUTION. - *Resolved, nemine contradicente* - That this House expresses its deep regret at the death on 12 May 2020 of John Maxwell Beattie, a former Chairman of Committees of this House from 1982 to 1989, and Member for the Electorate of Franklin from 22 April 1972 until 13 May 1989, and further, that this House respectfully tenders to his family its sincere sympathy in their bereavement. (The Premier)

*Ordered*, That a copy of the foregoing Resolution be forwarded to the family of the late Mr Beattie. (The Premier)

**17** BILL NO. 21. - The Order of the Day being read for the Second reading of the Building and Construction (Regulatory Reform Amendments) Bill 2020.

And a Motion being made, and the Question being proposed - That the Bill be now read the Second time. (The Minister for State Growth)

A Debate arose thereupon.

**18** SUSPENSION OF SITTING. - At One o’clock the Speaker left the Chair.  
At half-past Two o’clock the Speaker resumed the Chair.

**19** BILL NO. 21. - And the Question being again proposed;

The House resumed the Debate.

And the Question being put;

It was resolved in the Affirmative.

And the Bill was, accordingly, read the Second time, and committed to a Committee of the whole House.

And the Speaker having left the Chair, the House resolved itself into the said Committee.

It passed in the Negative.

Clause 6, as read, further considered and agreed to.

Clauses 7 to 14 agreed to.

Title agreed to.

Bill to be reported without Amendment.

And the Bill was, accordingly, read the Third time.
