- **1 COUNCIL MEETS.** The Council met at 11.00 o'clock in the forenoon and the President read Prayers.
- 2 PAPERS.— The Clerk of the Council laid upon the Table the following Papers:—
 - (1) Report of the Integrity Commission: Report No. 3 of 2018 Report of an own-motion investigation into the management of information in Tasmania Police.
 - (2) Amendments to the 2017-18 Service Agreement between the Minister for Health and the Tasmanian Health Service.
 - (3) Department of Justice: Tasmanian Response Royal Commission into Institutional Responses to Child Sexual Abuse.
- 3 BUDGET PAPERS 2018-19 AND CONSOLIDATED FUND APPROPRIATION BILLS (NO.1 AND NO.2) 2018.— The Order of the Day was read for resuming the Debate on the Question, That the Budget Papers and the Consolidated Fund Appropriation Bills (No. 1 and No. 2) 2018 be noted.
