Notices of Motion

- 47 The Minister for Health to move—That the House:—
 - (1) Recognises 7 August 2024 is Aged Care Employee Day and that the 2024 theme is 'Thanks for caring'.
 - (2) Notes:—
 - (a) the importance of the thousands of aged care and community care staff who provide care and support to older and ageing Australians;
 - (b) that Aged Care Employee Day is celebrated every year on 7 August and has been hosted by the Attorney-General's colleagues at Aged & Community Care Providers Association (ACCPA) for the last 6 years;
 - (c) the Department of Health and the Tasmanian Health Service are committed to working closely with the aged care sector to improve care for older Tasmanians; and
 - (d) our Tasmanian Aged Care Collaborative is a cross-sector initiative to improve the interface between our health services and aged care services.
 - (3) Embraces that 7 August on Aged Care Employee Day, is a time for all of us to say loudly and proudly 'Thanks for caring' to our dedicated and compassionate aged care superheroes, who look after our older loved ones in residential care, home and community care, retirement living and seniors housing.
 - (4) Encourages all Tasmanians to:—
 - (a) recognise the incredibly important people who care for our older Tasmanians and Australians; and
 - (b) remember it only takes a moment to say 'Thanks for caring'. (7 August 2024)
- **48** The Minister for Health to move—That the House:—
 - (1) Acknowledges:—
 - (a) National Stroke Week serves as an essential reminder for all Tasmanians. Our State unfortunately has one of the highest incidences of stroke per capita in Australia; and
 - (b) the challenges stroke survivors face when returning home, especially those with cognitive disabilities, and emphasises the need for continued support and care.
 - (2) Recognises that a stroke can impact anyone at any age. In 2020, 24% of first-time stroke sufferers were aged 54 years and under.
 - (3) Supports National Stroke Week 2024, by the Stroke Foundation, aims to educate the community on recognizing the signs of stroke to save lives. The F.A.S.T. method is crucial: Face, Arms, Speech and Time.
 - (4) Emphasises that a stroke is always a medical emergency. Vigilance and swift action can save lives. If you see any of the signs, call 000 immediately.

- (5) Notes:
 - the Rockliff Government is committed to reducing the impact of strokes *(a)* through improved treatment, support, and recovery measures;
 - *(b)* the \$187 million upgrade to the Royal Hobart Hospital will include a new neurology and stroke ward, enhancing the existing Stroke Unit. This expansion provides Tasmanians with critical, time-sensitive medical care, particularly for acute strokes;
 - the statewide, 24/7 service staffed by dedicated specialists offers life-saving (c) treatment to stroke patients; and
 - the Victorian Stroke Telemedicine (VST) service, implemented at Mersey (d) Community Hospital and Launceston General Hospital, has benefited over 75 patients by providing rapid, accurate stroke assessment and treatment through instant virtual consultations with specialised neurologists. - 49 Ms Butler to move-That the House:---
 - (1)Notes the proposal to repurpose the Illawarra Road from Bishopsbourne Road to the Bass Highway from a rural access corridor to a National Highway.
 - (2) Further notes:
 - the proposed section hosts farm gateways every 300 metres with limited *(a)* ability to navigate oncoming fast moving freight trucks safely. The corridor is renown for the prevalence of sight obstructive fog; and
 - *(b)* landowners were not collaboratively consulted regarding the projects' negative impact on their farming activities, road access and agricultural industries along this length of Illawarra Road.
 - Acknowledges all recommendations made by landowners and significant (3)environmental, heritage and noise concerns were largely ignored by the Department of State Growth.
 - (4)Further notes:
 - the Department of State Growth rejected requests for the speed limit be *(a)* lowered to 80km/hr to improve safety on Illawarra Road by both the Northern Midlands and Meander Valley Councils and landowners;
 - (b) requests by landowners for livestock underpasses to enable continued movement of livestock across Illawarra Road were refused by the Department of State Growth; and
 - a rope wire barrier is not appropriate for the agricultural industries for which (c) the corridor is utilised with vehicle usage including the necessary carriage of slow-moving farm contracting machinery, including harvesters and tractors.
 - Calls on the Government to consider an 80km an hour speed limit to the section of (5) Illawarra Road from Bishopsbourne Road to the Bass Highway.
 - (6) Further calls on the Government to enter into a community focused, rigorous and collaborative consultation process with the landowners of Illawarra Road. (7 August 2024)
- 50 Ms Badger to move-That the House:-
 - Recognises:-(1)
 - (a) the importance of scientifically backed decision making; and
 - *(b)* the equitable need for all Members of Parliament to access expert advice from a range of specific scientific disciplines.
 - (2)Calls on the Government to establish in the next 12 months a statutory independent Tasmanian Science and Technology Advisory Committee (TSTC), which should:
 - be based on the National Science and Technology Council model; *(a)*
 - (b) comprise of seven independently appointed senior leaders in science, technology and engineering;
 - provide evidence-based advice to parliamentarians; (c)
 - be charged with providing independent, evidence-based advice to inform (d) decision-making on complex issues where science, technology and engineering have a major part to play; and
 - meet quarterly, with the Premier present for at least part of each meeting, with (e) the power to convene on an ad hoc basis as necessary or convenient. (8 August 2024)

51 The Minister for Veterans' Affairs to move—That the House:—

- (1) Recognises the significance of Vietnam Veterans Day, observed annually on 18 August 2024.
- (2) Notes:-
 - (a) this day is dedicated to honouring the courage, sacrifice, and dedication of the Australian men and women who served in the Vietnam War;
 - (b) the Vietnam War was a complex and challenging conflict, and our veterans endured extraordinary hardships and displayed remarkable bravery;
 - (c) over 60,000 Australian servicemen and women were deployed to Vietnam, contributing significantly to efforts to bring stability to the region;
 - (d) sadly, 521 Australians lost their lives, and over 3,000 were wounded;
 - (e) among these brave individuals were many Tasmanians, whose service and sacrifice we specifically honour and remember today;
 - (f) Vietnam Veterans Day serves as a remembrance of those who made the ultimate sacrifice
 - (g) it also recognizes the struggles faced by returning soldiers, many of whom endured physical and emotional scars;
 - (*h*) it is our duty to ensure our veterans, including those from Tasmania, receive the support and acknowledgment they deserve;
 - *(i)* significant progress has been made in recent years in providing services and support to our veterans; and
 - (*j*) however, continued efforts are necessary to address their needs, particularly in mental health, rehabilitation, and social reintegration.
- (3) Reflects on the sacrifices made by our Vietnam veterans.
- (4) Renews its commitment to supporting them and their families.
- (5) Ensures they receive the recognition they have rightfully earned. (8 August 2024)
