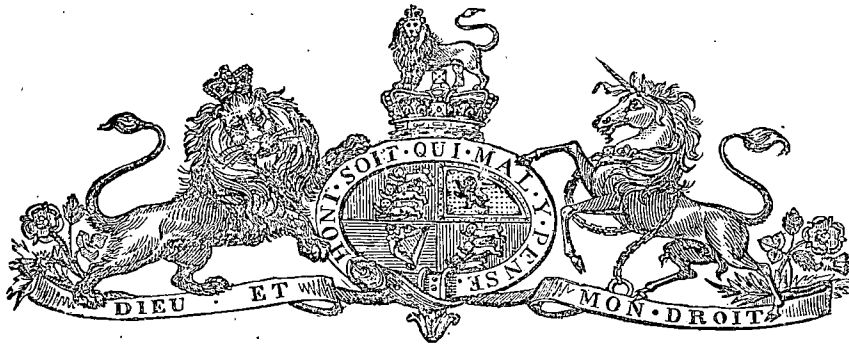

LONDON INTERNATIONAL EXHIBITION OF 1873.

(CIRCULAR.)

Downing-street, 11th March, 1873.

SIR,

I HAVE the honor to transmit to you two copies of the Papers mentioned in the margin*, which will explain to you the manner in which it is considered that it may be practicable, by united action on the part of the Colonies, to establish and maintain, at a very reasonable cost to each Colony, a permanent Exhibition of Colonial Products in connection with the Exhibition Building at South Kensington.

The proposed arrangements are so fully described in these Papers that I need not refer to them in detail, but with regard to the proportion of the aggregate space, and of the cost of construction and maintenance which has been assigned to each Colony, I have to observe that these particulars are necessarily subject to re-adjustment in the event of it being shown that the Colonial Revenue has been in any case incorrectly stated, or that any particular Colony, desiring to be admitted to the General Colonial Court, would require a larger or a smaller proportion of the space, in such a departure from the scale now proposed should be found convenient.

In order that the necessary works may be commenced during the summer of this year, it is most desirable that I should receive the earliest possible intimation from each Colony, as to its acceptance or otherwise of the proposal now communicated to you; and I request you to recommend it to the consideration of your responsible Advisers without delay, and inform me, as soon as practicable, whether they determine to ask the sanction of the Legislature for the necessary expenditure, and whether they concur in the details of the scheme now suggested, or would suggest any modifications.

It will probably be found convenient in fixing the contribution of each Colony to avoid fractions of a pound sterling.

It should be understood that in a permanent Exhibition of the nature now contemplated, it will be desirable that not only commercial products, but objects of interest of whatever kind, illustrating the Ethnology, Antiquities, Natural History, and Physical Character of the Country, should be included.

Her Majesty's Government will learn with much pleasure that this attempt to provide for the collective illustration on an adequate scale of the special characteristics of all the Colonies, has met with approval in the Colony under your Government; and I have to request that, in addition to communicating this Despatch with its enclosures to the Legislature, you will take such other steps as you may deem best calculated to give it general publicity.

I need perhaps hardly call attention to the fact that the expenditure of Colonial Funds on a permanent Exhibition, in regard of which the original outlay will be much reduced by combination, differs materially from expenditure on those temporary exhibitions, in which some Colonies have heretofore been represented at various places.

LONDON INTERNATIONAL EXHIBITION OF 1873.

REPORT of Sub-Committee on Colonial Court, 18th February, 1873.

I. THE Sub-Committee appointed at the Meeting held at the Victoria Office on Tuesday, the 23th January, 1873, report to the Committee that they have twice met for the purpose of carefully considering the construction and maintenance of a Colonial Court in connection with the current series of Annual International Exhibitions in London.

II. They recommend the Committee to ask Her Majesty's Commissioners for the Exhibition of 1851 to reserve, for a certain term of years, the Frontage and Space between the Belgian and French Annexes as a site for a Colonial Court, and to permit the ground between such site and the East Exhibition Galleries to be laid out as a Garden in connection with the Colonial Court—Her Majesty's Commissioners reserving to themselves all rights of access from Exhibition Road to the East Exhibition Galleries, and general supervision of the Police, Fire arrangements, and Door-keepers in the Colonial Court.

III. They consider that the first contribution, and the annual charge for maintenance, paid by each Colony should be in direct proportion to the space allotted to it in the Colonial Court; and that all arrangements connected with such allotments of space should be administered by a London Committee of Representatives of the Colonies, acting in connection with, and under the superintendence of, Her Majesty's Commissioners. They further suggest that the Annual Revenues of the Colonies would form a fair elementary basis of calculation as to proposals for first allotments of space; and they append a statement (Appendix E) showing the charges which, by this computation, would fall upon each Colony.

IV. The Sub-Committee have caused designs and approximate estimates to be prepared for purchasing the existing Belgian Annexe, and extending it to the French Annexe, so as to form a complete Colonial Court, containing, in addition to Office accommodation, an Exhibition area of about 15,000 superficial feet of floor space, and about 15,000 superficial feet of useful wall space. The cost of this work is estimated at £25,000, which sum includes the provision of a limited number of cases and fitments, the necessary heating, lighting, and water connections, external decoration of the wall facing Exhibition Road (according to Mr. REUBEN TOWNROE's designs), and laying out the Garden (*see* Appendix A herewith). They would observe that this sum provides for building Offices and a Reading-room, which (if provided with Colonial Newspapers, &c.) would form a convenient rendezvous at all times of the year for Colonists visiting London. For the £25,000 a floor space of about 15,624 square feet would be obtained, and 15,176 square feet of available wall space; thus allotting, for each £1,000 expended, a floor space of 625 square feet, and of wall space 607 square feet, *i. e.*, a length of $17\frac{1}{2}$ feet of the Court, which will be 36 feet wide.

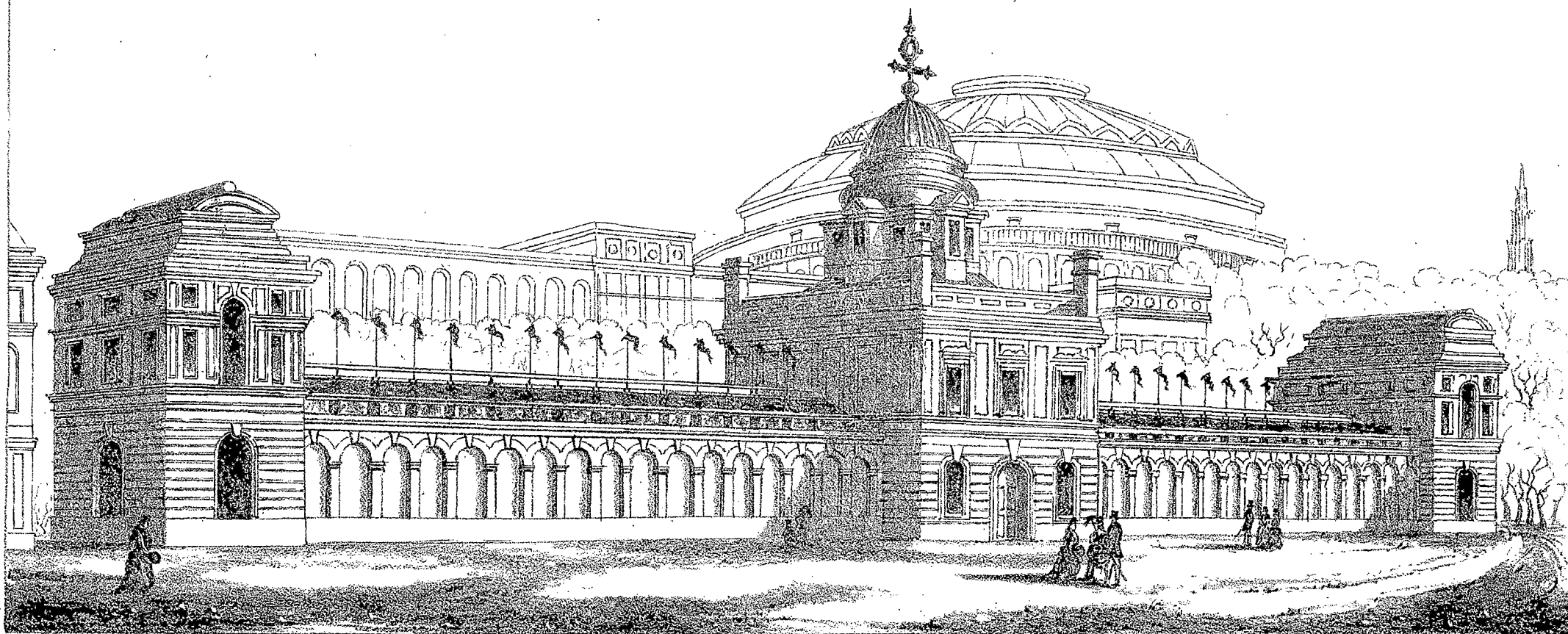
V. The annual cost of maintaining this general Colonial Court has been estimated at about £1300, according to Appendix B herewith.

VI. The outlay required for preparing and occupying the Belgian Annexe as a temporary Colonial Court during the Exhibition of 1873 has been estimated at about £2000 (*see* Appendix C herewith), it being assumed that Her Majesty's Commissioners lend the Building to the Colonies for the season free of charge. The Belgian Annexe is 171 feet 6 inches long, and 36 feet wide, containing a floor space of 6156 square feet, and an available wall space of 6500 square feet.

VII. The Sub-Committee recommend that, if their proposals be approved, a statement of the Scheme (accompanied by approximate Estimates) be at once prepared for the information of the Colonies, who should be requested to state severally the amounts which might be expected from them as contribution to the Capital Account and to the Annual Maintenance of the Building in the event of such Building being erected. They would also recommend that some detailed Drawings and Estimates be at once proceeded with (at the approximate cost of £100), without waiting for general approval of the project as a whole.

VIII. They finally report that, if the Colonies propose to occupy the Belgian Annexe as a separate Colonial Court in the London Exhibition of 1873 (which is to open in the middle of April next), authority should at once be obtained for the expenditure of the whole, or a part, of the £2000 estimated, according to Appendix C, as being necessary for that purpose.

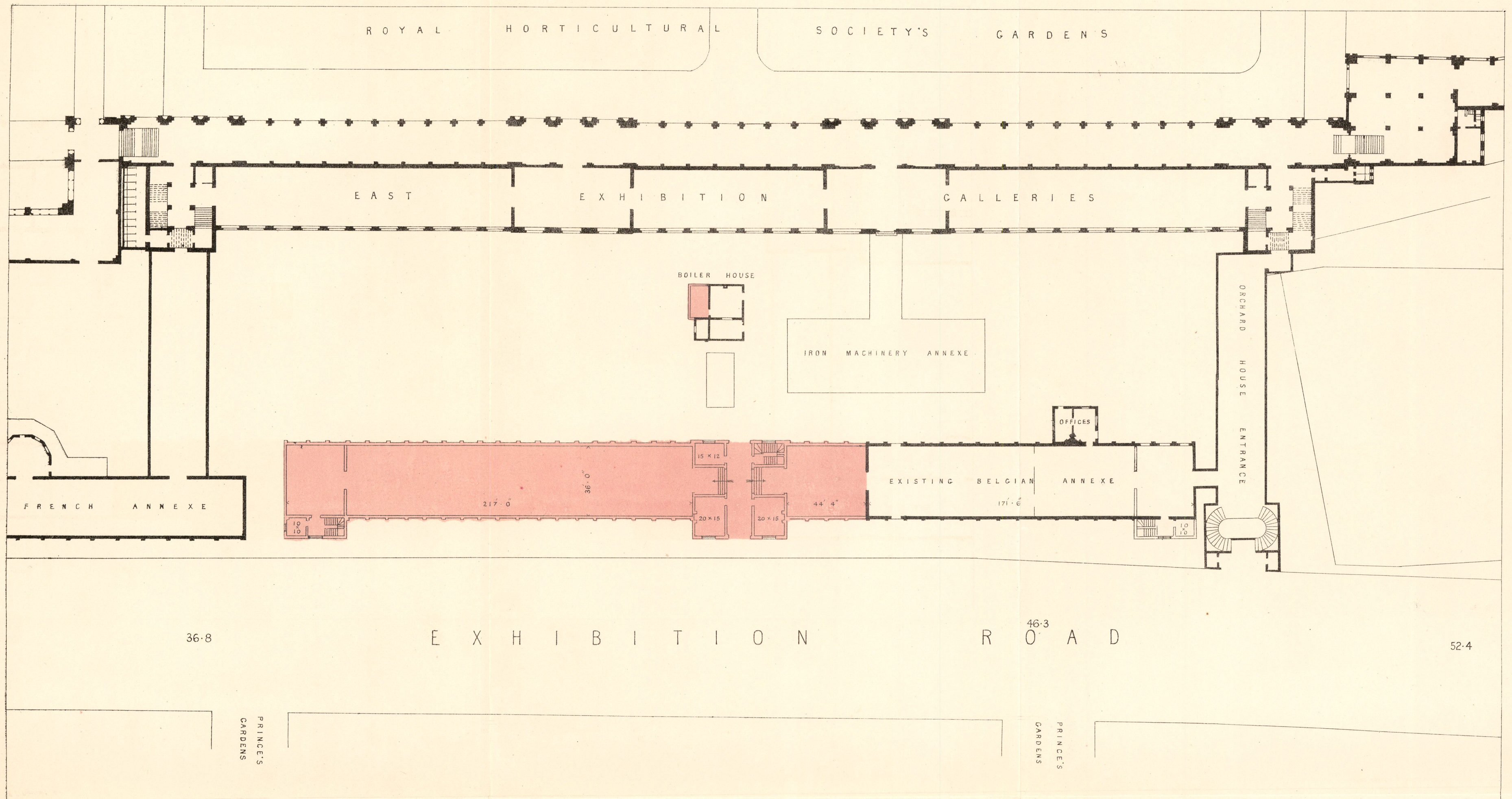

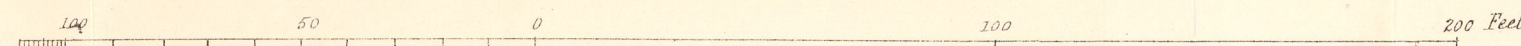
PROJECT OF COLONIAL COURT

LONDON INTERNATIONAL EXHIBITION OF 1873.

MINUTES of the First Conference concerning a Colonial Court in connection with the Annual International Exhibitions in London:

*Office of the Agent-General for Victoria,
8, Victoria Chambers, Westminster, S.W., 28th January, 1873.*

AN informal Conference is held for the purpose of considering the formation of a Colonial Court in connection with the Exhibition Building at South Kensington, at which there are present—

On the motion of Sir JAMES M'CULLOCH, Mr. CHILDERS takes the Chair.

Mr. CASHEL HOEY is appointed Secretary to the Conference.

MR. CHILDERS states the circumstances which have led to the meeting of the Conference; that the success of the Queensland Annexe of last year had induced the Governments of Victoria and South Australia to vote respectively £2000 and £1500 towards the establishment of a permanent Australian Annexe; that in the course of communication with the Exhibition Staff, the project of founding a general

Colonial Court instead had originated; that of this project the Canadian Government, through SIR JOHN ROSE, had promptly signified his approval, as also the Government of Victoria by telegram; that the Agents-General of the various Australasian Colonies had also adhered to it; that the Crown Agents for the Colonies had expressed their wish to aid it on the part of the Colonies represented by their Department; and that LORD KIMBERLEY had informed him that the project was regarded by him with favour, and would be supported by the Colonial Office. MR. CHILDERS further stated that, at this stage of the proceedings, he had brought the subject under the notice of His Royal Highness the PRINCE OF WALES, and that His Royal Highness was pleased to signify at once his warm approval, and to propose to bring the wishes of the Colonies concerned before the Commissioners of International Exhibitions; in consequence of which the Commissioners, adhering to the view that a Colonial Court might with advantage be added to the Building at South Kensington, had, pending the erection of a permanent edifice, offered for the purposes of this year's Exhibition the use of the Belgian Annexe to the Colonies prepared to exhibit; finally, that the present Conference is convened to consider the course proper to be pursued both with regard to preparations for this year's Exhibition, and to the erection of a permanent Colonial Court.

MR. CASHEL HOEY states that he has received a letter from SIR JOHN ROSE regretting his inability to attend, and expressing his concurrence in the objects of the Conference, and that he has also received a similar communication from DR. FEATHERSTON.

The letter of the Commissioners of International Exhibitions, offering the use of the Belgian Annexe for this year to such Colonies as are willing to combine for a permanent exhibition of Colonial objects, is considered; and it is agreed to advise that Colonial Exhibits belonging to the four Classes proper to this year's exhibition be displayed in connection with the exhibits of such four Classes coming from other Countries—reserving the Belgian Annexe, or such other special space as may be allotted by the Commissioners, for permanent and general Colonial Exhibits.

It is agreed that a Sub-Committee be appointed to report upon a plan of building arrangements with the Commissioners, and estimates of the expenditure, both for this year and in the event of the erection of a permanent Building, to consist of—

The Conference adjourn to Tuesday, the 11th of February, but is further adjourned, by desire of the Sub-Committee, to Tuesday, the 18th of February.
