

BOARD OF IMMIGRATION.

REPORT for the Year 1883.

Immigration Office, Hobart, 1st May, 1884.

SIR,

1. The Board of Immigration have the honor to forward their Annual Report for the year ended 31st December, 1883.
2. During the year 598 immigrants arrived under the "assisted passage" system, (including 227 children), being an increase of 457 persons as compared with the year 1882.
3. The number of "assisted passage certificates" issued by the Board during 1883 was 154, viz., 54 family, 54 single males, and 46 single females; 19 certificates were unused, viz., 7 family, 7 single males, and 5 single females.
4. The London Agents of the Board issued 203 "assisted passage certificates" during the year, viz., 83 family, 79 single males, and 41 single females.
5. The amount paid for "assisted passage certificates" was £1820, of which sum £114 was refunded on account of unused certificates.
6. "Land Certificates" under the 7th Section of the Act 31 Vict. No. 26 were granted to 94 individuals, entitling them to select 4630 acres of land.
7. These certificates represent 84 male and 48 female adults, and 106 children,—a total of 238 souls.
8. Forty-six "Land Orders," under the 5th Section of the same Act, were issued, the total nominal value of such Orders being £1422.
9. These "Land Orders" represent 67 adults and 26 children under 15 years of age.
10. The balance at the disposal of the Board on 31st December, 1883, amounted to £19,496 14s. 2d. There was a balance in the hands of the London Agents at same date amounting to £446 13s. The Board are liable for repayments on over-due Bounty Tickets (*vide* Returns Nos. 6 and 7,) to the amount of £1667.
11. It is believed that most of the immigrants who arrived during the year have obtained remunerative employment.
12. The number of persons arriving in the Colony who pay the full cost of their passages and claim "Land Orders," or "Land Certificates," is well maintained. Such persons are usually possessed of means and enterprise, and are likely to prove permanent colonists. The Return No. 8 shows that 3023 acres 2 roods of the Crown Lands were purchased by such persons in addition to the areas to which they were entitled under Land Orders and Certificates.
13. During the year the Brickfields Establishment was converted into an Immigration Dépôt, and is capable of affording comfortable accommodation for 130 immigrants.
14. In consequence of a variation in the classification of passengers on board some lines of steamers, a question has arisen as to the definition of the term "intermediate" in the 7th Section of the Immigration Act. The Board consider it desirable that the right to claim the privileges of the 7th Section should be governed by a minimum amount of passage money, rather than by a passenger classification which may vary in different vessels.

15. A difficulty has frequently arisen through persons who have paid the full cost of their passage having failed, in ignorance of the law, to obtain from the Agents in London the "Land Order Warrants" required by the 4th Section of the Act. Immigrants thus precluded from securing the advantages they anticipated when selecting Tasmania as their future homes, experience very bitter disappointment. The Board recommend this matter to the consideration of Government.

16. Difficulty has been experienced by the Agents in London in their efforts to meet the demand for "domestic servants," from the fact that the New Zealand Government supply female servants proceeding to that Colony with free passages and free sea-kits, whilst under Clause 3 of the Board's Regulations a charge of £3 is made for each single female.

17. Should it be thought desirable to make any alteration of the law in regard to these or other matters, the Board recommend the consolidation as well as the amendment of the existing Acts.

18. The usual Returns for the year 1883 are appended, five relating to the operations of the Board under the Acts of Parliament 31 Vict. No. 26, and 38 Vict. No. 16, and two showing the liabilities of the Government and the Board on overdue "Bounty Tickets."

19. A statement is also appended showing the acreage selected and purchased by the holders of "Land Certificates" and "Land Orders" during the year 1883.
