



# JAMES MADDEN'S CLAIM FOR COMPENSATION:

REPORT FROM THE SELECT COMMITTEE, WITH MINUTES OF THE PROCEEDINGS.

Brought up by Mr. Braddon, and ordered by the House of Assembly to be printed, November 23, 1886.

# REPORT.

YOUR Committee have met twice, and obtained by written questions the evidence of nine witnesses.

From the replies given to questions, it is conclusively shown that James Madden met with an accident in 1881, while driving on the Mersey bridge approach; that this accident would probably not have occurred if that approach had been properly fenced, and that the consequence of that accident has been to render Madden a helpless and bedridden invalid beyond hope of recovery. It is further shown that Madden has been for years known as a man of temperate habits and good character, who most unwillingly comes before Parliament with an application for help.

At the time of the accident the Mersey Bridge and approaches were in the hands of the Main Road Board; the Main Road Board were at the time the agents of the Government, and when the road was taken over the Government took it with all liabilities. Having these points in view, and considering all the circumstances of the case, your Committee are of opinion that Madden has a claim for compensation, which Parliament might fairly take into its indulgent consideration.

## MINUTES OF PROCEEDINGS.

### THURSDAY, NOVEMBER 4, 1886.

Resolved, That Mr. W. Smith, Chief Clerk of the Public Works Department, be requested to give evidence before the Committee at once.

Mr. Smith forwarded his evidence in writing.

The Draft Report was drawn up, considered, and adopted.
