

RETIREMENT OF MR. FORSTER, AND THE APPOINTMENT OF MR. SWAN.

## EXECUTIVE COUNCIL MINUTE, 9TH JUNE, 1862.

Colonial Secretary's Office, 1st August, 1862.

THE Governor in Council has been pleased to approve of the adoption of the following scale under the 5th Section of "The Superannuation Act, 1860:"—

To those persons who shall have served ten years and under sixteen years there may be added five years, with an additional year for every succeeding year of actual service, until twenty years service is reached, after which no additional period can be granted.

With respect to those persons who shall have served five years and under ten, there may be given as compensation one month's pay for each year of service, with the addition of three months' pay; and to persons who shall have served under five years, one month's pay for each year of service, with the addition of one month's pay.

In every case the applicant must produce a certificate from the Head of his Department that he has discharged his duties with diligence and fidelity.

MINUTE No. 396.

THE Colonial Secretary submits the following Minute:—"That John Forster, Esquire, having expressed his desire to be allowed to relinquish his appointments as Sheriff and Inspector of Police, his request be acceded to; and that, in consideration of his long and faithful services to the Government, he be granted a Pension at the rate of £400 per annum, from the 1st January, 1875. To be provided for upon a Supplementary Estimate."

Sir,

I Have the honor to acknowledge through the Honorable the Colonial Treasurer the receipt of your Memo of the 31st December, 1874, intimating that the Administrator of the Government in Council had been pleased to approve of a Retiring Allowance being granted to John Forster, Esquire, Inspector of Police, at the rate of Four hundred pounds per annum, to take effect from the 1st instant.

It has hitherto been the rule in all cases of granting Retiring Allowances to forward the pension papers to this Office for examination before submitting the case for the approval of the Governor in Council, but in the above no papers have been received.

Will you therefore be so good as to inform me why the rule has been departed from?
