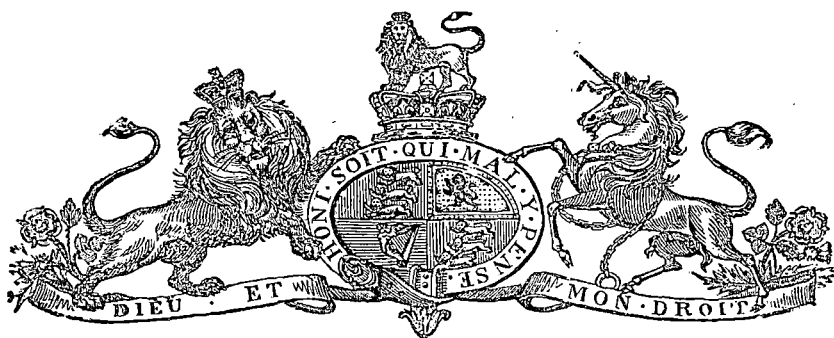

To the Honorable the House of Assembly, in Parliament assembled.

The humble Petition of the undersigned Persons in the Civil Service of the Government of Tasmania.

SHOWETH :

THAT your Petitioners have learned, with regret, that it is proposed to abrogate the system of Classification which at present regulates the remuneration to the Subordinate Officers of the Government.

That the existing system of Classification was approved of by the Governor in Council in the year 1856, and subsequently ratified by Parliament.

That your Petitioners look upon the system of Classification thus sanctioned as forming a compact between the Crown and themselves, on the faith of which many of them have entered into engagements which they would not have contracted had they supposed that the system was liable to be affected by fluctuations in the Revenue.

That, in the proposed scheme, individual cases of great hardship and many anomalies occur.

Your Petitioners therefore humbly pray that the subject matter of this Petition may receive the earnest consideration of your Honorable House.

And your Petitioners will ever pray.
