### Notices of Question

- **69** Ms *Butler* to ask the Minister for Health With respect to non-urgent/emergency patient passenger transport:
  - (1) Has Ambulance Tasmania undertaken non-urgent emergency patient passenger transports in the financial year 2017/2018 and from July 2018 to current? If so, how many?
  - (2) Has a private contractor undertaken non-urgent emergency patient passenger transports in the financial year 2017/2018 and from July 2018 to current? If so, how many and what were the costs? (2 May 2019)
- 70 Ms *Butler* to ask the Minister for Health With respect to non-urgent/emergency patient passenger transport in regional centres:
  - (1) Has Ambulance Tasmania undertaken non-urgent emergency patient passenger transports in regional centres during the financial year 2017/2018 and from July 2018 to current? If so, how many?

- 73 Ms *O'Connor* to ask the Minister for Housing With respect to the Office of the Residential Tenancy Commission, in relation to the period 1 July 2016 to 1 July 2019:-
  - (*a*) were any applications lodged under section 23(1) of the *Residential Tenancy Act 1997*, and if so, how many?
  - (b) were any such applications determined by the Commissioner in favour of:-
    - (i) the tenant, and if so, how many; and
    - (ii) the landlord, and if so, how many?
  - (c) were any applications determined by the Commissioner in favour of the tenant referred to a Court under section 23(5) of the *Residential Tenancy Act 1997* and if so, how many?
  - (d) in respect of any such cases referred to in paragraph (c), were any resolved by the Courts in favour of:-

- (i) the tenant, and if so, how many; and
- (i) the landlord, and if so, how many?
- (e) were any applications determined by the Commissioner in favour of the landlord referred to a Court under section 23(5) of the *Residential Tenancy Act 1997*, and if so, how many?
- (f) in respect of any such cases referred to in paragraph (e), were any resolved by the Courts in favour of:-
  - (i) the tenant, and if so, how many; and
  - (ii) the landlord, and if so, how many? (7 August 2019)
- 74 Ms O'Connor to ask the Minister for Environment, Parks and Heritage With respect to National Parks:
  (1) During the 2017/18 financial year, were any National Park issued, and if so, how many were issued:-
  - (i) in total;
  - (ii) as day passes;
  - (iii) as annual passes; and
  - (iv) as concession passes?
  - (2) Are there any commercial leases in National Parks, and if so:
    - (i) how many (broken down by lease duration);
      - (ii) are the leases subject to automatic renewal or is there a competitive tender;
      - (iii) what was the total income received from commercial leases in national parks during the 2017/18 financial year? (15 October 2019)
