

THAT your Petitioners are interested in the growing of Fruit, and that their industry is threatened with very serious losses through the ravages of an insect commonly known as the Codlin Moth.

That experience in this Colony and in other parts of the world has proved that if preventive measures are taken the evil effects of the moth may be very considerably modified, if not entirely obviated, but that without legislative enactment it is impossible to secure such a general enforcement of preventive measures as will alone tend to make them in any degree successful.

Your Petitioners therefore humbly pray your Honorable House to pass the Codlin Moth Bill now before Parliament.

## To the Honorable the President and Honorable Members of the Legislative Council, in Parliament assembled.

The humble Petition of the Fruit-growers of Geeves Town and vicinity,

**RESPECTFULLY SHOWETH:** 

THAT your Petitioners have had under their consideration, in public meeting, the Codlin Moth Bill now before your Honorable House.

That they consider those clauses of the Bill unnecessary which provide for dealing with the Codlin Moth in unclean districts; but that they think it very desirable, in order to prevent the spread of the pest into districts now free from it, that so much of the Bill as provides protection against infection to clean districts should be passed into law.

That your Petitioners empowered Mr. Osborne Geeves, who was Chairman of the meeting above referred to, to sign a Petition to your Honorable House embodying their views.

Your Petitioners therefore pray that your Honorable House will be pleased to give effect to their wishes in passing so much of the Codlin Moth Bill as is necessary to give to clean districts the protection which Section 14 of the said Bill will afford.

THAT your Petitioners have observed with regret that the House of Assembly has again passed a Bill professedly for the destruction of the Codlin Moth, notwithstanding that a similar measure has several times been rejected by your Honorable House.

2. That your Petitioners are still of opinion that no legislation on this subject is necessary, and that the destruction of all the apple and pear trees in the Colony would not necessarily destroy the Codlin Moth, which exists and can exist in other trees, and live upon other fruit, than apples or pears, as has already been shown in evidence taken before a Select Committee of the House of Assembly.

3. Your Petitioners would therefore humbly pray that your Honorable Council will not pass the said measure until it can be shown that it will effect the object proposed; your Petitioners being firmly of opinion that no legislation is necessary or can be effectual in destroying the so-called Codlin Moth or any other pest to which fruit-growing or any other industry is liable.

The humble Petition of the undersigned Fruit-growers of the Electoral District of Glenorchy,

OBSERVE with regret that a Bill has been passed by the House of Assembly, entitled "The Codlin Moth Bill." We, your Petitioners, are of opinion that legislation in the matter is unnecessary, and in opposition to the wishes of the majority of the fruit-growers in the District. That fruit-growers are already alive to the importance, and are exerting themselves to get rid of the pest wherever it has made its appearance. That the appointment of Inspectors is not needed, and will not assist the object sought.
