

# PARLIAMENT OF TASMANIA.

# ORDERS IN COUNCIL UNDER SUPERANNUATION ACT.

Laid before both Houses of Parliament, in accordance with the Superannuation Act.



ORDERS under "The Superannuation Act" made by the Governor in Council since the Meeting of Parliament in the year 1888.

## MONDAY, JUNE 25, 1888.

#### MINUTE No. 303.

THE Governor approves of the following Recommendations submitted by the Attorney-General :---.

1. That H. T. A. Murray, Esq., Police Magistrate at Launceston, have leave of absence on full pay to the 31st December next, and that he then retire from the Public Service, in order to effect a reorganisation of the Department by combining other offices with the office of Police Magistrate; and that under these circumstances Mr. Murray's pension be calculated under the 5th Section of "The Superannuation Act" as upon 40 years' service.

#### TUESDAY, OCTOBER 16, 1888.

#### MINUTE No. 471.

The Governor grants a Retiring Allowance at the rate of £54 17s. 11d. to Mr. Robert Leitch, Constable, Territorial Police.

To commence on 1st November next, and to be provided for by Supplementary Estimate.
