

REAL PROPERTY LAW.

REPORT FROM THE RECORDER OF TITLES, AND RETURNS.

Presented by Mr. Attorney-General, and ordered by the House to be printed, 2 September, 1863.



Lands' Titles Office, 31st August, 1863.

I HAVE the honor to transmit to you, herewith, a Return showing in detail the nature and extent of the various transactions under "The Real Property Act," during the first twelve months of its operation.

When it is remembered that the system was entirely new both to landholders and capitalists, and that it had to encounter the strenuous opposition of the majority of the legal profession, and that the depressed state of the Colony during the past year has had the effect of limiting transactions in real property, I think I am fully justified in viewing the progress of the Department as eminently satisfactory.

In every district, from the Huon to George Town, we have now property under the operation of the Act; in every quarter of the Island the system has fairly taken root; the safety, the simplicity, and the cheapness of it begin to be better known and understood, the adoption of it has become more general, and I have not the smallest doubt that, in spite of all opposition, it will gradually but surely supersede the old mode of conveyancing.

It is gratifying to me to be able to speak of the gentlemen appointed to assist me in working the Department with unqualified praise; the Commissioners have afforded me a cordial co-operation of the most valuable kind. To the facilities afforded to the public by the courtesy and indefatigable industry of the Deputy-Recorder at Launceston must, in justice, be mainly ascribed the success of the Act on the North side of the Island; whilst both the Solicitor and Draftsman have performed their respective duties with skill, diligence, and a hearty zeal for the promotion of the interests of the system which have left me nothing to desire. As a satisfactory proof, indeed, of the care which has been bestowed upon the work passing through the Office, I am glad to be able to inform you, that although upwards of 250 properties, valued at £150,000, have been involved in the transactions we have effected, no claim has been made upon the Assurance Fund, nor have we been called upon to defend any of our decisions in the Supreme Court. But although our work has hitherto been performed with safety, it has not, I am bound to confess, been executed with the rapidity which I could have desired.

The financial embarrassments of the Colony unfortunately prevented the Department, in spite of my remonstrances, from being placed upon the footing which Mr. Torrens advised; and, until very lately, the staff of the Office has been limited to one clerk and draftsman. The natural consequences have not failed to show themselves. As applications increased the work gradually accumulated until it fell seriously into arrears,—that celerity of action which (when compared with the interminable delays of the old law) was one of the most attractive recommendations of the new system was compromised, and no little disappointment and dissatisfaction was occasioned to many of the applicants.

I am happy, however, to say that this condition of things has now been remedied: with the aid of a temporary draftsman, and by working after hours, the arrears have been discharged; and a second efficient draftsman having been attached permanently to the Department, I trust that for some time, at least, we may be able to avoid further delays. I feel bound, nevertheless, to record my conviction, that the business of the Department will necessitate a still further increase of staff before the expiration of the coming year.

In a financial point of view, the progress of the Act has also been encouraging. The fees received have gone on steadily increasing in amount until they now supply about one-third of the total cost of the Department; a result which must be regarded as highly satisfactory, when it is borne in mind that the work we have been hitherto doing has of necessity been more a preparation for future transactions than actual dealings with land.

Sir,

The quantity of Real Property, however, which has now been brought under the Act, all dealings in regard to which must be effected through this Office, has laid a wide foundation for future operations, and affords us an assurance that the Registration Fees cannot fail materially to increase. Although, therefore, fluctuations must of course be looked for, there is every reason to hope that, at no very distant period, the Department may be self-supporting.

In conclusion, I am enabled to say with perfect truth that, upon the whole, the Act has worked with a facility and smoothness which leave little to desire: certain amendments in regard to the subject of Dower and other minor points might be, perhaps, desirable, but no serious obstacle has presented itself; and the result of twelve months' experience of the operation of the Act in this Colony is such as to entitle it to the character which it has received from one of the most eminent of living lawyers, Sir Hugh Cairns; viz.,—that of being a safe, simple, and expeditious mode of transferring Real Property.*
