can the Government provide the requested FTE information for the following occupations:

 - (gb) Diversion Officers.
- (h) Department of Natural Resources and Environment Tasmania

"MR PRESIDENT,

The House of Assembly having agreed to the following Resolution, begs now to transmit the same to the Legislative Council, and to request its concurrence therein—

That the

House of Assembly:

- (1) Notes:
 - (a) The Motion for Respect: Report into Workplace Culture in the Tasmanian Ministerial and Parliamentary Services report released on Monday 29 August 2022; and
 - (b) That the Report provides 14 recommendations to improve workplace culture and processes, and ensure a shared responsibility for the varied workplaces covered by the Report;
- (2) Acknowledges:
 - (a) Those who shared their experiences and apologises for the hurt and harm caused to them;
 - (b) The need to improve workplace culture and processes in the workplaces covered by the Report;
 - (c) That Tasmanians expect Members of Parliament and their offices to set the highest standards in workplace culture and accountability:
 - (d) That staff employed in the workplaces covered by the Report are hard-working, dedicated and valued by Members of Parliament;
 - (e) That the Report addresses a number of individual workplaces with respective needs and employment conditions; and
 - (f) That each workplace must retain its individual rights to employ and manage staff, in line with best practice workplace policies, processes and procedures.
- (3) Resolves
 - (a) That Members and staff employed in the workplaces covered by the Report have a right to a safe and inclusive work environment free from discrimination, bullying and sexual harassment; and
 - (b) That best practice workplace policies, processes and procedures enable safe and respectful workplaces and contribute towards positive culture.
- (4) Supports:
 - (a) The development and sharing of policies, procedures and frameworks, and relevant codes of conduct, that would ensure consistency across the workplaces covered in the Report; and
 - (b) The provision of ongoing professional development and training to deliver a culture of continuous improvement.
- (5) Commits to:
 - (a) Ensuring oversight and accountability for the implementation of the recommendations accepted by the relevant employer.

- 1 Ms Rattray to move That Statutory Rules 2021, No. 93, Nature Conservation (Wildlife) Regulations dated 22 November 2021 made under the Nature Conservation Act 2002 and laid upon the Table of the Council on 4 May 2022, be disallowed as provided by Section 47 of the Acts Interpretation Act 1931.
- 2 Ms Webb to move That a draft proclamation made under Section 11(2) of the Nature Conservation Act 2002, dated 26 May 2022 and laid upon the Table of the Council on 2 June 2022 and which draft proclamation declares areas of Crown land specified in Parts 1 to 10 of Schedule 1 to the draft proclamation to be reserved land, be disallowed in accordance with the provisions of s.18(3) of the Nature Conservation Act 2002.
- 3 Ms Webb to move That a draft proclamation made under Section 11(2) of the Nature Conservation Act 2002, dated 18 May 2022 and laid upon the Table of the Council on 2 June 2022 and which draft proclamation declares area of Crown land specified in Parts 1 to 11 of Schedule 1 to the draft proclamation to be reserved land, be disallowed in accordance with the provisions of s.18(3) of the Nature Conservation Act 2002.
- 4 Ms *Armitage* to move That the report of the Auditor-General No. 7 of 2021-22, COVID-19 Response to social impacts: mental health and digital inclusion, be considered and noted.
- 5 Ms *Howlett* to move That the Legislative Council —
- (1) Notes the importance that Neighbourhood Houses play in the economic, social and mental wellbeing of Tasmanians;
- (2) acknowledges the significant role volunteers play within Neighbourhood Houses;
- (3) thanks those that work and volunteer at Neighbourhood Houses for the critical role they play in the wellbeing of the community; and
- (4) commends the Rockliff Liberal Government's recent investment of an additional \$1.75 million, equating to an additional \$50,000 for each of Tasmania's 35 Neighbourhood Houses, to allow Neighbourhood Houses to do more to support those in the community.
- 6 Ms Webb to move That the Legislative Council —
- (1) Notes the recent review of the Tasmania Law Reform Institute (TLRI) undertaken by an independent Review Panel, and the *Review of the Tasmania Law Reform Institute Final Report June* 2022, released on 20 July 2022;
- (2) welcomes the findings of the independent review, in particular:
 - (a) its observation that all submissions "strongly supported preserving the Tasmania Law Reform Institute (TLRI) given its current positive impact on the broader Tasmanian community"; and
 - (b) the Report's emphasis on the important contribution made by the TLRI to public policy debate in Tasmania;
- (3) notes the 20 recommendations made to the TLRI Founding Partners in the review's Final Report;
- (4) further notes the review Final Report's clear assessment of the urgent need to place the TLRI on a sustainable footing, as the current lack of financial and staffing resources has resulted in work on four references ceasing, "as has all other work such as engaging with law reform bodies in other jurisdictions, contributing to inquiries, commenting on draft legislation and engaging students in law reform projects";

- (5) acknowledges the high regard in which the TLRI is held across the community, fostered by the Institute's recognised independence, impartiality and institutional integrity, and the need to maintain that current strong public confidence;
- (6) notes the current TLRI Founding Partners' agreement is due for renewal in November 2022; and
- (7) urges the Tasmanian government to:
 - (a) prioritise delivering in full, and in good faith, the recommendations of the *Review of the TLRI Final Report* for which government holds entire or partial responsibility, and encourage its fellow Founding Partners, the University of Tasmania and the Law Society of Tasmania to do likewise: and
 - (b) commit to ensuring Tasmania's acclaimed premier law reform agency is sufficiently resourced to place it on a "secure and sustainable footing into the future" as recommended by the 2022 independent Panel's Review of the Tasmania Law Reform Institute Final Report.
