**4 ADJOURNMENT: MATTER OF PUBLIC IMPORTANCE.**— Ms *Forrest* proposed to move, That the Council does now adjourn for the purpose of discussing a Matter of Public Importance; namely, the circumstances surrounding the recent damage to the Cam River Bridge at Somerset and the resulting major delays to travel as a result of the reduction to one lane of traffic, the concerns around the integrity of the bridge and the need for a reliable alternative route.
