I have enclosed a document called the Economic Appraisal for Wood Smoke Control Measures, final report 2011.

The enclosed document states that wood smoke, if allowed to continue in NSW will cost the NSW State Government

8-9 BILLION, \$\$\$ by 2030.

Unlike other States within Australia Tasmania has approx 7-9 months of Wood Heater use. This is not only a problem

for Launceston, but every town in Tasmania from Devonport to Dover.

Tasmania has the highest rate of wood heaters in Australia. It should be OUR State Government that is commissioning

a report into Wood Smoke, but now we have this report let's not waste time in doing another one!

Some important facts regarding Wood Smoke& Health:

- 1. Studies have shown passive Wood Smoking is more toxic than passive Cigarette smoking.
- 2. Wood Smoke contains Benzene, Carbon Dioxide, Carbon Monoxide, Nitrogen Oxides, Formaldehyde & VOC's, just to name a few of the toxins.
- 3. Studies have shown , that 70 % of wood smoke re enters buildings , either your own home or a close neighbour.
