Subject: Service vessel intrusion at Dennes Point/Tinderbox/North West Bay

#### Background:

I am a resident of Dennes Point North Bruny. I have owned a shack at Dennes Point since 2004 and have been a full-time resident since 2011.

For your information I have included a satelite map showing the area concerned (see Attachment 01). Two fish farm operators (Huon & Tassal) have home bases in North West Bay.

### **Impacts: Noise**

My neighbours and I are repeatedly being impacted by the noise from marine fish farm service vessel movements transiting between the D'Entrecasteaux Channel, North West and Storm Bays.

The noise (a low drone or deep throbbing) can be heard during quiet periods of music and during the muted ads on the television, even with the windows and doors closed. It penetrates habitable rooms and disturbs sleep.

The opening between the Channel and Storm Bay is 1.6kms narrow. Vessels are therefore in close proximity to residential houses at Dennes Point and Tinderbox. Vessels are often within 300m of the shoreline.

For your information I have attached a list of some intrusive incidents dating from mid-2017 (see Attachment 2). Many incidents occur at anti-social hours between 6pm and 7am.

### **Impacts: Frequency**

Huon operates 40+ vessels (my guesstimate) throughout the Channel. Tassal and Petuna would have similar fleets of vessels. There is an ever growing number of very large industrial scale machines servicing fish farm operations in South-east Tasmanian waters (and especially in the Channel). These machines are operating 24 hours a day 365 days of the year.

For example every morning I (and my neighbours) are subjected to multiple services vessels proceeding from North West Bay out to Storm Bay. These services vessels are operating from 6am every morning and the noise is intrusive.

### **Impacts: Fish Pen towing**

Some of the more intrusive episodes involve fish pen towing. This means a a low drone/robbing noise intrusion which lasts upwards of 4 hours as the vessel and pen crawls passed my home at 0.2 knot per hour. Fish pen towing is happening at all hours of the day and night! See Attachment 02 for times and dates.

### **Impacts: Vessel size**

With the unrestricted expansion of fish farming in South East Tasmania and its concentration around the Channel and Storm Bay the number and size of industrial marine vessels is having an impact on the environment. These impacts include backwash from high speeds causing danger to smaller boats and shoreline erosion, bright lights at night, negative visual impact of Fortress Pens, vessel noise and congestion aound the narrow (1.6km) opening at Dennes Point .

The biggest vessel coming into operation is over 116 metres long. These large vessels are incompatible with the mixture of other commercial and recreational vessels (kayaks, jetskis, tinnies, yachts, motor boats, fishing trawlers, etc) which also frequent the area.

See Attachment 03 for details of some of the larger vessels operating in the area.

### **Summary**

I and my neighbours are forced to live with noise intrusion from fish farm expansion and industrialization of the waterways of South East Tasmania. This industrialization is magnified in the restricted confines of the Channel compared to the open ocean. The Channel is a sheltered area of scenic beauty, of oyster beds and recreational boating and fishing activity as well as commercial operators.

Francis Bender (CEO Huon Acquculture) told me she "... is a farmer so you must expect noise". Marine farming service vessels are, by far, the dominate commercial activity in the Channel. In the area of Dennes Point this domination has only been the case since mid-2017. And the "farming" is taking place in Storm Bay not at Dennes Point.

Pene Snashall (Community Relations Manager Huon Acquculture) tells me ".. all our vessels comply with government regulations and noise controls" but we are still subjected to intrusive throbbing diesel noise pentrating habitable rooms at all hours of the day and night!

I understand the need for jobs and that the waterways are a public resource.

What I can't understand is why the noise and environmental impacts have to impact myself and my neighbours at all hours of the day and night just so a few Tasmainians have jobs and an even fewer Tasmanians can grow bigger (wealthier) on the backs of myself and my neighbours.

#### **Inquiry outcomes**


- 1. Improved Policy and Procedures to reduce or eliminate noise impacts on neighbours when transiting past residential neighbourhoods.
- 2. Restrictions on vessels operating during anti-social hours (6pm 7am). Currently there is an open slather policy ie no restrictions at all.
- 3. Fish pen towing limited to 7am 6pm
- 4. **Immediate modification of all diesel engines** such that noise intrusion does not exceed natural background noise levels (eg: Huons' vessel Brazillian).


