Thank you for your letter of 23 September 2024 in relation to my appearance before Estimates Committee B. Please find below additional information as requested by the Committee:

Division 5 – DEPARTMENT OF HEALTH Overview

1. How many patients are currently waiting to start haemodialysis in the north and north west and whether there is forecast numbers for dialysis in patients in the next 5 or 10 years. Also, a breakdown of the \$600,000 which included engineering works, could further detail be provided? (RA)

Response:

I can advise that Haemodialysis is not managed via a waiting list. Patients are scheduled to receive this service when it is medically necessary. At the time of preparing this response, there were 10 patients requiring dialysis who were yet to commence their treatment, but these will be scheduled shortly.

It is projected that the number of public hospital renal dialysis admissions across the North and NW of Tasmania will increase by an average annual growth rate of 0.8 per cent until 2031/32.

As at 25 September 2024, \$541 921 has been spent on professional fees, planning and scoping phases which includes architects, site assessments / investigations (engineering), building condition reports, functional design briefs and concept design development.

2. Current LGH SMO positions advertised and provide number of applications received for positions? (RA)

Response:

At LGH there are eight specialist medical officer roles currently either advertised or with an active selection process underway. The positions are:

- Anatomical Pathology 8 applications
- Colorectal Surgery 7 applications
- Gastroenterology 8 applications
- General Medicine/Acute Care 13 applications
- Immunology none as at 30 September 2024
- Obstetrics and Gynaecology 7 applications
- Respiratory Medicine 12 applications
- Urology 9 applications

Response:

- a) There are three headcount ENT practitioners engaged as specialists at the Royal Hobart Hospital (RHH), working a total of 2.14 FTE with .48 FTE currently vacant.
 - The LGH has a total of three headcount staff contracted to work 2.22 FTE. One of those staff members has not yet commenced but is due to start next month.
- b) At the RHH there are a total of 5.48 FTE of working Gastroenterologist specialists with 2.1 FTE of vacancy.
 - At the LGH, there are a total of five Gastroenterologists working a total of 2.26 FTE. There is a total of 1.68 vacant, with recruitment currently underway.

- c) There are 38.1 FTE of Psychiatrists engaged across the range of services run by the Statewide and Mental Health Services. Current advertising is underway to fill 4.4 FTE ongoing vacancies.
- d) In Urology there are three staff currently working at the RHH contracted to work 1.05 FTE. A further three new specialists have been engaged but not yet commenced, which will bring the total complement to 2.65 FTE.

At LGH there are no vacancies, and a total of 6 specialists working 2.92 FTE. The current advertising is based on pending retirements for 2025.

- e) There is one Paediatric Endocrinologist engaged at the RHH (1 FTE), engaged as a General Paediatrician, this Paediatrician provides specific Endocrine clinics.
- f) There are 11 Neurologists working at the RHH, a total of 6.21 FTE.

There are five Neurologists currently working 2 FTE at the LGH.

Response:

With regard to the diabetes paediatric clinic at LGH, there are fewer than five patients on the waiting list. Further information cannot be provided, given the small numbers, as individuals may be inadvertently identifiable. For the ENT paediatric clinic at the RHH, there were 772 patients on the waiting list, comprising 74 category 1 patients, 620 category 2 patients and 78 category 3 patients.

Information for the other categories is provided below by hospital and the speciality of the treating clinician. Data is provided as at July 2024.
