

SIR,

I HAVE the honor to forward herewith the Annual Returns of the Gaols at Hobart and Launceston.

The number of prisoners in custody, and their distribution on 31st December last, compared with the same day of the previous year, is shown in the following tabulated Return :—

being a decrease of 1 male and 5 females in Hobart, and 3 males in Launceston, and a total decrease of 4 males and 5 females as compared with 1890.

The total number received and discharged during 1891 was—

As compared with the previous year, there is an increase of both receipts and discharges ; the increase being—receipts, 198 men at Hobart and 13 at Launceston ; and in discharges, of 213 men at Hobart.

Since my last Report further improvements have been effected in the Gaol at Hobart. The shoemakers' and tailors' shops have been transferred to the general workshops, where, under one roof, all the trades followed in the Establishment are carried on under more perfect and economical supervision than heretofore.

The appliances for washing and drying being very imperfect, the yard formerly used as workshops has been utilised for that purpose, and by the aid of a small steam-engine the washing of the Department is more perfectly performed ; and steam-power is used for the wringing machine, the cutting of firewood, &c.

Quite recently a new industry has been started by the introduction of looms for mat-making, which has been the means of employing a number of men physically weak, who would otherwise of necessity be idle. The mats already produced have given the greatest satisfaction ; and this branch of work is likely to be of a profitable character. Mat-making is an industry extensively carried on in the larger prisons of Victoria and New South Wales.

The cleanliness and good order of the Gaols reflect credit upon the Superintendents.
