## **A BILL FOR**

**An Act for the appropriation of \$82 050 000 out of the  
Public Account for the services of the Government for the  
financial year ending on 30 June 2024**

Be it enacted by Her Excellency the Governor of Tasmania, by  
and with the advice and consent of the Legislative Council and  
House of Assembly, in Parliament assembled, as follows:

### **1. Short title**

This Act may be cited as the *Appropriation  
(Further Supplementary Appropriation for  
2023-24) Act 2024*.

### **2. Commencement**

This Act is taken to have commenced on  
1 July 2023.

**3. Interpretation**

For the purposes of this Act –

*Capital Services* means –

- (a) public works or property required for public purposes; or
- (b) a loan authorised by law;

*Operating Services* means the ordinary annual services of the Government.

**4. Issue, application and appropriation of \$82 050 000**

- (1) In respect of the financial year ending on 30 June 2024, the Treasurer may –
  - (a) issue the sum of \$82 050 000 out of the Public Account; and
  - (b) apply that sum for the services of the Government.
- (2) The sum specified in subsection (1)(a) is appropriated.

**5. Purposes of appropriation**

The sum specified in section 4(1)(a) is to be applied for the purposes referred to in Schedule 1 and detailed in either of the following:

**6. Expiry of Act**
