The Parliamentary Standing Committee of Public Accounts (Committee) is finalising its targeted inquiry into the Tasmanian Government's process into the planning for the proposed Arts, Entertainment and Sports Precinct in Hobart. The Committee resolved to have an updated progress report from the proponent, Macquarie Point Development Corporation, and a briefing by Dr Nicholas Gruen with respect to his independent assessment of the proposed AFL stadium at Macquarie Point released earlier this year.

In addition, the Committee is undertaking a targeted inquiry into the TT-Lines Spirits Project and the Committee has resolved to hear from Tasmanian Public Finance Corporation (TASCORP) representatives with respect to TT-Line's recent breach of their debt arrangement with TASCORP.

The Committee will conduct public hearings to obtain further information to the Inquiry.

The hearings will be held in Committee Room 2, Parliament House, Hobart and will commence at 9:30 am on Wednesday, 26 March 2025. The timetable and details of witnesses are attached.
