FOURTEENTH ANNUAL REPORT of the Inspector of Police on the State of the Territorial Police of Tasmania, for the Year ending the 30th June, 1881.

Office of Inspector of Police, 29th August, 1881.

SIR, IN presenting my Annual Report for 1880 and 1881 upon the state of the Territorial Police, I have the honor to record the continued good conduct of the Force, no serious cases of misconduct having been brought under my notice during the period. Discipline has been well maintained by the Officers in charge of Districts, while care and intelligence have generally prevailed in the conduct of police duty.

The proposals for the improvement of the position of the Force, in present remuneration and prospective provision on retirement, have given great satisfaction, and if carried out must prove beneficial to the permanency and character of the service.

The number of Constables employed throughout Tasmania appears to bear a large proportion to the population. I have before pointed out that this is inevitable from the physical character of the country. The centres of population are divided by tracts of unproductive thinly inhabited land, the small scattered townships are soon provided with public-houses, and it is found necessary to comply with the local demands for police protection.

Public convenience has been consulted by the establishment of Courts of Petty Sessions in all directions, necessitating the employment of Police. The inferior offices connected with the Civil Courts are also filled by Constables. Again, in the collection of rates and timber licences, inspection of stock, and in situations as subordinate officers of customs, baliffs of crown lands, and collection of taxes, so many are employed that no comparison can fairly be made with other places where police employment is confined to the preservation of the peace.

The increase in population during the past twenty years has not been followed by proportionate police augmentation. There are many reasons for this. Although the cessation of transportation was quickly followed by sweeping police reduction, the criminal classes remained in much more formidable numbers than now exist. Railways and the electric telegraph have rendered the detection of crime and the arrest of offenders more easy, saving the labor of pursuit, and facilitating interception. In 1858 and '9, there was one Constable to 269 inhabitants in the rural districts; now there is one to 368, although so many new stations have been established in the mining localities.

The Pieman and Macquarie Harbour District has not been proclaimed: the District Constable, however, is stationed at Macquarie. I have not yet found it necessary to appoint the additional Constable sanctioned by Parliament,—the anticipated increase of population not yet having occurred.

Strength of Force 20

One Constable was allowed to resign, his conduct not being satisfactory. There were no other changes in this Force beyond the transfer of several constables to the outlying districts and the appointment of their successors.

successors. It may here become necessary to repeat, in explanation of the number of police apparently employed on this station, that two Constables are engaged on night duty on the wharves in connection with Customs and harbour duty, two at the Powder Magazine (one for day and one for night), two employed to look after the Domain, one at Bridgewater watchhouse, one at Government House; leaving four for the suburb lying between the northern boundary of the city of Hobart and the municipality of Glenorchy. As this district contains a watchhouse, and night patrol is kept up, it will appear that for the area and population the force is small. At Sandy Bay there are three, including the District Constable; night patrol is here kept. There is also a Constable for duty at the Main Line Railway when trains arrive or start, one for the Cascade, and one for the Huon Road. I consider that this force, from the importance of the work entrusted to it, is under-manned. The frequent demands on this Force for preserving order in the Domain, on occasions when sports are going on, are supplied by bringing in Constables from the out-stations and employing the night Constables on extra duty. The Chief District Constable is Collector of Fees due to Charitable Institutions. Town Surveyor

The Chief District Constable is Collector of Fees due to Charitable Institutions, Town Surveyor Bailiff of Crown Lands, Sub-Collector of Carriage Duties, Collector of Rural Police Rates for the District of Hobart, Collector of Fees due to Training School, and Inspector under the Contagious Diseases Act. A District Constable is Summoning Officer to the Supreme Court (Criminal), and performs the duties of Coroner's Clerk.
