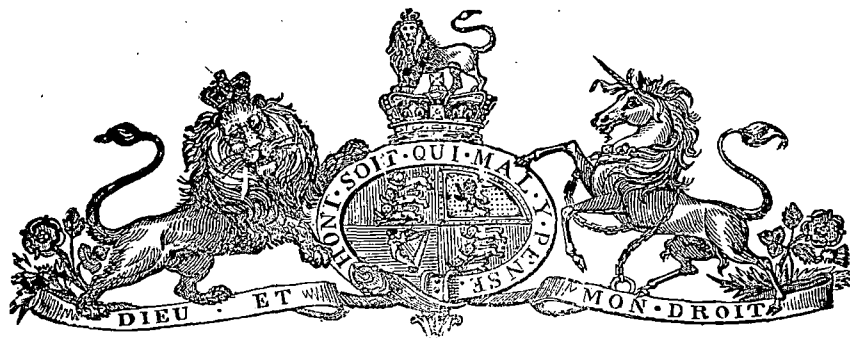

FRIDAY, NOVEMBER 22, 1872.

MINUTE No. 319.

THE services of Mrs. Alice Meadows, late Conductress of the Public School at Macquarie Plains, having been dispensed with in consequence of the discontinuance of the School, His Excellency approves of a Retiring Allowance, to commence on the 1st September last, being granted to her at the rate of £11 18s. 6d. per annum. The amount to be provided for upon a Supplementary Estimate.

MONDAY, MARCH 31, 1873.

MINUTE No. 71.

The Governor approves of Mr. William Johnston, Master of the Public School at Trinity Hill, Hobart Town, being allowed to retire on the ground of ill-health; and grants him a Pension, calculated on the 1st Clause of "The Superannuation Act," at the rate of £98 8s. 11d. per annum.

To take effect from 1st April next, and to be provided for upon a Supplementary Estimate.

MONDAY, MAY 19, 1873.

MINUTE No. 96.

On the recommendation of the Colonial Treasurer, the Governor approves of the following Minute of the Lords of the Treasury being recorded in the Minutes of the Council, with a view to its being acted on in any case of the kind which may arise:—

*Treasury Minute, 17. 12. 64.*

"My Lords have before them their Minute of the 4th June, 1859, the 4th Clause of which regulates the granting of allowances by way of Compensation under the 7th Section of the Act, 22 Vict. Cap. 26, to persons on the occasion of the abolition of office.

“By that Minute a specified number of years is to be added to the actual number which persons may have served without reference to the period of life which they may have attained.

“Upon further consideration of this subject, My Lords are of opinion that it would not be proper to adhere too strictly to this rule in the case of persons who may be advanced in years, and who from that circumstance might not remain much longer in the Public Service, and that in such cases they should reserve to themselves the free exercise of their discretion in fixing the number of years which should be added to the actual service, according to the view which they may take of the circumstances of each particular case.

“My Lords are therefore pleased to declare that in the case of persons who, if they served the time granted by that Minute for Compensation, would be over 60 years, and who may retire from office under the circumstances above referred to, they will not consider themselves bound by that Minute, but will decide upon each particular case according to the view they may take after a full consideration of the circumstances attending it.”
