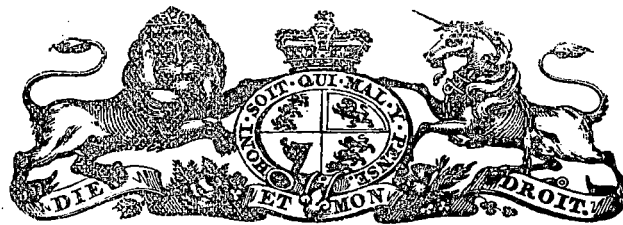

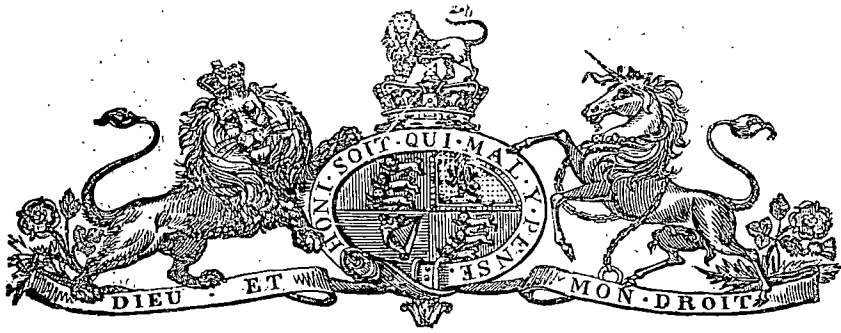

REPORT FROM THE SELECT COMMITTEE.

Laid upon the Table by the Premier, and ordered by the House to be printed,
November 1, 1882.



SELECT COMMITTEE appointed on Wednesday, the 1st November, to search the Records of the Legislative Council during the present Session, with the view of ascertaining what steps have been taken by the Council with regard to the Customs Duties Act Amendment Bill, No. 32, transmitted by the House to the Council on the 19th day of October last, and to report thereon forthwith.

R E P O R T.

THE Select Committee appointed on Wednesday, the 1st November, to search the Records of the Legislative Council to ascertain what steps had been taken with regard to the Customs Duties Amendment Bill, have the honor to report that they have searched the Records of the Legislative Council, and find the following entry in the Journals of the Council of Tuesday, the 31st of October, with regard to the said Bill:—

“6. The Order of the Day being read for the further consideration of the Message of the House of Assembly disagreeing to the Council’s Amendments to the Customs Duties Amendment Bill, 1882;

“And the Question being again proposed—That this Council do not insist on its Amendment to Clause 2;

“The Council resumed the consideration of the said Message.

“An Amendment was proposed to be made to the Question, by leaving out from the word “That” to the end of the Question, and adding the words “the further consideration of the Message of the House of Assembly be deferred until this day Six months,” instead thereof. (*Mr. Crowther.*)

“And the Question being put.—That the words proposed to be left out stand part of the Question;
