

MR. HENRY'S CLAIM.

REPLIES BY DEPUTY COMMISSIONER OF CROWN LANDS TO CERTAIN QUESTIONS.

Laid upon the Table by the Colonial Secretary, and ordered by the House to be printed, October 10, 1876.

Colonial Secretary's Office, Hobart Town, 9th October, 1876.

THE Minister of Lands and Works will oblige by obtaining from the Deputy Commissioner of Crown Lands answers to the several questions herewith submitted.

THOS. REIBEY.

WILL Mr. Hull be good enough to comply with the request of the Hon. the Colonial Secretary? C. O'REILLY, Minister of Lands and Works.

MEMORANDUM.

WILL the Deputy [Commissioner of Crown Lands be good enough to answer the following questions?

1. Was Mr. Sorell's letter of the 3rd July, 1876, with diagram forwarded with it, submitted to Mr. Moore personally?

2. By whose authority did the Deputy Commissioner of Crown Lands write the Memo. on Mr. Sorell's letter of 3rd of July, 1876, (initialed "J.H., 12. 7. 76.) written on behalf of Mr. Henry, and applying for the *second site* opposite to Barrack-street?

3. Was the letter dated 12th of July written under the impression that it referred to the first or second application of Mr. Henry,—and did the Deputy Commissioner write the said letter and afterwards submit it to Mr. Moore for his signature?

4. Did Mr. Moore read the said letter before he attached his signature to it?

5. Was the Deputy Commissioner present when Mr. Meredith attached his signature to the Memo. on Mr. Sorell's letter, initialed "J.H., 12. 7. 76?"

6. Was Mr. Moore present?

7. Was Mr. Henry present?

8. At whose request did Mr. Meredith attach his signature?

9. Did Mr. Moore name the annual rental of £5 in the presence of Deputy Commissioner and Messrs. Meredith and Henry?

10. Will the Deputy Commissioner distinctly state that he believed Mr. Moore expressed his willingness that Mr. Meredith should legally confirm, by attaching his signature to Memo. "Minister approves" on Mr. Sorell's letter, the agreement entered into with Mr. Henry by him previous to his resignation of office as Minister of Lands and Works? Yes. It formed as it were the cover of the correspondence.

By the authority of the then Minister of Lands and Works (Mr. Moore).

I wrote the letter referred to under the impression that I was dealing with the second site. Mr. Moore read the letter and added to it in his own handwriting.

Yes; and added to it.

No. Mr. Meredith sent for me and showed me what he had done in the presence of Mr. Moore.

Mr. Moore and Mr. Henry, I believe, were present.

I do not know.

I am not quite sure upon this point, but I believe he did.

I was not present when Mr. Meredith attached his signature : had I been present I would have got Mr. Moore's signature as well, because it was a record Mr. Moore told Mr. Henry, in his letter of the 12th July, that he had made. 11. Will the Deputy Commissioner state whether any objection to the second site had been received at the Lands and Works Office prior to the day on which Mr. Meredith was asked to sign the Memo. on Mr. Sorell's letter "Minister approves, &c.?"

12. Did the Deputy Commissioner of Crown Lands receive any private or official intimation from Mr. Moore that he had approved of Mr. Henry's application for Section No. 2 whilst under the impression his approval had reference to the original application of the 19th of April, 1876?

13. If such intimation has been made, when did it reach Mr. Hull, and did he communicate it to the Minister of Lands and Works? Only one letter from Mr. C. Smith, J.P.

Yes; a private letter, after the matter had been before the Governor in Council.

It reached me about the latter end of August. I did not show it to the Minister of Lands and Works, but I advised Mr. O'Reilly to let the matter stand over to be dealt with by Parliament.
