### **A BILL FOR**

**An Act to amend the *Acts Interpretation Act 1931, Agricultural and Veterinary Chemicals (Control of Use) Act 1995, Ambulance Service Act 1982, Asbestos-Related Diseases (Occupational Exposure) Compensation Act 2011, End-of-Life Choices (Voluntary Assisted Dying) Act 2021, Health Act 1997, Poisons Act 1971, Public Health Act 1997, Public Trustee Act 1930, Workers Rehabilitation and Compensation Act 1988* and other health-related legislation**

Be it enacted by Her Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:

### **PART 1 – PRELIMINARY**

#### **1. Short title**

This Act may be cited as the *Health Legislation (Miscellaneous Amendments) Act 2022*.
