# **Notices of Motion**

80 The Minister for Primary Industries and Water to move—That the House:—

- (1) Notes:—
  - (*a*) the Kempton Festival was held on 20 February 2022, back bigger than ever with almost 2000 attendees;
  - (b) highlights of the 2022 event included the ever-popular sheep racing that drew sponsors from all over the State including the Hon. Guy Barnett MP,. whose entrant 'Baaaaarnett' did not win, but was said to be appreciative of the opportunity to race in such a prestigious event;
  - (c) the plethora of entertainment included wood chopping demonstrations, sheaf and gumboot tossing, and for the first time Barrel Rolling;
  - (*d*) the fantastic support of the major sponsor, Old Kempton Distillery, who also donated the barrel for Barrel Rolling; and
  - (e) the Hon. Mark Shelton MP assisted the event, facilitating a grant to meet the cost of providing horse-drawn carriage for rides.
- (2) Celebrates that events such as this demonstrate how community spirit is alive and well in the Southern Midlands and acknowledges that rural and regional shows are an integral part of rural communities.
- (3) Congratulates the Southern Midlands community, Green Ponds Progress Association and the Southern Midlands Council for organising the festival, a community event celebrating and showcasing rural and village life. (3 March 2022)

81 Mr *Tucker* to move—That the House:—

- (1) Agrees that Tasmania has experienced significant economic growth, and population growth, due to increasing demand for the Tasmanian way of life.
- (2) Acknowledges that the only way to meet growth in demand is to increase the supply of housing and land, which supports our strong economy and provides more jobs and opportunities for Tasmanians.
- (3) Notes:-
  - (a) the Tasmanian Liberal Government's recently announced housing package is the biggest housing investment in our State for decades, at more than \$1.5 billion; and
  - (b) that the Liberal Government's bold, comprehensive plan will deliver 10,000 new social and affordable homes by 2032.
- (5) Welcomes the Government's plan to increase first home ownership through the Housing Market Entry program, by doubling the State's equity contribution and reducing the deposit required, opening the door to home ownership to more Tasmanians.

- (6) Recognises that reductions in property costs, such as land tax, put downward pressure on rental price increases.
- (7) Acknowledges that other supports, such as first home owner duty concessions and grants, put more money back into the pockets of first home buyers.
- (8) Notes that incentives such as ancillary dwelling grants and help to increase the supply of land and rental homes. (8 March 2022)
- 82 The Attorney-General to move—That the House:—
  - (1) Recognises that 20 February 2022 marked the 50th anniversary of formal diplomatic relations between Australia and Poland.
  - (2) Notes that Polish culture is deeply embedded in the Tasmanian community, particularly since the arrival of Polish immigrants to Tasmania following the end of World War II, when many Polish ex-service personnel and their families arrived in Tasmania, found work as labourers in organisations of the day, such as the Hydro-Electric Commission, during the construction of dams and power stations to provide electricity to a growing state, as well as PMG, Zinc Works, Cadbury, Siltex and IXL.
  - (3) Recognises that the Polish community throughout Tasmania actively engages in, and maintains Polish traditions and culture, preserves and celebrates Polish history and heritage, and promotes a deep connection between Poland and Tasmania that enriches the cultural fabric of the Tasmanian community. (8 March 2022)
- 83 The Minister for Women to move—That the House:—
  - (1) Acknowledges that it is International Women's Day on 8 March 2022.
  - (2) Notes that:—
    - (a) the theme for 2022 is 'Break the Bias';
    - (b) the United Nations has also issued a 2022 theme: 'Gender equality today for a sustainable tomorrow'; and
    - (c) International Women's Day is an important opportunity for us to celebrate women's successes, and reflect on progress and the actions we need to take to create a more equal future.
  - (3) Acknowledges there has been significant progress in recent years, for example women's representation on Government Boards and committees has steadily increased from 33.8% in June 2015 to 47.37% in September 2021.
  - (4) Further notes that by challenging gendered stereotypes and biases, we create cultural change in the environment in which women and girls live and work and in the opportunities women are afforded.
  - (5) Further acknowledges that this is more important than ever as we work to recover from the impacts of COVID-19. (8 March 2022)
- 84 Ms *Dow* to move—That the House:—
  - (1) Acknowledges that:—
    - (*a*) the current Burnie Court site is not fit for purpose;
    - (b) at the 2018 State Election, both parties committed \$15 million to redevelop the Court on the current site;
    - (c) in 2020 the Liberal Government announced the relocation of the court to the old University of Tasmania campus; a residential and educational precinct in West Burnie; and
    - (d) the Labor party at the 2021 State election committed to redeveloping the current site or to rebuild the Burnie Court on another site in the Burnie CBD.
  - (2) Notes:-
    - (a) there has been no consultation with local residents about the relocation of the Court to their neighbourhood;
    - (b) the ongoing concerns raised by the business community;
    - (c) the ongoing concerns raised by the Law Society;
    - (d) the ongoing concerns of the Burnie City Council;
    - (e) the absence of a public expression of interest on availability of land in the Burnie CBD;
    - (f) the project has now blown out to \$40 million;

- (g) 50,000 people visit the court complex each year and their removal will have a devastating impact on Burnie's CBD; and
- (*h*) alternate sites and proposals have been provided by the Burnie Chamber of Commerce.
- (3) Calls on the Premier Hon. Peter Gutwein MP, to hold a community meeting in Burnie to listen to the concerns of residents and stakeholders, to adopt Labor's position and keep the Burnie Court in the Burnie CBD. (8 March 2022)
- 85 Dr *Woodruff* to move—That the House:—
  - (1) Notes that on the 4 March, 2022, the Premier Hon. Peter Gutwein MP, announced a phase out of the mandatory mask-wearing public health order.
  - (3) Acknowledges:—
    - (*a*) this decision is likely to increase community transmission of Covid-19 and expose vulnerable Tasmanians to higher risk; and
      - (b) Covid-19 protections, and their removal, are a significant matter of public interest.
  - (3) Calls on the Gutwein Government to table the unredacted advice provided by Public Health that underpinned the Premier's decision to remove mask protections. (8 March 2022)
- 86 Ms *White* to move—That the House:—
  - (1) Appoints a Select Committee, with power to send for persons, papers and records, to inquire into and report upon the Tasmania Government's dealings with Tasmania Basketball Pty Ltd and any other associated entities from 27 August 2020 onwards, including but not limited to:—
    - (a) whether the relationship between the former Minister for Sport and Recreation, the Hon. Jane Howlett MLC and Tasmania Basketball Pty Ltd's Chief Executive Officer, Mr Simon Brookhouse, constituted a conflict of interest under the Ministerial Code of Conduct;
    - (b) the involvement of the Premier, Hon. Premier Gutwein and his Office in managing Ms Howlett's alleged conflict of interest and her departure from the Ministry;
    - (c) Ms Howlett's involvement in decisions relating to Tasmanian Government support for Tasmania Basketball Pty Ltd; and
    - (*d*) any other matters incidental thereto.
  - (2) Members to serve on the Committee be:—
    - (*a*) three from the Government, nominated by the Leader of the House, including the Chairperson
    - (*b*) the Deputy Leader of the Opposition;
    - (c) the Leader of the Greens; and
    - (d) the Mover.
  - (3) The Committee report by 3 May next. (8 March 2022)
- 87 Ms *O'Byrne* to move—That the House:—
  - (1) Notes:-
    - (*a*) 8 March is International Women's Day (IWD);
    - (b) globally 47,000 women and girls were killed by their male partners or family members in 2020 and those are only the deaths we know about, 47 countries still have no repercussions for husbands who rape their wife;
    - (c) 2.7 billion women are legally restricted from having the same choice of jobs as men; and
    - (d) 45 countries do not have specific laws against domestic violence and 30% of women globally have experienced sexual or physical violence in their lifetime;
  - (2) Recognises that Australia's gender pay gap is 14.2%.
  - (3) Further notes despite domestic violence laws, public awareness and access to legal protections, Australian men are still killing women partners or exes at the rate of one a week.
  - (4) Acknowledges:—

- (a) reproductive rights are a political football and that in Australia access varies by State, and in some parts of the United States, laws have passed making terminations inaccessible, no matter the reason behind the woman's decision; and
- (b) despite legislation in this House in 2013 only recently have public available abortions been accessible by Tasmanian women.
- (5) Further notes according to a major report in 2020, climate change is increasing violence against women and girls, case studies included domestic abuse, human trafficking, sexual assault, and violence against women environmental rights defenders.
- (6) IWD is a once-a-year chance to remind governments, businesses and everyone else watching that women aren't going anywhere, and we're prepared to take action to achieve our human rights.
- (7) These issues are compounding challenges faced by women of colour, women with disabilities, and queer or trans women, and stand in partnership with them. (8 March 2022)
