- 1 COUNCIL MEETS.**— The Council met at 11.00 o'clock in the forenoon.
- 2 ACKNOWLEDGEMENT OF TRADITIONAL PEOPLE.**— The President said: “We meet today on Tasmanian Aboriginal land. We acknowledge and pay respect to the Tasmanian Aboriginal people and elders, past and present. We recognise them as the traditional and original owners and the continuing custodians of this land.”
- 3 PRAYERS.**— The President read Prayers.
- 4 PAPER.**— The Clerk of the Council laid upon the Table the Health Practitioner Regulation National Law and Other Legislation Amendment Act 2022, Act No. 22 of 2022, Queensland.
- 5 BILL NO. 49.**— The Appropriation (Supplementary Appropriation for 2022-23) Bill 2022 was read the Third time and passed.
- 6 BILL NO. 49.**— A Message to the House of Assembly:—  
MR SPEAKER,  
The Legislative Council has this day agreed, without Request, to a Bill intituled, ‘A Bill for an Act for the appropriation of \$163 408 000 out of the Public Account for the services of the Government for the financial year ending on 30 June 2023’, now returns the same to the House of Assembly.

- 7 BILL NO. 39.**— The Stadiums Tasmania Amendment (Transfers) Bill 2022 was read the Third time and passed.

And the Bill was, accordingly, read the Second time and committed to a Committee of the Whole Council.

And the President having left the Chair, the Council resolved itself into the said Committee.
