Hydro Tasmania Pty Ltd

 - Should Project Marinus progress as a regulated service, the regulatory framework provides for a commercial rate of return to be earned on the funds invested. This would apply to both the Marinus Link interconnector and the North West Transmission Developments.

For example, the current Return on Equity allowance for TasNetworks' current transmission revenue determination period is 5.8%.

- TasNetworks engaged independent global advisory firm FTI Consulting (FTI) to undertake
 analysis on wholesale energy price benefits if Project Marinus proceeds. This document is also

- The regulatory investment test for transmission (RIT-T) is a cost-benefit analysis overseen by the Australian Energy Regulator (AER).
