



DEPUTY AUDITOR'S LETTERS.

QUERIES ON ACCOUNTS.

Laid upon the Table by the Colonial Treasurer, and ordered by the House to be printed, 14 August, 1866.



22nd January, 1866.

Sir,

I have the honor to inform you that the Auditor, shortly before leaving for England, brought under my notice the fact of the Accounts of the Immigration Commissioners not having been rendered for Audit since the year 1859; and that I have applied to the Secretary to the Board for the said Accounts on several occasions, both verbally and in writing, since Mr. Manley left, but have not succeeded in obtaining them. I therefore consider it my duty to report the circumstance for the information of His Excellency the Governor in Council, without further delay, in the hope that some means will be adopted to ensure these Accounts being forwarded to this Office for examination, and this duty being attended to in a more satisfactory manner for the future.

SIR,

With reference to the Report of Queries not returned to this Office of the 24th February, 1865, I have the honor to acquaint you for the information of His Excellency the Governor, that several of these Queries still remain unanswered, and that many more have accumulated since that date, a list of the whole of which is enclosed.

I also forward a Return of Surcharges upon your Accounts, made in accordance with Section 9 of *The Audit Act*, up to this date, by which you will perceive that you have not received a full acquittance for the months of December, 1862; January, February, July, and August, 1863; January, February, September, November, and December, 1864; and July, 1865, in consequence of the neglect complained of.

The usefulness of important Regulations under *The Audit Act* will be destroyed if irregularities of this nature are overlooked, in addition to the inconvenience and loss of time caused to this Office from the necessity of constantly sending reminders when one application should be sufficient. I beg, therefore, to recommend the adoption of some stringent measure in order that Officers whose duty it is to see that Queries from the Audit Office are satisfied may not neglect that duty with impunity. Possibly the carrying out of the Order of the Governor in Council of 28th September, 1863, bearing upon the subject (a Notice of which was forwarded to each Head of Department on 13th October, 1863, but not acted upon), might have the desired effect.

SIR,

With reference to my letter of the 22nd January last, in which I brought under your notice, for the information of His Excellency the Governor in Council, the fact of the Accounts of the Board of Immigration not having been tendered for Audit since the year 1859, I have now the honor to report that the Account for the year 1860 has subsequently been furnished, but that the Vouchers forwarded in support of the entries and other matters connected with the same were in so unsatisfactory a state that I found it necessary to raise a number of Queries upon them, which were forwarded to the Secretary to the Board for explanation on the 23rd ultimo, but that no reply has yet been received.

I have also to inform you that, finding the account of the Board for the year 1859 had been referred by Mr. Manley to the Secretary with Queries for explanation, on the 14th March, 1861, and that it had not been returned with the required information, I addressed a letter to Mr. Tribe, on the 22nd ultimo, requesting he would return it, as it was necessary, in order to complete the check for 1860, that I should be in possession of the account for the previous year,—and that I have also failed in obtaining any reply to this request.

It will be seen that for no less than seven years the accounts of the Immigration Commissioners (who have received and expended a very large amount of public money during that period) have not been duly audited; and that for five years they have not even been rendered. I am not aware that any satisfactory reason has ever been given for this delay, although the neglect of duty has been on numerous occasions brought under notice by the Audit Office. I therefore consider it my duty to urge upon His Excellency the necessity for insisting upon satisfactory explanation being immediately given to the questions raised by this Office with reference to the Accounts for 1859 and 1860, and the production of the Accounts for the remaining five years without delay.

Sir,

With reference to my letter of 3rd March and 6th April last, in which I reported that certain Queries issued from this Office had not been answered, I have now the honor to forward a Supplementary List up to this date; and at the same time to bring under notice that, out of fifty-five of the said Queries originally reported as unsatisfied, only five have as yet been attended to. Some of these cases involve matters of material importance as to the correct rendering of Accounts, both as regards Revenue and Expenditure; and it is evident that the Audit Office will be rendered powerless as a safeguard against irregularities in the Public Accounts, if the duty of answering satisfactorily questions raised by that Office be neglected with impunity. I pointed out in a former letter other mischievous effects of this neglect, which it is unnecessary to repeat; but I feel myself called upon to urge again the necessity for adopting and carrying out some measure that would have the effect of enforcing proper attention to this important duty.
