**A BILL FOR**

**An Act to amend certain enactments consequential on the  
enactment of the *Audit Act 2008***

Be it enacted by His Excellency the Governor of Tasmania, by  
and with the advice and consent of the Legislative Council and  
House of Assembly, in Parliament assembled, as follows:

**1. Short title**

This Act may be cited as the *Audit  
(Consequential Amendments) Act 2008*.

**2. Commencement**

- (1) Except as provided in this section, this Act commences on the day on which the *Audit Act 2008* commences.
- (2) Section 4 and Schedule 2 commence on 1 July 2010.
