R E P O R T.

To His Excellency FREDERICK ALOYSIUS WELD, *Esquire, Companion of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Colony of Tasmania and its Dependencies.*

MAY IT PLEASE YOUR EXCELLENCY.

WE, the Commissioners appointed by Her Majesty's Commission, dated the 13th day of April, 1877, "to make adequate arrangements for the representation of the Colony of Tasmania in the Metropolitan Exhibition to be held in Sydney in April, 1877," have the honor to report to Your Excellency respecting our proceedings and the results thereof.

Immediately on being notified of our Commission we assembled together and appointed Henry Edgell, Esq., of Launceston, to act as our Secretary, and took active steps to collect subscriptions towards the cost of the representation of Tasmania at the Sydney Exhibition, on the understanding that Her Majesty's Government would contribute £1 for every £1 so subscribed by the public.

Our individual exertions in this behalf were confined to the Town of Launceston and its vicinity; but we appointed Hugh Munro Hull, Esq., Clerk of the House of Assembly, to act on our behalf in the City of Hobart Town and on the southern side of the Island generally. We much regret that Mr. Hull's efforts were not very successful, the total amount of subscriptions obtained by him being £1 10s. In northern Tasmania the sum obtained by subscription to date amounts to £73 11s. 6d., making a total of £75 1s. 6d. money subscribed, which, with the Government contribution, placed a sum of £150 3s. at the disposal of the Commissioners. To this will have to be added several other amounts promised but not yet paid in.

We issued Circulars and Entry Forms to all persons whom we thought likely to become exhibitors, and adopted every means to give publicity to our proceedings,—advertising the objects of the Commission through the press; but, we regret to say, the public seemed to regard the object of the Commission with considerable apathy, and when the time for closing entries arrived we found there were only thirty-one exhibitors, with an aggregate of eighty-three exhibits.

This we regard as a matter greatly to be deplored, because the Sydney Metropolitan Exhibition is a most important one, bringing into honorable competition the industry of the several Australasian Colonies; and a large representation of Tasmanian products and manufactures could not have failed to benefit the material interests of the Colony by making her capabilities known, and paving the way for a large increase in our intercolonial trade.

Small as was the representation, however, we are happy to report that the Tasmanian Court gained a large share of the prizes and honors bestowed by the Council of the New South Wales Agricultural Society; and, further, that a considerable amount of business was done in several classes of exhibits. Our Minerals, Woollen Goods, Hat manufactures, Bacon, Hams, Cheese, and cereals were especially admired by all classes of visitors.

We deputed one of our number, Mr. T. C. Just, to proceed to Sydney to represent the Colony at the Exhibition. Mr. Just arrived at Sydney on 6th April, and took possession of the space allotted to the Colony in the Exhibition Building. By his exertions, and the kindly aid of the officials of the Exhibition, the Court was got ready in time for the opening, and at once attracted attention.

Mr. Just left Sydney on 25th April; and up to Saturday, 21st April, upwards of 120,000 persons had passed through the gates of the Exhibition, exclusive of members of the Agricultural Society, the officials of the Exhibition, visitors, and others on the free list. The final return of the attendance is as yet unknown to us.

Up to the time of Mr. Just leaving the judging had not been completed; but we have the honor to annex a list of the prizes and honors awarded to the Tasmanian Courts to 25th April, which includes 1 Silver Medal, 5 Bronze Medals, 15 First Prizes, 4 Second Prizes, 2 Special Extra Prizes, and 9 Certificates of high commendation,—in all 36 awards. Exhibits in one or two classes remained to be judged, and we hope to have the pleasure of reporting still further honors in a supplemental report.

We regret that the Wool exhibited did not arrive in time for the judging in that department, and that the quantities sent did not comply with the conditions of entry. Had it been otherwise, we have authority for believing that the highest honors would have fallen to Tasmania. The quality of the exhibits was such that, although the Judges had finished their duties, they awarded us two special extra prizes.

As experience gained on such occasions should be made useful as a guide for the future, we think it well to note the fact that exhibitors displayed great carelessness in the manner of addressing their exhibits. The tickets and address cards were in several instances torn from the bags and packages, and our representative Commissioner experienced some difficulty in identifying the exhibits. We should recommend that on future occasions the name of the exhibitor should be legibly painted upon his packages, and that the entry form should embrace all particulars in regard to the exhibit.

The late period at which the Tasmanian entries arrived prevented the possibility of all being included in the official catalogue; but Mr. Just at once had a list prepared which appeared as an "inset," (copy herewith marked A). Subsequently he prepared a "Special Catalogue," and printed 5000 copies, which were distributed gratuitously (copy herewith marked B*).

Finding the public of New South Wales very imperfectly informed as to the resources and prospects of Tasmania, Mr. Just took the opportunity of circulating gratuitously, at his own risk, about four hundred copies of the work annexed hereto marked C* (Tasmaniana); also five hundred copies of the "Conspectus" (marked D*). These were received with much interest, and were of great assistance to the representatives of the press, being the means of obtaining lengthy and interesting notices of the Court in several newspapers.

On leaving Sydney Mr. Just placed the Court in the charge of a trustworthy attendant, and also appointed an agent to see to the disposal of the exhibits ordered for sale. As the Exhibition will be open until about the middle of May, we are not yet in a position to render an account of expenditure incurred. This will form a portion of our supplementary report.

We have to acknowledge the courtesy extended to our representative by the Government of New South Wales, the Council and officials of the Agricultural Association, and the Officers of the Exhibition.
