

SIR,

Hobart Town, 5th April, 1866.

I HAVE the honor of forwarding to you the particulars required to be furnished in reference to persons applying for retiring allowances.

Having received my appointment prior to August, 1829, I claim my Pension under the Act of William the Fourth, as the Pension will be calculated on all allowances as well as salary, which is not the case under the Colonial law.

I forward this application, as directed, through the Head of my Department, the Bishop; but his Lordship cannot certify as to my services for thirty-seven years.

If necessary, I can send you letters from Sir George Arthur, Sir John Franklin, Sir William Denison, the late Bishop of Sydney, and the late Archdeacon Hutchins; also from Mr. Forster, then Colonial Secretary, and many others; also numerous addresses presented to me in 1840, when I left this for England, and similar addresses when I left Longford for Hobart Town.

During my residence here, during the last fourteen years, I have been personally known to all the Members of the Executive, so I need not allude to my services during that period.

I may add that it is not my intention to leave the Colony; but I hope, if my life be spared, to make myself useful as a Missionary Chaplain in visiting the neglected portions of this Archdeaconry.

Cause of retirement, [with annexed Medical Certificate, if from infirmity of mind or body, and under 60.]—Sixty years, and failing health.

I HAVE attended Archdeacon Davies professionally for several years, during which period his general health has frequently been in a very unsatisfactory condition. One of the most troublesome affections he has suffered from has been aggravated Dyspepsia, inducing want of rest, loss of appetite, general debility, &c. He has lately tried change of air, and although some temporary benefit was at first apparently obtained, his debility is now as great as ever.

I consider that he is quite unfit for the performance of the duties of his position, and (taking his age into consideration) I believe a permanent relief from them would be the only means likely to be productive of any real benefit.

From the testimony of the Metropolitan, and my predecessor in office the late Bishop of Tasmania, I am persuaded that the long and life-engaging services of the Archdeacon entitle him to the fullest regards of the Ministry. Nearly 40 years' devotion to his very arduous labours, especially in the earlier history of the Colony, fully account for declining health and strength at the age of 60. I am anxious to lay stress upon the facts, that a liberal consideration of his case can form but an exceedingly limited precedent, and that his residence and services up to the limit of his physical powers will still be retained to the Colony.

PENSION TO ARCHDEACON DAVIES.

By the Act 4 & 5 Will. 4, cap. 24, clause 9, under which the Archdeacon's Pension would be calculated, it is enacted that to an officer who shall have served 10 years and under 15 years there may be granted any amount as an annual allowance not exceeding $\frac{4}{12}$ of the annual salary and emoluments of his office. The Colonial Secretary will feel obliged to the Attorney-General for his opinion whether the term "emoluments" of office can be taken to include the fees which the Archdeacon receives as Incumbent of St. David's for marriages, deaths, &c.

ABOUT three months since I found it necessary to apply to the Executive for leave of absence to proceed to Victoria on account of my health.

Previous to my departure I forwarded an application for my Pension, on the following grounds:—1st. That I had passed my sixtieth year; and 2nd, on account of failing health, with a medical certificate to that effect.

I claimed my Pension under the Act of William the Fourth, as I was appointed Chaplain under the Sign Manual of George the Fourth prior to August, 1829.

There is a special clause in the Colonial Act referring to my case. Under this Act I could only claim my Pension on Salary; the former Act allows Emoluments to be added to Salary.

Since my return to Hobart Town my health has improved, but I still feel unequal to the duties of Incumbent of St. David's, and desire to confine myself to those of Archdeacon, in which capacity, from my intimate knowledge of the Country, and requirements of the people, I feel that I may still be of use in the Diocese.

I hope therefore that the Executive Council will take my application into consideration at once, and decide as to the amount of my retiring Pension, as it is important to myself to know the exact position in which I should be placed, and the certainty on which I may depend, in case of my being obliged to retire at an early date.

At the same time I beg leave to observe that it is not my present intention to resign immediately; but I am anxious that the amount of my Pension should be placed on the Estimates for next year, in order that I may not have to wait for another Session of Parliament, if in the mean time I should feel it incumbent on me to resign my Chaplaincy.
