## Notices of Motion

**198** The Treasurer to move—That the House approves, in accordance with sub-sections 11(7) and 12 (4) of the Public Account Act 1986, additional Recurrent Services and Works and Services expenditure in 2018-19 for the purpose detailed in the Section 19 Return for the June Quarter 2019. (15 October 2019)

**201** Ms *O'Byrne* to move—That the House:—

- (1) Notes the significant community concern about the proposed closure of the TasTAFE campus in the Launceston CBD.
- (2) Recognises the problems with the current aging infrastructure at the Alanvale campus.
- (3) Further notes the recent delays and cancellations to courses faced by students studying information technology, plumbing and electrotechnology.
- (4) Further notes the serious issue of understaffing at TasTAFE and its effect on teaching staff.
- (5) Further notes the decision by the University of Tasmania to relocate its Newnham campus to the CBD.
- (6) Further notes the difficulties faced by businesses across a range of industries that are desperate to find skilled staff.
- (7) Further notes Tasmania has lost 5,600 full time jobs in the past year and has a youth unemployment rate of 13.7 per cent.
- (8) Calls on the Premier, the Hon. Will Hodgman MP, to rule out the closure of the TasTAFE campus in the Launceston CBD. (15 October 2019)

**202** Ms *O'Connor* to move—That the House:—

- (1) Notes the significance of Parliament Lawns for the facilitation of protests and peaceful presentation of political views to Members of Parliament.
- (2) Acknowledges that Tasmanian members of the global climate activist movement, Extinction Rebellion, have had a near-constant presence on Parliament lawns for some months.
- (3) Agrees these Tasmanians have been fostering awareness of the climate emergency, and have engaged in a friendly and welcoming manner with the public on the lawns, spreading an important message in a positive way.
- (4) Commends these Tasmanians for their dedication to a safe climate, and agrees that their advocacy has been beneficial for our state and our democracy. (15 October 2019)

**203** Mrs *Rylah* to move—That the House:—

## NOTICES OF MOTION AND ORDERS

- (1) Acknowledges the Hodgman Liberal Government knows that an apprenticeship or traineeship is one of the most meaningful ways for young people to earn while they learn and this Government has a long term plan that is working.
- (2) Recognises our plan is backed by a solid budget which remains in surplus through good disciplined budget management.
- (3) Notes the Hodgman Government has invested more than \$100 million to provide pathways into employment in high demand industries including health, community and social services, tourism and hospitality and building and construction.
- (4) Further notes that since 2015, the Hodgman Liberal Government has increased recurrent funding to TasTAFE from \$73.5 million to \$77.8 million a year; approximately 80 per cent of the State's training budget.
- (5) Further recognises through the release of Infrastructure Tasmania's Project Pipeline, we are providing certainty to our building and construction businesses to have confidence to further invest in a skilled workforce.
- (6) Further acknowledges that our skills policy settings are working and the 2019 State budget maintains the momentum with initiatives such as Small Business Grants and Payroll Tax rebates helping businesses to take on apprentices as our economy grows.
- (7) Congratulates the Hodgman Liberal Government on its Plan that has lifted Tasmania to new levels, with more opportunities, the fastest growing economy in the nation which has created 13,500 more jobs. (16 October 2019)

### **204** Mrs Rylah to move—That the House:—

- (1) Acknowledges the Hodgman Liberal Government continues to deliver on its commitment to supporting Tasmanians to leading healthy lifestyles.
- (2) Notes the Government's \$8.6 million Healthy Tasmania Strategic Plan is focused on improving the State's health with an ambitious goal of becoming the healthiest population by 2025.
- (3) Further acknowledges the Hodgman Liberal Government's 'Tasmanian Tobacco Control Plan 2017 – 2021' is delivering on its commitment to improve the health, social and economic wellbeing of all Tasmanians by reducing the prevalence of tobacco use and smoking and the inequalities it causes.
- (4) Further notes the latest Australian Secondary Students Alcohol and Drug survey 2017 reports a significant decline in the rates of young Tasmanians smoking, reaching an all-time low, with the current smoking rates halved among older students since 2011 – from 16 per cent to 8 per cent.
- (5) Further notes under Healthy Tasmania, the Hodgman Government is targeting action towards those who supply tobacco, and education and marketing to help people quit.
- (6) Recognises there is still more to do as Tasmania continues to have the second highest rate of daily smokers nationally with 17.9 per cent. The National Health Survey 2017 – 18 reports more adult males (19.3%) were current smokers compared to 15.7 per cent of females and the highest smoking by age group to be 18 to 24 year olds at 22.6 per cent.
- (7) Congratulate the Hodgman Liberal Government on its Plan to reduce smoking. (16 October 2019)

### **205** Mrs Rylah to move—That the House:—

- (1) Notes that the Hodgman majority Liberal Government has made it easier for Tasmanians to report rubbish dumping to help keep our bushland and public open spaces clean.
- (2) Recognises that Tasmanians who enjoy our open spaces whether on horseback, moto cross riders or 4x4 drivers, are perfectly placed to use the new Report Rubbish tool at <https://rubbish.epa.tas.gov.au/> to record the location, type and amount of litter or dumped rubbish.
- (3) Acknowledges that this new Report Rubbish link, is a very useful tool for the Hodgman Liberal Government's commitment to crack down on litter. And works in conjunction with the Litter Amendment Bill 2018, which significantly increases penalties for illegal dumping.
- (4) Further notes that research indicates, the equivalent of a garbage dump truck of waste enters our oceans, every 1 minute.

- (1) Congratulates Prime Minister Hon. Scott Morrison MP and the Federal Liberal Party for the outstanding result in the Australian Federal election held on 18 May 2019.
- (2) Further congratulates, subject to final confirmation, the election of Tasmanian Federal Liberal representatives in both the Senate and the House of Representatives.
- (3) Notes the strong relationship between the Hodgman and Morrison Governments, working together to deliver a stronger economy, real investment in infrastructure and better health and education services for all Tasmanians. (Next Speaker: Dr *Woodruff*)

**5** Battery of the Nation: Adjourned Debate on the Question proposed on Wednesday, 31 July 2019 by Mrs *Rylah*—That the House:—

- (1) Notes Tasmania has the renewable and dispatchable energy the rest of the nation needs, and the Hodgman Liberal Government is committed to using this advantage to ensure all Tasmanians benefit.
- (2) Records this Governments continuing drive for the development of the Battery of the Nation and the crucial second interconnector, the Marinus project, which have the potential to inject up to \$5 billion into the Tasmanian economy and deliver 2,000 jobs, particularly into regional areas.
- (3) Further notes that the development stage of the first phase of the Battery of the Nation carries the commitment of the Federal Government through the Federal Underwriting New Generation Investment program.
- (4) Further notes that support by both the Hodgman Liberal Government and the Federal Government, gives UPC Renewables and AC energy, more confidence to develop their Robbins Island and Jims Plain wind and solar parks.
- (5) Recognises that Tasmania has a world-class wind resource complemented by our pumped hydro that means there will always be some electricity available for export when the mainland is experiencing low wind or high demand.
- (6) Acknowledges that the Australian Government clearly recognises the importance of Tasmania's energy solutions and our status as the leading energy state.
- (7) Commends the Hodgman Liberal Government for its strong commitment to making use of the natural resources available to the State while at the same time ensuring all Tasmanians will have access to low cost, reliable and clean energy in their homes and businesses. (Mrs *Rylah*)

To which the following amendment has been proposed by Dr *Woodruff*, by leaving out all words after "That the House:-" and inserting instead:

- “(1) Notes that the Liberals repeatedly talk about the Marinus project and use it as a political wedge, particularly during election periods, despite the fact that they have not put forward a financing proposal or a position on who should finance the multi-billion project.
- (2) Agrees that the project could cost in excess of current total Public Non-Financial Corporations Sector debt, and feasibility studies and prominent economists such as Saul Eslake have raised serious concerns about the viability of the project, which have not been addressed by the State Government.

- (3) Notes that the Liberals passed legislation to set wholesale electricity prices at a rate higher than projected, leading to energy bills decreasing by less than they would otherwise would have.
- (4) Notes with alarm that the Liberal Government continues to allow Entura to engage in profiteering from immoral projects overseas such as the Karuma hydro power project Uganda, which has been linked to killings and other human rights violations.
- (5) Condemns the Liberal Government for their lack of honesty, ethics or plan in their handling of the Energy portfolio.” (Next Speaker: Minister for Energy)

**6** Minimum Mandatory Sentences: Adjourned Debate on the Question proposed on Wednesday, 7 August 2019 by Mr *Tucker*—That the House:—

- (1) Welcomes the Federal Labor party’s recent sensible backflip on minimum mandatory sentences for crimes relating to child abuse.
- (2) Acknowledges the Tasmanian Labor Party is now out of step with its Federal Labor colleagues.
- (3) Supports the introduction of minimum mandatory sentences for serious sexual offences against children. (Next Speaker: The Attorney-General)

**7** Housing and Homelessness: Adjourned Debate on the Question proposed on Thursday, 8 August 2019 by the Minister for Housing—That the House:—

- (1) Acknowledges the dedicated work that is being done every day in the community and housing sectors to support Tasmanians experiencing homelessness or who are at risk of homelessness.
- (2) Further acknowledges that homelessness is often linked to other challenges such as mental illness, and the Tasmanian Government is focusing on the integration of mental health services to provide more holistic support and greater independence for clients.
- (3) Further acknowledges that Tasmania’s Affordable Housing Strategy is responding to the current challenges in the housing market by boosting supply across a spectrum of needs.
- (4) Further acknowledges that the Affordable Housing Action Plan Stage 2 and the additional investment in funding is another positive step towards continuing this momentum.
- (5) Recognises that all levels of government have a role to play in addressing the supply and demand in our housing market.
- (6) Call on all Members to work together to put the needs of Tasmanians above political point scoring. (Next Speaker: Minister for Housing)
