Notices of Motion

149 Ms O'Connor to move—That the House:—

- (1) Understands we are at a time in history where people must find ways to work together to tackle the serious challenges humanity faces.
- (2) Acknowledges that the Arctic and Amazon is on fire, the first glacier has melted in Iceland and we are in a climate emergency.
- (3) Recognises international political, trade and market instability.
- (4) Further understands Tasmania is not immune from the issues faced globally – the rapidly changing climate, international security and trade tensions, the rise of authoritarianism and the erosion of democracy.
- (5) Further acknowledges that in times of crisis people need real leadership.
- (6) Calls on all parties in the Tasmanian Parliament to work together to combat and prepare our community for the climate emergency and the geopolitical upheaval Tasmania is facing. (3 September 2019)

150 Ms O'Connor to move—That the House:—

- (1) Understands that in a time of climate emergency and growing social inequality, political parties need to work together.
- (2) Recognises the role of Opposition parties is to hold the Government to account.
- (3) Further understands it's also the role of Opposition parties to present an alternative vision.
- (4) Notes while they don't deliver an Alternative Budget as do the Greens, we now know that Labor supports:—
 - (a) most damningly for current and future generations, inaction on the climate emergency;
 - (b) Poker machines in communities until 2043;
 - (c) failing to protect young people at festivals from lethal drugs;
 - (d) the privatisation of public protected areas;
 - (e) shady dealings with developers in the office of the Coordinator General;
 - (f) soaring levels of foreign ownership of agricultural lands and housing;
 - (g) a cable car on kunanyi;
 - (h) the Cambria Green mega development near Swansea;
 - (i) the logging of high conservation value, carbon banking forests; and
 - (j) poorly regulated, unsustainable fish farm expansion.
- (5) Acknowledges that leadership across the community is required to ensure future wellbeing and prosperity for Tasmanians and that at a time when the Leader of the Opposition, Hon. Rebecca White MP could make a real, positive difference, she is refusing to do so.
- (6) Accepts that Tasmanian Labor under Hon. Rebecca White has become Liberal-lite.
- (7) Recognises that even if they don't support the Greens, Tasmanians know where we stand.

- (8) Further acknowledges with regret that the Greens are the only party that takes the climate emergency seriously, and the two Greens MPs remain the real opposition in Tasmania's Parliament. (3 September 2019)
- 152** The Minister for Building and Construction to move—That the House:—
- (1) Recognises that the annual NECA Tasmania Excellence and Apprentice Awards were held on 17 August 2019.
 - (2) Acknowledges that the awards are the electrical and communication subcontractors' highest accolade and the industry's most prestigious awards program in Tasmania.
 - (3) Congratulates all entrants and finalists across all categories including technology innovation, management, workplace health and safety, and commercial expertise.
 - (4) Further congratulates the award recipients, namely:—
 - (a) Nelson South Electrical Contractor for the Energy Efficiency & Environment Project category;
 - (b) RBD Electrical for both the Industrial Small Project and Industrial Medium Project categories;
 - (c) Stowe Australia for the Commercial Small Project category; and
 - (d) Degree C for the Commercial Medium Project category.
 - (5) Further recognises the outstanding performance and commitment to industry by the 2019 Apprentice Award winners, which were awarded to Marek Porter and Alexander Findlater.
 - (6) Further congratulates all award winners, who will go on to represent the best that Tasmania has to offer in the National Industry Excellence and Apprentice Awards to be held in Brisbane in November. (3 September 2019)
- 153** The Minister for Building and Construction to move—That the House:—
- (1) Recognises that the Master Builders Awards for Excellence was held on 17 August 2019 in Hobart.
 - (2) Acknowledges these awards celebrate Tasmania's builders who demonstrate excellence, professionalism and an utmost commitment to quality workmanship in the projects being constructed around the State.
 - (3) Notes that there were 17 award category winners, highlighting the high level of achievement by individuals and organisations across Tasmania.
 - (4) Further notes the special category winners, including:—
 - (a) Residential Master Builder of the Year – AJR Construction;
 - (b) Commercial Master Builder of the Year and Specialist Contractor of the Year – Fairbrother Construction;
 - (c) Young Builder of the Year – Matthew Barwick, Barwick Developments;
 - (d) Tasmanian Apprentice of the Year – Adam Gelston, Fairbrother Construction; and
 - (e) Hands On Skill Apprentice of the Year – Matthew Bates, Faulker Building.
 - (5) Commends every entrant and finalist, who exemplify the outstanding craftsmanship and commitment to building excellence that exists throughout Tasmania;
 - (6) Further congratulates all award winners, who will go on to showcase Tasmania's best in the National Excellence in Building and Construction Awards to be held at Uluru in the Northern Territory later in 2019. (3 September 2019)
- 154** The Attorney-General to move—That the House:—
- (1) Recognises the significant body of work contained in the 409 recommendations of the Royal Commission into Institutional Responses to Child Sexual Abuse.
 - (2) Further recognises the significant number of reforms that the Hodgman Liberal Government has already pursued in response to those recommendations.
 - (3) Notes the importance of these reforms to ensuring that the failings of the past are not repeated in the future.
 - (4) Commends the survivors and their advocates for continuing to lobby all Australian governments so as to ensure the momentum for change caused by the Royal Commission is not lost. (3 September 2019)
- 155** The Minister for the Arts to move—That the House:—

- (1) Recognises that there are a record 198 entries for the 2019 Premier's Literary Prizes which is a clear demonstration of the talent and enthusiasm across Tasmania's literary sector.
- (2) Notes that 2019 judges include esteemed writers, academics and industry professionals, including Professor Lucy Frost, Jane Rawson, Dr Robert Clark, Dr Natasha Cica, Rohan Wilson and Dr Graeme Miles.
- (3) Further notes that once the judging is complete, all of the books will be distributed to Tasmania's prison libraries.
- (4) Acknowledges that the Premier's Literary Prizes are presented by the Tasmanian Government and also supported by the University of Tasmania and private philanthropists. (3 September 2019)

157 Mrs Rylah to move—That the House:—

- (1) Acknowledges that under the Hodgman Liberal Government, the Australian Bureau of Statistic's labour force data for July 2019 shows 13,000 jobs have been created since we came to office.
- (2) Notes that these results follow recent data confirming that our economy is the strongest growing in the nation.
- (3) Further acknowledges that the NAB Monthly Business Survey results, for the seventh month in a row, found that Tasmania's business conditions are the best in the nation, three times better than the national result in trend terms.
- (4) Recognises the latest Sensis Business Index also found that Tasmania's businesses are the most confident in the nation and the Deloitte Access Economics analysis revealed Tasmania has the best business conditions in the nation.
- (5) Further acknowledge that Tasmanian small businesses currently employ more than 110,000 people across the State and are the powerhouse of our economy.
- (6) Congratulates the Hodgman Liberal Government on such strong results and its commitment to continue to grow the economy and create jobs by supporting businesses to develop a higher skilled workforce; cut red tape and unlock investment opportunities in Tasmania. (3 September 2019)

158 Mrs Rylah to move—That the House:—

- (1) Acknowledges that the Hodgman Liberal Government saved the Mersey Community Hospital and that it was the Labor Party that wanted to shut it down, after selling the Mersey Hospital to the Federal Government for \$1.
- (2) Notes that it was the Labor Party that left the neurology services in the North West in limbo for three years.
- (3) Recognises that it was the Labor Party that did not commit to one more doctor in the North West or promise a single extra paramedic for the coast and, that it was under Labor, that Mersey funding was also dishonestly taken from the hospital and spent in the South.
- (4) Further acknowledges that the Hodgman majority Government has invested in a life-saving helipad at the site and continues to invest a record \$83.7 million into the hospital in 2019-20, which includes a new 12 bed rehabilitation ward.
- (5) Further notes that it is the Hodgman Liberal Government that has a strong record in funding for health, whereas Labor can't produce an alternative budget, they have no policies, they stand for nothing and now they are trying to con North West Coasters into believing they finally care.
- (6) Congratulates the Minister for Health, Hon. Sarah Courtney MP and the Minister for Mental Health and Wellbeing, Hon. Jeremy Rockliff MP with the full backing of this Government, working closely to ensure every aspect of health, including primary and prevention, community and acute, is performing at its very best. (3 September 2019)

159 Mrs Rylah to move—That the House:—

- (1) Acknowledges that the Hodgman Liberal Government is delivering on our commitment to improve education results in Tasmania.
- (2) Notes that approximately 25,000 Tasmanian students in years 3,5,7 and 9 from all Government, Catholic and the vast majority of independent schools completed the 2019 NAPLAN tests.

- (3) Recognises that Tasmania's 2019 preliminary NAPLAN results show that years 3 and 9 writing are seeing improvements from 2018 and, along with reading, are one of our strongest domains.
- (4) Further notes that while the results are overall encouraging, they also show that numeracy and spelling remain an area for future focus.
- (5) Further acknowledges that this Government has invested significantly in literacy and numeracy initiatives, including the recently launched 'Literacy Framework and Plan for Action', and the Government's commitment to providing access to a Literacy Coach for every Tasmanian Government School, work is also now underway to develop a Numeracy Framework.
- (6) Congratulates the Hodgman Liberal Government on its commitment to improving educational outcomes in Tasmania by our record \$7.1 billion investment in education. (3 September 2019)

160 The Minister for Veterans' Affairs to move—That the House:—

- (1) Recognises that Legacy Week is being held from 1 September to 7 September 2019.
- (2) Notes Legacy Week, first held in 1942, is the annual national appeal of Legacy Australia, an iconic national charity providing services to Australian families suffering after the incapacitation or death of a spouse or parent, during or after their Defence Force service.
- (3) Further notes that funds raised during Legacy Week go to helping Legacy care for around 60,000 Australians, including 859 widows and widowers and 19 children in southern Tasmania and 1,159 widows and widowers and five children across northern Tasmania.
- (4) Further notes that funds raised assist Legacy in providing essential services including counselling, special housing, medical, advocacy and social support to Australian families and also help assist the education of the children of our deceased veterans through contributions to school fees and resources and the hosting of recreational activities to grow their self-confidence.
- (5) Acknowledges that Legacy Australia grew out of the Remembrance Club, formed in Hobart in 1923 by one of the nation's foremost First World War heroes, Tasmanian Major-General Sir John Gellibrand KCB DSO and Bar—a fact that Tasmanians can be particularly proud of.
- (6) Congratulates the staff, Legatees and volunteers of Legacy—including the President of Legacy (Hobart), Mr Alec Young, Friends of Hobart Legacy and the President of Legacy (Launceston), Mr Russell Hogarth—for their tireless efforts in supporting the families of our incapacitated and deceased veterans. (3 September 2019)

161 The Minister for Resources to move—That the House:—

- (1) Notes that Tasmania's forest industry is continuing to achieve accolades and recognition for the premium products sourced from our production forests.
- (2) Further notes Hydrowood has recently been recognised for their premium Tasmanian timber products at the Australasian Timber Flooring Association (ATFA) Awards for excellence last week.
- (3) Congratulates Hydrowood for taking out three awards at this event, including the significant prize of "Overall Winner – Floor of the Year Award".
- (4) Further notes that this award winning floor was also showcased on Grand Designs Australia, providing significant positive exposure to the quality and premium timber products available here in Tasmania.
- (5) Acknowledges that the Tasmania's world class forest practices system and reserve estate supports this renewable and sustainable industry to achieve global recognition and drive demand for our valuable wood products.
- (6) Supports the Hodgman Majority Liberal Government's positive Strategic Growth Plan for Tasmania Forests, Fine Timber and Wood Fibre. (3 September 2019)

162 The Minister for Primary Industries and Water to move—That the House:—

- (1) Notes that 3 September 2019, is Australian National Flag Day, the annual day specifically dedicated to celebrating our national flag.
- (2) Further notes that Australian National Flag Day was officially established in 1996 by the proclamation of the former Governor-General Sir William Deane and celebrates

the first time the flag was flown on 3 September 1901 over the dome of the Exhibition Building in Melbourne when then Prime Minister Edmund Barton announced the winners of a competition to design a flag for Australia.

- (3) Acknowledges the Australian National Flag as Australia's foremost national symbol and a unifying and powerful expression of Australian identity.
- (4) Further notes that Australian National Flag Day provides all Australians with an opportunity to reflect with pride and gratitude upon the achievements and qualities of this great nation since Federation.
- (5) Further acknowledges the sterling work of the Australian National Flag Association in promoting and protecting our national symbol, whose work locally is led by Reg Watson.
- (6) Congratulates all individuals, community organisations, local authorities, businesses and schools across Tasmania that celebrated Australian National Flag Day by conducting flag-raising ceremonies and by flying or displaying the National Flag. (3 September 2019)

163 Ms O'Connor to move—That the House:—

- (1) Acknowledges with immense concern that the Arctic is on fire, the first glacier has melted in Iceland and we are in a climate emergency.
- (2) Understands that the Amazon rainforest is burning as a result of illegal land clearing, primarily for beef production.
- (3) Recognises that the Amazon, Arctic and forests around the planet are in large part, the lungs of the earth,
- (4) Accepts the 8 August 2019 report from the International Panel on Climate Change, that notes the critical part forests play in mitigating emissions and storing carbon
- (5) Further understands that business as usual is not an option for current and future generations, and that all jurisdictions and communities have an obligation to make significant changes in the unfolding climate emergency.
- (6) Celebrates the 20 African countries that have joined together to plant a giant wall of trees that will run 7000 kilometres across their continent to stop the spread of the Sahara Desert.
- (7) Further accepts the protection of existing carbon-sequestering forests are critical to a safe climate.
- (8) Calls on the Liberal and Labor Parties to heed the science and recognise their moral responsibility to support the ongoing protection of the 356,000ha of high conservation value, carbon banking forest set aside under the Tasmanian Forest Agreement. (4 September 2019)

165 The Minister for Veterans' Affairs to move—That the House:—

- (1) Acknowledges 3 September 2019, was Merchant Navy Day, which is commemorated on the anniversary of the sinking of the first British merchant vessel during World War II, and in 2019 it falls on the 80th anniversary of when Australia entered the Second World War.
- (2) Further acknowledges that the Merchant Navy Day illustrates the important contribution mariners have made to Australia's economic growth and prosperity in peace time and in war.
- (3) Notes that the Merchant Navy of the whole British Empire, which included the Australian Merchant Fleet, suffered proportionately the highest casualties of any of the allied services in the Second World War.
- (4) Further notes that thirty thousand two hundred and forty eight British Empire merchant seamen who served at sea under the red ensign lost their lives doing so with the Australian Department of Veterans Affairs nominal roll recording 3,500 Australian merchant seamen serving in World War II in Australian registered ships.
- (5) Recognises the Tasmanian Seafarers' Memorial, located in Triabunna, on Tasmania's East Coast, which honours the lives of all Tasmanian seafarers who lost their lives at sea, including those who served in the armed forces. (4 September 2019)

166 The Minister for Health to move—That the House:—

- (1) Notes that National Stroke Week 2019 is taking place from 2-8 September 2019.

- (2) Further notes that the theme for National Stroke Week in 2019 is "F.A.S.T. Heroes" – recognising the everyday heroes who have spotted the signs of a stroke and called an ambulance straight away.
- (3) Further notes the F.A.S.T. test helps us to remember the stroke signs we need to watch out for and what to do if you suspect somebody is having a stroke:—
 - (a) Face – has the person's face dropped;
 - (b) Arms – can they lift both arms;
 - (c) Speech – is the person's speech slurred and can they understand what is being said; and
 - (d) Time – calling 000 as soon as possible is critical.
- (4) Congratulates the Stroke Foundation for their outstanding work to provide support for people living with stroke and raising awareness of stroke both locally and nationally.
- (5) Acknowledges the Tasmanian Government's strong investment in boosting access to stroke services and support, including \$440,000 of funding provided to the Stroke Foundation in 2018 and the new stroke telemedicine service which will commence later in 2019 thanks to the recruitment of full time neurologists to service the North and North-West. (5 September 2019)

167 The Minister for Health to move—That the House:—

- (1) Recognises Women's Health Week, which takes place from September 2 -6, with the theme of movement – Put your best foot forward for your health.
- (2) Notes the two biggest barriers for women not maintaining a healthy lifestyle is 'lack of time' and 'health not being a priority'.
- (3) Further notes that Women's Health Week serves as a timely reminder to all women that they need to look after themselves, inside and out.
- (4) Supports the Tasmanian Women's Strategy 2019-2021, which focuses on four priority areas – financial security, leaderships and participation, safety and health and wellbeing.
- (5) Acknowledges the Hodgman Liberal Government has taken strong action on this issue, including investment of \$435,200 to Women's Health Tasmania to improve health and wellbeing outcomes for Tasmanian women, especially women vulnerable to poorer health. \$398,100 was also allocated to The Link Youth Health Services to provide an implement services which improve the health and wellbeing of young people, noting that young women represent the majority of service clients.
- (6) Encourages individuals, communities and workplaces to get involved by sharing our health messages, hosting an event and encouraging as many women as possible to sign up to the week. (5 September, 2019)

168 The Minister for Police, Fire and Emergency Management to move—That the House:—

- (1) Recognises that the Government has a duty to protect those who protect us.
- (2) Notes that the Hodgman majority Liberal Government makes no apology for taking strong action to protect people from the scourge of drugs and violence.
- (3) Further notes Labor's track record of siding with the Greens when it came to the Hodgman majority Liberal Government's strong action to protect Tasmanians by cracking down on serious organised crime and outlaw motorcycle gangs, even against the advice of Tasmania Police and the Australian Criminal Intelligence Commission.
- (4) Further notes that just like the Greens, Labor opposed and continue to oppose guaranteed prison time for assaults on off duty police officers.
- (5) Further notes that Labor together with the Greens opposed and continue to oppose protections for our frontline workers and oppose guaranteed prison time for criminals who assault our frontline workers.
- (6) Further notes that Labor just like the Greens, consistently opposes guaranteed prison time for serious child sex offenders.
- (7) Further notes that Labor, like the Greens, has no policies to support the police in their role to protect the Tasmanian community.
- (8) Would welcome the Government bringing forward new legislation to guarantee prison time for assaults on frontline workers and serious child sex offenders. (5 September 2019)

- 169** Ms *O'Connor* to move—That the House condemns the Hodgman Liberal Government for its reckless mismanagement of wildlife in Tasmania that is driving species towards extinction. (5 September 2019)
- 170** Ms *Dow* to move—That the House:—
- (1) Notes that Tas Ports has called for \$80 million to be invested in the Burnie Port to deliver the upgrades outlined in the Burnie Port Masterplan.
 - (2) Confirms that the Hodgman Liberal Government has failed to allocate any State money to the project in the 10 year infrastructure pipeline released during the week commencing 2 September 2019.
 - (3) Acknowledges the potential for job-expansion in mining, agriculture, forestry and tourism relies on upgrades at the Burnie Port.
 - (4) Further notes that the Hodgman Liberal Government has failed to invest in a project that is crucial to protect and grow Tasmanian jobs at a time when the state desperately needs leadership on jobs.
 - (5) Further notes that businesses have told Tasmanian Labor that capacity constraints at the Burnie Port are costing them thousands and are particularly jeopardizing new jobs and investment in the minerals sector.
 - (6) Further acknowledges that more than 5,100 full time Tasmanian jobs have been lost in the past year with the North-West and West Coast suffering severely under the Hodgman Liberal Government.
 - (7) Further confirms that this is yet another example of how people on the North-West Coast and in regional Tasmania are being left behind by the Hodgman Liberal Government. (10 September 2019)
- 171** Ms *O'Connor* to move—That the House:—
- (1) Acknowledges the critical role forests play in carbon sequestration and oxygen production.
 - (2) Understands that to prevent the extremes of global heating the carbon that is in the ground, must stay in the ground.
 - (3) Calls on the Labor and Liberal Parties to support the protection of the 356,000ha of high conservation value, carbon-rich forests set aside under the Tasmanian Forests Agreement. (10 September 2019)
- 174** The Minister for Veterans' Affairs to move—That the House:—
- (1) Recognises that 15 September 2019 is Battle of Britain Day, an annual day of remembrance for those who fought and died in the Battle of Britain, history's first entirely aerial campaign and a strategic turning point of the Second World War.
 - (2) Notes that the Battle occurred over the United Kingdom between 10 July 1940 and 31 October 1940 between the air forces of Nazi Germany and the then British Empire and Commonwealth.
 - (3) Further notes that Allied success in the Battle was pivotal in seeing the planned seaborne invasion of the United Kingdom by Hitler's Germany cancelled, allowing the British Isles to eventually become the springboard from which the invasion of occupied Europe was performed, leading to the liberation of millions under Nazi oppression.
 - (4) Pays tribute to 'The Few', as Winston Churchill immortally named the fighter pilots fighting in the skies over Britain, for their service, courage and sacrifice, including more than thirty Australians, 14 of whom died in the Battle including Flight Lieutenant Stuart Walch, of Hobart, who attended the Hutchins School before joining the RAAF.
 - (5) Acknowledges that over this coming weekend, a memorial service commemorating the Battle will be held at St David's Cathedral and a wreath laying service at the Hobart Cenotaph with representatives from the Australian Defence Force, foreign militaries, ex-service organisations and all levels of Government attending and encourages all Tasmanians to pay their respects. (10 September 2019)
- 175** Mrs *Rylah* to move—That the House:—
- (1) Acknowledges that the Hodgman Liberal Party Government is working with primary producers to develop their exports, particularly into key Asian markets.
 - (2) Notes that Tasmanian growers will be showcasing our produce at Hong Kong's Fruit Logistics in the week 10 - 13 September 2019 - which attracts more than 13,000 buyers

from over 76 countries enabling Tasmanian producers to connect with key buyers and importers across Asia.

- (3) Further notes in 2019 Fruit Growers Tasmania has partnered with Brand Tasmania to exhibit at Asia Fruit logistics in their own right under the unique Tasmanian banner of 'the quiet pursuit of the extraordinary.'
- (4) Further acknowledges that Tasmania's brand is one of our State's greatest assets and Tasmanian growers will affirm their commitment to exceptional quality which is expected to boost export demand for our premium horticultural products.
- (5) Further notes that a key priority in our Trade Strategy is to build the export capability of local businesses and growing our agricultural exports will help deliver our target to grow the annual farm gate value of Tasmanian agriculture to \$10 billion by 2050.
- (6) Recognises that over 80 per cent of Tasmania's exports are consigned to the Asian region, with China and Hong Kong alone accounting for 35 per cent of total Tasmanian exports.
- (7) Further acknowledges that the Tasmanian Government is committed to empowering businesses to take their products to the world, so that the Tasmanian economy continues to grow, creating local jobs. (10 September 2019)

176 Mrs Rylah to move—That the House:—

- (1) Acknowledges that the '2018 – 19 Preliminary Outcomes Report', confirmed that the Hodgman Liberal Government, has delivered a balanced State Budget, returning a modest surplus of \$101.9 million.
- (2) Notes that the same Report shows the Government is on track to deliver a surplus for the fourth year in a row of approximately 1.6 per cent of revenue.
- (3) Further acknowledges that the NAB Monthly Business Survey results, for the seventh month in a row, found that Tasmania's business conditions are the best in the nation, three times better than the national result in trend terms.
- (4) Recognises that the this Government continues to have a strong balance sheet, holds net cash and investments, as opposed to net debt.
- (5) Further acknowledges that only by keeping the Budget strong can we deliver record investments in health, education and infrastructure. (10 September 2019)

177 Mrs Rylah to move—That the House:—

- (1) Acknowledges that Tourism contributes more than \$3 billion to Tasmania's economy.
- (2) Notes that our Tourism industry supports approximately 38,000 jobs—15.6% of total employment across the State.
- (3) Records that the Hodgman Liberal Government continues to invest strongly into our visitor economy, ensuring all regions reap the benefits.
- (4) Recognises that as a part of our 2019-20 Budget, this Government has committed \$20 million into the 'Regional Loan Attraction Scheme' that provides low interest loans of up to \$1 million for business to invest in new job creating tourism projects.
- (5) Congratulates the Hodgman Liberal Government for continuing to support visitor growth in Tasmania by:—
 - (a) supporting Tourism Tasmania marketing;
 - (b) growing the number of flights to the north of the State;
 - (c) launching the Western Wilds drive journey and the next iconic walk;
 - (d) investing \$72 million in our 'Roads to Support Tasmania's Visitor Economy' program; and

- (7) Supports the introduction of an offence of misconduct in public office, to apply to all individuals holding public office in Tasmania. (13 November 2019)

239 The Minister for Energy to move—That the House:—

- (1) Marks the official opening on 1 November 2019 of the Cradle Coast Future Energy Hub, the one stop shop for information on Tasmania's exciting energy future.

NOTICES OF MOTION

- (2) Acknowledges this collaborative initiative of the Cradle Coast Authority, TasNetworks and Hydro Tasmania to create an energy hub to engage with the locals and regional stakeholders, provide information and to listen to community feedback.
- (3) Notes the intention of other renewable energy developers to make use of the Cradle Coast Future Energy Hub to expand the communities' access to information and updates on a broad range of energy initiatives.
- (4) Encourages community members to access the Energy Hub, ask questions and provide feedback about the opportunities that exist in the North West and West Coast regions of Tasmania.
- (5) Further acknowledges that renewable energy development is one of Tasmania's greatest economic opportunity for the next decade, with our Battery of the Nation and second interconnector projects set to create thousands of jobs and inject billions into the Tasmanian economy over the coming years.
- (6) Further acknowledges the Government's Tasmania-First Energy Policy, which is focussed on delivering Tasmanian residents and businesses amongst the lowest regulated electricity prices in the Nation and being 100 per cent self-sufficient in renewables by 2022. (13 November 2019)

240 The Minister for Energy to move—That the House:—

- (1) Recognises that 14 November 2019 was World Diabetes Day, an international day of awareness and advocacy on behalf of those affected by diabetes.
- (2) Notes:—
 - (a) this annual day of awareness, created by the International Diabetes Federation (IDF) and World Health Organization (WHO) in 1991, is in response to growing concerns about the escalating health threat posed by diabetes;
 - (b) World Diabetes Day is the world's largest diabetes awareness campaign reaching a global audience of over 1 billion people in 170 countries and territories, aiming to draw attention to issues of paramount importance to those affected by diabetes and keeping diabetes firmly in the public and political spotlight;
 - (c) the theme for World Diabetes Day 2019 is 'Family and Diabetes', raising awareness of the impact that diabetes has on the family and support network of those affected, and promoting the role of the family in the management, care, prevention and education of diabetes; and
 - (d) Diabetes is the fastest growing chronic disease in Australia with more than 1.7 million Australians, including an estimated 41,000 Tasmanians living with diabetes.
- (3) Acknowledges the advocacy of the Tasmanian Parliamentary Diabetes Support Group in helping raise awareness of people living with diabetes and their families.
- (4) Congratulates the staff and volunteers of Diabetes Tasmania – including CEO, Ms Caroline Wells, and President, Mr Robert Manning – for their tireless efforts in advocating on behalf of those living with and affected by diabetes. (14 November 2019)

241 Mrs Rylah to move—That the House:—

- (1) Notes the serious issue of quad bike safety and the tragic deaths around Tasmania that have occurred as a result of quad bike use.
- (2) Commends the Federal Government for its action in implementing a new mandatory safety standard for quad bikes.
- (3) Further notes that the Federal Government has undertaken reforms which will require that, within the next 24 months, all new quad bikes must:—
 - (a) have affixed a warning label alerting quad bike users to the risk of vehicle rollover;
 - (b) be tested for stability and the test result be displayed on the bike at the point of sale;
 - (c) have integrated rollover protection; and
 - (d) meet minimum stability requirements.
- (4) Further notes that the Hodgman majority Liberal Government has funded a rebate scheme which allows farmers a fifty percent rebate on the cost to equip existing quad bikes with approved rollover protection devices.

- (5) Further notes the Government's quad bike safety forums recently held around the State, aimed at increasing education and awareness to ensure farmers can continue to use quad bikes as an important piece of farming equipment in a safe manner.
- (6) Further notes the Government's commitment to a new public awareness and education campaign with a focus on keeping children safe around quad bikes.
- (7) Further notes that the Hodgman Liberal Government continues to work closely with all stakeholders to ensure that all possible measure are taken to prevent deaths and serious injuries as a result of quad bike use into the future. (26 November 2019)

242 The Minister for Primary Industries and Water to move—That the House:—

- (1) Notes the 70th anniversary of Peter and Una Rockliff's involvement in the seafood industry, being celebrated on 29 November 2019, and recognises the impressive contribution Peter and Una have made to our iconic industry.
- (2) Further notes the Rockliffs have been fishing for a very long time, with Peter establishing his first commercial fishing boat called the 'Alva', named after his mother, in 1949.
- (3) Further notes Peter and Una—who are from a well-known fishing family in Bridport—combined their names for one of their boats 'Petuna'.
- (4) Further notes the Rockliffs continued to build upon their fishing interests and soon finalised the construction of Tasmania's first deep sea fishing boat, the Petuna Endeavour in 1979.
- (5) Further notes that by 1990 the Rockliffs had further broadened their fishing interests and expanded into Aquaculture, and established their Petuna head office, factory processing and distribution facility in East Devonport.
- (6) Further notes that Peter and Una's work pioneering Petuna Ocean Trout and Petuna Atlantic Salmon in aquaculture has been recognised with an Order of Australia Medal in 2004.
- (7) Congratulates Peter and Una on this 70th anniversary milestone.
- (8) Further notes that our important salmon industry provides thousands of direct and indirect jobs, many of which are in regional areas of the State, and many of which accrue to Petuna. (26 November 2019)

243 Mr *Tucker* to move—That the House:—

- (1) Recognises that criminal organisations such as Outlaw Motor Cycle Gangs (OMCGs) are a threat to community safety.
- (2) Notes the OMCGs culture is one where government and the rules of law don't apply to them, unlike the other 99 per cent of society.
- (3) Further notes that OMCGs engage in intimidation, drug trafficking and gun crime resulting in community harm and fear.
- (4) Acknowledges the efforts of Tasmania Police, along with police in other jurisdictions including the AFP, for their work in tackling serious organised crime.
- (5) Further notes that Tasmania's new consorting and colours laws send a clear message to OMCGs that they are not welcome in Tasmania.
- (6) Further recognises the new laws will help keep Tasmanians safe and calls on the House to support the Government's tough on crime approach. (26 November 2019)

247 Ms *Butler* to move—That the House:—

- (1) Recognises growing concern in the Westbury community over plans to build a maximum security prison in their township.
- (2) Notes that protests against the project have already attracted hundreds of people.
- (3) Further notes residents in Westbury are fearful that if they dare to protest construction of a Maximum Security Prison on their doorstep, they will be arrested and charged by Tasmania Police.
- (4) Calls on the Liberal Government to guarantee that protestors will not be prosecuted if they protest against the Westbury prison. (26 November 2019)
