### Inquiry into the TT-Line Spirits Project

---

The Parliamentary Standing Committee of Public Accounts (Committee) is undertaking a targeted inquiry into the TT-Lines Spirits Project, with particular reference to the delivery of the new Spirit of Tasmania vessels and associated infrastructure and the decision by TT-Line to vary the terms of the contract for the new Spirit of Tasmania vessels, including its adherence to caretaker conventions.

The Committee will conduct further public hearings to obtain additional information to the Inquiry.
