

ORDERS of the Administrator in Council made under "The Superannuation Act" since the last Meeting of Parliament.

SATURDAY, SEPTEMBER 25, 1880.

MINUTE No. 391.

THE Colonial Secretary submits that Mr. Hopton Scott, First Clerk in the Audit Department, be allowed to retire upon a Pension of £200 per annum.

To take effect on the 1st instant, and to be provided for upon a Supplementary Estimate.

MONDAY, OCTOBER 18, 1880.

MINUTE No. 405.

In accordance with the desire of the Commissioners of the Hospital for the Insane, New Norfolk, the Administrator approves of George Francis Huston, Esq., Superintendent and Medical Officer of that Institution, being allowed to retire from the Public Service, and grants him a Retiring Allowance of £243 ls. 1d. per annum, commencing on the 1st instant; the amount to be provided on a Supplementary Estimate.
