- **4** QUESTIONS SEEKING INFORMATION. In accordance with Standing Order No. 43, Questions without notice were asked.
- 5 PETITION. Dr *Woodruff* presented a Petition from approximately 684 residents of Tasmania, requesting that the House call on the Government to facilitate the removal of Castle Forbes Forest from the Permanent Timber Production Zone, or otherwise permanently exclude it from logging operations. (HA20/2021)

Which Petition was read and received.

6 PETITION. – Dr *Woodruff* presented an E-Petition from approximately 730 residents of Tasmania, requesting that the House call on the Government to facilitate the removal of Castle Forbes Forest from the Permanent Timber Production Zone, or otherwise permanently exclude it from logging operations. (HA19/2021)
